In addition, three years of full-time relevant personal financial planning experience is required.

Graduates of the CRPS® Professional Designation Program must complete a specialized study course that provides a foundation for giving retirement planning advice to corporations and small businesses. The course covers key issues involved in all phases of establishing retirement plans within businesses. The designation is awarded to students after they successfully complete the course, pass a four hour final examination, and sign a code of ethics commitment and declaration form.
