To earn the right to use the Chartered Financial Analyst designation, candidates must pass three examinations that are each six hours long each. Successful candidates must master the Candidate Body of Knowledge™ (CBOK) consisting of accounting, portfolio management, options, ethics, statistics, quantitative analysis, and investment theory questions. CFA Charterholders must also complete four years of qualified investment work experience. In addition, candidates must join the CFA Institute, the local chapter of the CFA Institute and annually sign and pledge to adhere to the CFA Code of Ethics and Standards of Professional Conduct.

The company has been providing wealth management services to high net worth individuals and institutions ever since. Brandon has been the portfolio manager, Chief Compliance Officer and manager of the firm since its inception in 2002.
