### **Educational Background and Business Experience**

Gregory Lawton received his Bachelor of Arts in Business Administration from Ft Lewis College in 1981. Since that time Mr. Lawton has worked for Citicorp's Development Division as a Vice President concentrating on working with high net worth individuals (1981-1983). In addition he was Senior Vice President for A.E. Stephenson Inc. where he spent seven years working with clients and was trained to manage clients' portfolios (1983-1990).

In 1990 Mr. Lawton formed a strategic alliance with the Frank Russell Company and opened Ziv Lawton Russell, Inc. and became a registered investment advisor. He bought out his partners in 1995 (Ziv) and renamed the firm Lawton Russell, Inc. This firm concentrated on managing the retirement plans of companies and their owners' personal investments.

In 1998 Mr. Lawton sold his firm to Corus Bank, N.A. (CORS symbol). At the time Mr. Lawton was managing over \$300 million in assets. Upon completion of the sale Mr. Lawton was retained by Corus to be the CIO for Corus Bank's Trust Department. Mr. Lawton resigned in 2000 after his employment contract ended.

At the request of former clients, in 2001 LAMI was formed to concentrate on managing money for business owners, individuals and their trusts.

Mr. Lawton has not been involved in any legal or disciplinary events that would be material to a client's evaluation of Mr. Lawton or LAMI.

### **Other Business Activities**
