# Advisory Business

---

## Firm Description

Coast Wealth Management, Inc., ("Coast Wealth Management") was founded in 2003.

Coast Wealth Management provides personalized confidential financial planning and investment management to individuals, pension and profit sharing plans, trusts, estates, charitable organizations and small businesses. Advice is provided through consultation with the client and may include: determination of financial objectives, identification of financial problems, cash flow management, tax planning, insurance review, investment management, education funding, retirement planning, and estate planning.

Coast Wealth Management is strictly a fee-only financial planning and investment management firm. The firm does not receive commissions for purchasing or selling annuities, insurance, stocks, bonds, mutual funds, limited partnerships, or other commissioned products. The firm is not affiliated with entities that sell financial products or securities. No commissions in any form are accepted. No finder's fees are accepted.

Investment advice is an integral part of financial planning. In addition, Coast Wealth Management advises clients regarding cash flow, college planning, retirement planning, tax planning and estate planning.

Investment advice is provided, with the client making the final decision on investment selection. Coast Wealth Management does not act as a custodian of client assets. The client always maintains asset control. Coast Wealth Management places trades for clients under a limited power of attorney.

A written evaluation of each client's initial situation is provided to the client, often in the form of a net worth statement. Periodic reviews are also communicated to provide reminders of the specific courses of action that need to be taken. More frequent reviews occur but are not necessarily communicated to the client unless immediate changes are recommended.

Other professionals (e.g., lawyers, accountants, insurance agents, etc.) are engaged directly by the client on an as-needed basis. Conflicts of interest will be disclosed to the client in the unlikely event they should occur.

The initial meeting, which may be by telephone, is free of charge and is considered an exploratory interview to determine the extent to which financial planning and investment management may be beneficial to the client.

---

## Principal Owners

Michael Vandenburg is the owner, advisor, and only stockholder in Coast Wealth Management, Inc.

---

**Types of Advisory Services**

Coast Wealth Management provides investment supervisory services, also known as asset management services; manages investment advisory accounts not involving investment supervisory services; furnishes investment advice through consultations.

On more than an occasional basis, Coast Wealth Management furnishes advice to clients on matters not involving securities, such as financial planning matters, taxation issues, and trust services that often include estate planning.

As of 01/01/2012, Coast Wealth Management manages approximately \$35,000,000 in assets for approximately 24 clients. Approximately \$22,000,000 is managed on a discretionary basis, and \$13,000,000 is managed on a non-discretionary basis.

---

**Tailored Relationships**

The goals and objectives for each client are documented in our client relationship management system. Investment policy statements are created that reflect the stated goals and objective. Clients may impose restrictions on investing in certain securities or types of securities.

Agreements may not be assigned without client consent.

---

**Types of Agreements**

The following agreements define the typical client relationships.

---

**Advisory Service Agreement**

Most clients choose to have Coast Wealth Management manage their assets in order to obtain ongoing in-depth advice and life planning. All aspects of the client's financial affairs are reviewed, including those of their children.

Realistic and measurable goals are set and objectives to reach those goals are defined. As goals and objectives change over time, suggestions are made and implemented on an ongoing basis.

The scope of work and fee for an Advisory Service Agreement is provided to the client in writing prior to the start of the relationship. An Advisory Service Agreement includes: cash flow management; insurance review; investment management (including performance reporting); education planning; retirement planning; estate planning; and tax preparation, as well as the implementation of recommendations within each area.

The Advisory Service Agreement fee is based on a percentage of the investable assets and is inclusive of all financial planning necessary for each client according to the following schedule:

- \_1.00%\_ on the first \$1,000,000;
- \_0.85%\_ on the next \$2,000,000 (from 1,000,001 to 3,000,000); and
- \_0.75%\_ on the next \$2,000,000 (from 3,000,001 to 5,000,000); and
- \_0.60%\_ on the assets above \$5,000,000.

Current client relationships may exist where the fees are higher or lower than the fee schedule above.

Although the Advisory Service Agreement is an ongoing agreement and constant adjustments are required, the length of service to the client is at the client's discretion. The client or the investment manager may terminate an Agreement by written notice to the other party. At termination, fees will be billed on a pro rata basis for the portion of the quarter completed. The portfolio value at the completion of the prior full billing quarter is used as the basis for the fee computation, adjusted for the number of days during the billing quarter prior to termination.

---

### **Investment Management Agreement**

An *Investment Management Agreement* may be executed when financial planning is not provided as part of the relationship. The annual fee for an *Investment Management Agreement* is:

- \_1.00%\_ on the first \$1,000,000;
- \_0.85%\_ on the next \$2,000,000 (from 1,000,001 to 3,000,000); and
- \_0.75%\_ on the next \$2,000,000 (from 3,000,001 to 5,000,000); and
- \_0.60%\_ on the assets above \$5,000,000.

---

### **Financial Planning**

Financial Planning services are included with the Investment Management Agreement and the standard Advisory Services Agreement and are not charged separately. There may be some clients who wish to engage in financial planning only and not have their assets managed or their plan implemented by Coast Wealth Management and the fee for such services is \$200 per hour.

---

### **Asset Management**

Assets are invested primarily in no-load or low-load mutual funds and exchange-traded funds, usually through discount brokers or fund companies. Fund companies charge each fund shareholder an investment management



fee that is disclosed in the fund prospectus. Discount brokerages may charge a transaction fee for the purchase of some funds.

Stocks and bonds may be purchased or sold through a brokerage account when appropriate. The brokerage firm charges a fee for stock and bond trades. Coast Wealth Management does not receive any compensation, in any form, from fund companies.

Investments may also include: equities (stocks), warrants, corporate debt securities, commercial paper, certificates of deposit, municipal securities, investment company securities (variable life insurance, variable annuities, and mutual funds shares), U. S. government securities, options contracts, futures contracts, and interests in partnerships.

---

### **Termination of Agreement**

A Client may terminate any of the aforementioned agreements at any time by notifying Coast Wealth Management in writing and paying the rate for the time spent on the investment advisory engagement prior to notification of termination. If the client made an advance payment, Coast Wealth Management will refund any unearned portion of the advance payment.

Coast Wealth Management may terminate any of the aforementioned agreements at any time by notifying the client in writing. If the client made an advance payment, Coast Wealth Management will refund any unearned portion of the advance payment.

---

### **Conflicts of Interest**

Coast Wealth Management prides itself as being free from conflicts of interests with its clients. Coast Wealth Management does not accept soft dollar agreements, commissions, or any other type of compensation for business received or referrals given. While doing our best to maintain an environment free from conflicts of interest, in the event that one such event does occur, please note the following. If a conflict of interest occurs between the advisor and the client, the client shall be notified in writing that the conflict exists. The client will also be notified in writing that they are under no obligation to act upon the advisor's recommendation, and if they elect to act on any of the recommendations, they are under no obligation to effect the transactions through the advisor.

## **Fees and Compensation**

---

### **Description**

Coast Wealth Management bases its fees on a percentage of assets under management or hourly charges. Fees are *negotiable*. Lower fees for

comparable services may be available from other sources. Coast Wealth Management does not participate in wrap-fee programs

---

### **Fee Billing**

Investment management fees are billed quarterly, in *arrears*, meaning that we invoice you *after* the three-month billing period has *ended*. Payment in full is expected upon invoice presentation. Fees are usually deducted from a designated client account to facilitate billing. The client must consent in advance to direct debiting of their investment account.

---

### **Other Fees**

Custodians may charge transaction fees on purchases or sales of certain mutual funds and exchange-traded funds. These transaction charges are usually small and incidental to the purchase or sale of a security. The selection of the security is more important than the nominal fee that the custodian charges to buy or sell the security.

Coast Wealth Management, in its sole discretion, may waive its minimum fee and/or charge a lesser investment advisory fee based upon certain criteria (e.g., historical relationship, type of assets, anticipated future earning capacity, anticipated future additional assets, dollar amounts of assets to be managed, related accounts, account composition, negotiations with clients, etc.).

Lower fees for comparable services may be available from other sources.

---

### **Expense Ratios**

Mutual funds generally charge a management fee for their services as investment managers. The management fee is called an expense ratio. For example, an expense ratio of 0.50 means that the mutual fund company charges 0.5% for their services. These fees are in addition to the fees paid by you to Coast Wealth Management.

Performance figures quoted by mutual fund companies in various publications are after their fees have been deducted.

---

### **Past Due Accounts and Termination of Agreement**

Coast Wealth Management reserves the right to stop work on any account that is more than 30 days overdue. In addition, Coast Wealth Management reserves the right to terminate any financial planning engagement where a client has willfully concealed or has refused to provide pertinent information about financial situations when necessary and appropriate, in Coast Wealth Management's judgment, to providing proper financial advice. Any unused portion of fees collected in advance will be refunded within 30 days.

# Performance-Based Fees & Side-By-Side Management

---

## Sharing of Capital Gains

Fees are not based on a share of the capital gains or capital appreciation of managed securities.

Coast Wealth Management does not use a performance-based fee structure or Side-By-Side Management because of the potential conflict of interest. Performance-based compensation may create an incentive for the adviser to recommend an investment that may carry a higher degree of risk to the client.

## Types of Clients

---

### Description

Coast Wealth Management generally provides investment advice to individuals, families, trusts, estates, charitable organizations, corporations or business entities.

Client relationships vary in scope and length of service.

### Account Minimums

The minimum account size for Private Wealth Management is \$1,000,000 of assets under management, which equates to an annual fee of \$10,000.

The minimum account size for Investment Management is \$100,000 of assets under management, which equates to an annual fee of \$1000.

Coast Wealth Management has the discretion to waive the account minimum. Accounts of less than \$100,000 may be set up when the client and the advisor anticipate the client will add additional funds to the accounts bringing the total to \$100,000 within a reasonable time. Other exceptions will apply to employees of Coast Wealth Management and their relatives, or relatives of existing clients.

## Methods of Analysis, Investment Strategies and Risk of Loss

---

### Methods of Analysis

Security analysis methods may include charting, fundamental analysis, technical analysis, and cyclical analysis.

The main sources of information include financial newspapers and magazines, inspections of corporate activities, research materials prepared

by others, corporate rating services, timing services, annual reports, prospectuses, filings with the Securities and Exchange Commission, and company press releases.

Other sources of information that Coast Wealth Management may use include Morningstar mutual fund information, Morningstar stock information, Fidelity Investments, Advisor Intelligence, and the World Wide Web.

---

### **Investment Strategies**

The primary investment strategy used on client accounts is strategic asset allocation utilizing a core and satellite approach. This means that we use passively-managed index and exchange-traded funds as the core investments, and then add actively-managed funds where there are greater opportunities to make a difference. Portfolios are globally diversified to control the risk associated with traditional markets.

The investment strategy for a specific client is based upon the objectives stated by the client during consultations. The client may change these objectives at any time. Each client executes an Investment Policy Statement that documents their objectives and their desired investment strategy.

Other strategies may include long-term purchases, short-term purchases, trading, short sales, margin transactions, and option writing (including covered options, uncovered options or spreading strategies).

---

### **Risk of Loss**

All investment programs have certain risks that are borne by the investor. Our investment approach constantly keeps the risk of loss in mind. Investors face the following investment risks:

- **Interest-rate Risk:** Fluctuations in interest rates may cause investment prices to fluctuate. For example, when interest rates rise, yields on existing bonds become less attractive, causing their market values to decline.
- **Market Risk:** The price of a security, bond, or mutual fund may drop in reaction to tangible and intangible events and conditions. This type of risk is caused by external factors independent of a security's particular underlying circumstances. For example, political, economic and social conditions may trigger market events.
- **Inflation Risk:** When any type of inflation is present, a dollar today will not buy as much as a dollar next year, because purchasing power is eroding at the rate of inflation.
- **Currency Risk:** Overseas investments are subject to fluctuations in the value of the dollar against the currency of the investment's originating country. This is also referred to as exchange rate risk.

- **Reinvestment Risk:** This is the risk that future proceeds from investments may have to be reinvested at a potentially lower rate of return (i.e. interest rate). This primarily relates to fixed income securities.
- **Business Risk:** These risks are associated with a particular industry or a particular company within an industry. For example, oil-drilling companies depend on finding oil and then refining it, a lengthy process, before they can generate a profit. They carry a higher risk of profitability than an electric company, which generates its income from a steady stream of customers who buy electricity no matter what the economic environment is like.
- **Liquidity Risk:** Liquidity is the ability to readily convert an investment into cash. Generally, assets are more liquid if many traders are interested in a standardized product. For example, Treasury Bills are highly liquid, while real estate properties are not.
- **Financial Risk:** Excessive borrowing to finance a business' operations increases the risk of profitability, because the company must meet the terms of its obligations in good times and bad. During periods of financial stress, the inability to meet loan obligations may result in bankruptcy and/or a declining market value.

## **Disciplinary Information**

---

### **Legal and Disciplinary**

The firm and its employees have not been involved in legal or disciplinary events related to past or present investment clients.

## **Other Financial Industry Activities and Affiliations**

---

### **Financial Industry Activities and Affiliations**

Coast Wealth Management and Michael Vandenburg are not registered nor do we have a pending registration to be a broker-dealer, or a representative of a broker-dealer.

Coast Wealth Management and Michael Vandenburg are not registered nor do we have a pending registration to be a commodity pool operator, a commodity trading advisor, or an associated person of the foregoing entities.

Coast Wealth Management and Michael Vandenburg does not have any relationships or arrangements that create any conflicts of interest with any broker-dealer, municipal securities dealer, government securities dealer broker, investment company or other pooled investment vehicle (including a mutual fund, closed-end investment company, unit investment trust, private

investment company or “hedge fund,” and offshore fund), other investment adviser or financial planner, futures commission merchant, commodity pool operator, or commodity trading advisor, banking or thrift institution, accountant or accounting firm, lawyer or law firm, insurance company or agency, pension consultant, real estate broker or dealer, sponsor or syndicator of limited partnerships.

Coast Wealth Management is registered as a Registered Investment Advisor in the state of California. Registration as an investment advisor does not imply a certain level of skill or training.

## **Code of Ethics, Participation or Interest in Client Transactions and Personal Trading**

---

### **Code of Ethics**

The employees of Coast Wealth Management have committed to a Code of Ethics that is available for review by clients and prospective clients upon request. The firm will provide a copy of the Code of Ethics to any client or prospective client upon request.

### **Participation or Interest in Client Transactions**

Coast Wealth Management and its employees may buy or sell securities that are also held by clients. Employees may not trade their own securities ahead of client trades. Employees comply with the provisions of the Coast Wealth Management *Compliance Manual*.

### **Personal Trading**

The Chief Compliance Officer of Coast Wealth Management is Michael Vandenburg. He reviews all employee trades each quarter. The personal trading reviews ensure that the personal trading of employees does not affect the markets, and that clients of the firm receive preferential treatment. Since most employee trades are small mutual fund trades or exchange-traded fund trades, the trades do not affect the securities markets.

## **Brokerage Practices**

---

### **Selecting Brokerage Firms**

Coast Wealth Management does not have any affiliation with product sales firms. Specific custodian recommendations are made to Clients based on their need for such services. Coast Wealth Management recommends

custodians based on the proven integrity and financial responsibility of the firm and the best execution of orders at reasonable commission rates.

Coast Wealth Management recommends discount brokerage firms and trust companies (qualified custodians), such as Fidelity Investments.

Coast Wealth Management *does not* receive fees or commissions from any of these arrangements.

---

**Best Execution**

Coast Wealth Management reviews the execution of trades at each custodian each quarter. The review is documented in the Coast Wealth Management *Compliance Manual*. Trading fees charged by the custodians is also reviewed on a quarterly basis. Coast Wealth Management does not receive any portion of the trading fees.

---

**Soft Dollars**

Coast Wealth Management does not receive any credits or soft dollar arrangements from any of the firms that Coast Wealth Management does business with.

---

**Order Aggregation**

Most trades are mutual funds or exchange-traded funds where trade aggregation does not garner any client benefit.

## **Review of Accounts**

---

**Periodic Reviews**

Account reviews are performed quarterly by advisors Michael Vandenburg, President. Account reviews are performed more frequently when market conditions dictate.

---

**Review Triggers**

Other conditions that may trigger a review are changes in the tax laws, new investment information, and changes in a client's own situation.

---

**Regular Reports**

Account reviewers are members of the firm's Investment Committee. They are instructed to consider the client's current security positions and the likelihood that the performance of each security will contribute to the investment objectives of the client.

# Client Referrals and Other Compensation

---

## **Incoming Referrals**

Coast Wealth Management has been fortunate to receive many client referrals over the years. The referrals came from current clients, estate planning attorneys, accountants, employees, personal friends of employees and other similar sources. The firm does not compensate referring parties for these referrals.

---

## **Referrals Out**

Coast Wealth Management does not accept referral fees or any form of remuneration from other professionals when a prospect or client is referred to them.

---

## **Other Compensation**

*None.*

# Custody

---

## **SEC “Custody”**

Coast Wealth Management does not maintain custody of client funds and only acts in the best interest of the client for the clients accounts.

---

## **Account Statements**

All assets are held at qualified custodians, which means the custodians provide account statements directly to clients at their address of record at least quarterly.

---

## **Performance Reports**

Clients are urged to compare the account statements received directly from their custodians to the performance report statements provided by Coast Wealth Management.

---

## **Net Worth Statements**

Clients are frequently provided net worth statements and net worth graphs that are generated from our client relationship management system. Net worth statements contain approximations of bank account balances provided by the client, as well as the value of land and hard-to-price real estate. The net worth statements are used for long-term financial planning where the exact values of assets are not material to the financial planning tasks.



# Investment Discretion

---

## **Discretionary Authority for Trading**

Coast Wealth Management accepts discretionary authority to manage securities accounts on behalf of clients. Coast Wealth Management has the authority to determine, without obtaining specific client consent, the securities to be bought or sold, and the amount of the securities to be bought or sold. However, Coast Wealth Management consults with the client prior to each trade to obtain concurrence if a blanket trading authorization has not been given.

The client approves the custodian to be used and the commission rates paid to the custodian. Coast Wealth Management does not receive any portion of the transaction fees or commissions paid by the client to the custodian on certain trades.

Discretionary trading authority facilitates placing trades in your accounts on your behalf so that we may promptly implement the investment policy that you have approved in writing.

---

## **Limited Power of Attorney**

A limited power of attorney is a trading authorization for this purpose. You sign a limited power of attorney so that we may execute the trades that you have approved.

# Voting Client Securities

---

## **Proxy Votes**

Unless the client designates otherwise, Coast Wealth Management votes proxies for securities over which it maintains discretionary authority consistent with its proxy voting policy. A copy of Coast Wealth Management's proxy voting policy is available upon request.

# Financial Information

---

## **Financial Condition**

A balance sheet is not required to be provided because Coast Wealth Management does not serve as a custodian for client funds or securities, and does not require prepayment of fees of more than \$500 per client, and six months or more in advance.

Coast Wealth Management and Michael Vandenburg have never been involved in a bankruptcy petition.

# Requirements for State Registered Advisors

---

## Requirements for State Registered Advisors

The sole owner and principle executive of Coast Wealth Management is Michael Vandenburg, CFP®. Education and business background can be found in the brochure supplement.

Michael Vandenburg is not engaged in any other business or service.

Coast Wealth Management and Michael Vandenburg are not compensated with any performance-based fee structure or any other method that would require disclosure.

Coast Wealth Management and Michael Vandenburg do not have any disclosure events and does not have any pending actions that would require disclosure. This includes any event, whether civil or criminal, by a self-regulatory organization, or administrative proceeding.

You have my assurance in writing that all material conflicts of interest under CCR Section 260.238 (k) are disclosed regarding the investment adviser, its representatives or any of its employees, which could be reasonably expected to impair the rendering of unbiased and objective advice.

## Business Continuity Plan

---

### General

Coast Wealth Management has a Business Continuity Plan in place that provides detailed steps to mitigate and recover from the loss of office space, communications, services or key people.

### Disasters

The Business Continuity Plan covers natural disasters such as snow storms, hurricanes, tornados, and flooding. The Plan covers man-made disasters such as loss of electrical power, loss of water pressure, fire, bomb threat, nuclear emergency, chemical event, biological event, T-1 communications line outage, Internet outage, railway accident and aircraft accident. Electronic files are backed up daily and archived offsite.

### Alternate Offices

Alternate offices are identified to support ongoing operations in the event the main office is unavailable. It is our intention to contact all clients within five days of a disaster that dictates moving our office to an alternate location.
