Such individuals are known as Investment Adviser Representatives (IARs).</p> <p><b><u>FINANCIAL PLANNING AND CONSULTING SERVICES</u></b></p> <p>Financial Planning and Consulting Services will typically involve providing a variety of services, principally advisory in nature, to clients regarding the management of their financial resources based upon an analysis of their individual needs. The process typically begins with an initial complementary consultation. If during or after the initial consultation, the client decides to engage PWC for financial planning services, pertinent information about the client's personal and financial circumstances and objectives is collected. As required, PWC will conduct follow up meetings for the purposes of reviewing and/or collecting financial data. Once such information has been studied and analyzed, a written financial plan, designed to achieve the clients' expressed financial goals and objectives, will be produced and presented to the client.</p> <p>Some clients may only require advice on a single aspect of the management of their financial resources. Clients may be offered this service on either a discretionary or non-discretionary basis.</p> <p>As part of this service, PWC and its Investment Adviser Representatives ("IARs") will assist the client in determining their investment goals and objectives, risk tolerance, and retirement plan time horizon in order to create an initial portfolio allocation designed to complement their educational, home ownership and retirements funds goals and objectives.
