MR monitors these portfolios for members. If clients elect to pay a \$19.95 monthly subscription fee, they will have access to software that allows them to manage their portfolios. Some members may also create their own ETF portfolios based upon their own knowledge and use our portfolio building software for free.</p> <p>These fees are negotiable, and the final fee schedule will be attached in the Investment Advisory Contract. Fees are paid monthly in advance, and clients may terminate their account with thirty days written notice. Refunds will be given on a prorated basis, based on the number of days remaining in a quarter at the point of termination. Clients may terminate their accounts without penalty, for full refund, within 5 business days of signing the advisory contract.</p> <p>INVESTMENT SUPERVISORY SERVICES</p> <p>MR will offer ongoing portfolio management services based on the individual goals, objectives, time horizon, and risk tolerance of each client. Investment Supervisory Services include, but are not limited to, the following: Investment strategy; Personal investment policy; Asset allocation ; Asset selection; Regular portfolio monitoring.</p> <p>MR will evaluate the current investments of each client with respect to their risk tolerance levels and time horizon. MR will request discretionary authority from clients in order to select securities and execute transactions without permission from the client prior to each transaction. Risk tolerance levels will be documented in the Investment Policy Statement, which will be given to each client. Fees for these services will be fixed fees as follows:</p> <p>Depending upon the complexity of the situation and the needs of the client, the fixed fee rate is between \$24,000 and \$50,000. Fees are paid in arrears. Because fees are charged in arrears, no refund is necessary. The fees are negotiable and the final fee schedule will be attached as Exhibit II of the Investment Advisory Contract. Clients may terminate their accounts without penalty, for full refund, within 5 business days of signing the advisory contract. MR will never charge a premium or commission on transactions, beyond the actual cost imposed by Custodian. Every attempt will be made to get group discounts on transactions when possible.

A: MR has marketing agreements with several online brokers where MR typically receives \$30 - \$60 for referring new accounts. These deals are usually completed through an intermediary like Commission Junction or directly with the broker.
