MR monitors these portfolios for members. If clients elect to pay a \$9.95 monthly subscription fee or a \$100 annual fee, they will have access to software that allows them to manage their portfolios. Some members may also create their own ETF portfolios based upon their own knowledge and use our portfolio building software for free.</p> <p>These fees are negotiable, and the final fee schedule will be attached in the Investment Advisory Contract. Fees are paid monthly in advance, and clients may terminate their account with thirty days written notice. Refunds will be given on a prorated basis, based on the number of days remaining in a quarter at the point of termination. Clients may terminate their accounts without penalty, for full refund, within 5 business days of signing the advisory contract.</p> <p>MR also offers RIA coaching services for \$399 for two hours of coaching. MarketRiders coaching provides a MarketRiders Registered Investment Advisor who helps the investor through a three step process online and by phone. The first step focuses on identifying the ideal asset allocation for the investor through a brief interview process. Based upon this interview the Coach architects within the E.Adviser software an asset allocation based on the investors age, risk tolerance, timeframe and other key factors, and then delivers them a personalized ETF portfolio in the MarketRiders E.Adviser software. In the second step, the coach helps the investor buy this recommended portfolio online and confirm these purchases in E.Adviser. Finally, once the investor's portfolio gets out of balance and a rebalancing alert is generated, the coach helps the investor perform their first rebalancing online, teaching the investor how to take the E.Adviser recommendations and execute them at their online broker and confirm the purchases back in the E.Adviser engine.</p>

There is an account minimum, \$25,000 which may be waived by the investment advisor, based on the needs of the client and the complexity of the situation. For investors using the E.Adviser software, there is no minimum, although MR recommends clients have at least \$50K.
