Receiving commissions and other incentive benefits may affect Mr. McGinness' judgment when recommending products to clients. Clients are never obligated or required to purchase insurance products from or through Mr. McGinness and may select any independent insurance agent and insurance company to purchase insurance products. Regardless of the insurance agent selected, the insurance agent or agency will receive normal commissions from the sale.

While Mr. McGinness spends the majority of his workweek on advisory matters, he does spend some time on insurance activities during normal securities trading hours.

Item 5 – Additional Compensation

Other than the advisory fees detailed in the Bazis and Young ADV Part 2A Disclosure Brochure, Richard McGinness, Jr. receives no other compensation related to advisory services provided to clients.
