Item 3. Disciplinary Information

Archetype is required to disclose information regarding any legal or disciplinary events material to a client's evaluation of Nicholas R. Walter. Archetype has no information to disclose in relation to this Item.

Item 4. Other Business Activities

Registered Representative of a Broker-Dealer

Nicholas R. Walter is a registered representative of United Planners Financial Services ("*United Planners*"), an SEC registered broker-dealer and member of FINRA. In this capacity, Nicholas R. Walter may provide securities brokerage services and implement securities transactions under a commission based arrangement. Nicholas R. Walter may be entitled to a portion of the brokerage commissions paid to *United Planners*, as well as a share of any ongoing distribution or service ("trail") fees from the sale of mutual funds.

A conflict of interest exists to the extent that Nicholas R. Walter recommends the purchase of securities where he receives commissions or other additional compensation as a result. This practice may give him an incentive to recommend investment products based on compensation received rather than on the client's needs. Archetype has procedures in place to ensure that all recommendations are made in the best interests of clients regardless of any additional compensation earned. For accounts covered by ERISA (and such others that the firm deems appropriate), Archetype provides investment advisory services on a fee offset basis, whereby offset its fees by an amount equal to the aggregate commissions and 12b-1 fees earned by Nicholas R. Walter in his individual capacity as a registered representative of *United Planners*.

Licensed Insurance Agent

Nicholas R. Walter is a licensed insurance agent and in such capacity may recommend, on a fully-disclosed commission basis, the purchase of certain insurance products. A conflict of interest exists to the extent that Archetype recommends the purchase of insurance products where Nicholas R. Walter receives insurance commissions or other additional compensation. Archetype seeks to ensure that all recommendations are made in the best interests of clients regardless of any additional compensation earned.

Certified Public Accountant

Nicholas R. Walter is a Certified Public Accountant ("CPA") and, in his individual capacity, may provide certain accounting and tax preparation services. These services are generally not offered to the firm's advisory clients and, as such, this relationship does not present any conflicts of interest under the circumstances.

Prime Lending Marketing Arrangement

In his individual capacity, Nicholas R. Walter provides marketing services to the mortgage provider, Prime Lending. Under this arrangement, Nicholas R. Walter receives compensation for his ongoing marketing efforts. A conflict of interest exists to that Archetype recommends the mortgage services of Prime Lending due to Nicholas R. Walter's relationship therewith. The firm seeks to ensure that all recommendations are made in its clients' best interests regardless of any such affiliation.

Item 5. Additional Compensation

Archetype is required to disclose information regarding any arrangement under which Nicholas R. Walter receives an economic benefit from someone other than a client for providing investment advisory services. Archetype has no information to disclose in relation to this Item.

Item 6. Supervision

William J. Lahr, IV, the President of the firm, is generally responsible for supervising Nicholas R. Walter's advisory activities on behalf of Archetype. The telephone number to reach William J. Lahr, IV is (215) 514-2827.

Archetype supervises its personnel and the investments made in client accounts. Archetype monitors the investments recommended by Nicholas R. Walter to ensure they are suitable for the particular client and consistent with their investment needs, goals, objectives and risk tolerance, as well as any restrictions previously requested by the client. Archetype periodically reviews the advisory activities of Nicholas R. Walter, which may include reviewing individual client accounts and correspondence (including e-mails) sent and received by Nicholas R. Walter.
