## **ITEM 2 - EDUCATIONAL BACKGROUND AND BUSINESS EXPERIENCE**

Education: Mr. Breskin graduated from Brown University with a B.A. in 1980, magna cum laude, with a double-major in History and Semiotics.

Business Background: Mr. Breskin has managed a number of alternative investment portfolios since 1992. Over this time, he has developed relationships with an extensive network of hedge fund managers, private equity managers, commodity trading advisors, fund of funds managers, and other investment advisors and financial associates with whom he maintains close contact. Mr. Breskin serves as the principal of Prosaic, LP ("Prosaic") and Poetic Justice, LLC (the "General Partner") and has managed the portfolio of Poetic License Partners, LP (the "Fund") since its inception on January 1, 2004. In addition to having responsibility for managing the investments of the Fund, Mr. Breskin also serves as Prosaic's Chief Compliance Officer.

## ITEM 3 – DISCIPLINARY INFORMATION

<b>Item 3.B</b>	<p>An administrative <i>proceeding</i> before the SEC, any other federal regulatory agency, any state regulatory agency, or any <i>foreign financial regulatory authority</i> in which the <i>supervised person</i></p> <ol style="list-style-type: none"> <li>1. was <i>found</i> to have caused an <i>investment-related</i> business to lose its authorization to do business; or</li> <li>2. was <i>found</i> to have been <i>involved</i> in a violation of an <i>investment-related</i> statute or regulation and was the subject of an <i>order</i> by the agency or authority <ol style="list-style-type: none"> <li>(a) denying, suspending, or revoking the authorization of the <i>supervised person</i> to act in an <i>investment-related</i> business;</li> <li>(b) barring or suspending the <i>supervised person's</i> association with an <i>investment-related</i> business;</li> <li>(c) otherwise significantly limiting the <i>supervised person's investment-related</i> activities; or</li> <li>(d) imposing a civil money penalty of more than \$2,500 on the <i>supervised person</i>.</li> </ol> </li> </ol> <p>Not applicable to Mr. Breskin.</p>

<p><b>Item 4.A</b></p>	<p>If the <i>supervised person</i> is actively engaged in any <i>investment-related</i> business or occupation, including if the <i>supervised person</i> is registered, or has an application pending to register, as a broker-dealer, registered representative of a broker-dealer, futures commission merchant (“FCM”), commodity pool operator (“CPO”), commodity trading advisor (“CTA”), or an associated <i>person</i> of an FCM, CPO, or CTA, disclose this fact and describe the business relationship, if any, between the advisory business and the other business.</p> <ol style="list-style-type: none"> <li>1. If a relationship between the advisory business and the <i>supervised person’s</i> other financial industry activities creates a material conflict of interest with <i>clients</i>, describe the nature of the conflict and generally how you address it.</li> <li>2.
