A.) Arbitration

i.) John J. Betterman has gone to arbitration one (1) time since beginning in the business in March of 1987. As described in the Investment Adviser Representative Public disclosure Report, please read below:

- o The arbitration took place while Mr. Betterman was at Merrill Lynch, Pierce, Fenner and Smith, Inc.

- Allegations: Customers allege that Financial Adviser made unsuitable investments in light of their investment objectives. The investment strategy was also contrary to the long-term growth portfolio selected for them. Customers further allege that Financial Advisor gave false and misleading assurances regarding their accounts.
 - Alleged Damages: \$680,699.00
 - Settlement Amount: \$180,000.00
 - This claim was settled at mediation, without admitting any liability, to avoid the expense of further litigation.
- ii.) There have been no awards where John J. betterman has been found liable in a civil, self-regulatory or administrative proceeding involving stated elements.
- iii.) John J. Betterman has IRS Tax Liens from 2007, 2008 and 2014 for a total of \$167,411.38. These liens accumulated as a result of a divorce.
- iv.) John J. Betterman has State of Illinois Tax Liens from 2014 for a total of \$13,989.
