Item 4 – Advisory Services

A. Firm Information

American Financial Network Advisory Services, LLC (“AFN” or the “Advisor”) is a registered investment advisor with the U.S. Securities and Exchange Commission (“SEC”), which is organized as a Limited Liability Company (“LLC”) under the laws of the State of Delaware. AFN was founded in October 2012, and is a wholly-owned subsidiary of American Financial Network, LLC. American Financial Network, LLC is owned and operated by Brett S. Ellen. This Disclosure Brochure provides information regarding the qualifications, business practices, and the advisory services provided by AFN.

B. Advisory Services Offered

AFN offers investment management, financial planning, consulting and advisory services to individuals, high net worth individuals, corporate clients and retirement plans in California and other states (each referred to as a “Client”). Additionally, AFN offers executive and employee benefit services to its corporate clients. AFN offers clients a highly customized approach to investing with comprehensive financial solutions, plus service and support that we believe is unparalleled in the industry. Utilizing innovative investment techniques, AFN specializes in asset allocation and portfolio design. Clients benefit from our expertise with full access to a team of accomplished professionals and a vast array of financial products and advisory services.

Investment Management Services

AFN provides customized investment advisory solutions for its Clients. This is achieved through continuous personal Client contact and interaction while providing discretionary investment management and consulting services. AFN works with each Client to identify their investment goals and objectives as well as risk tolerance and financial situation in order to create a portfolio allocation.

AFN will then construct a portfolio, consisting of individual equity securities, diversified mutual funds, exchange-traded funds (“ETFs”), and/or individual fixed income securities to achieve the Client’s investment goals. For certain accounts, the Advisor may employ options strategies, including covered call options or collar strategies (selling call options and buying put options). The Advisor may also utilize other types of securities as appropriate to meet the needs of its Clients.

Depending on each Client’s unique circumstances, AFN may implement a Client portfolio using one or more of AFN’s model portfolios or develop a custom investment strategy. AFN will construct, implement and monitor the portfolio to ensure it meets the goals, objectives, circumstances, and risk tolerance agreed to by the Client. Each Client will have the opportunity to place reasonable restrictions on the types of investments to be held in their respective portfolio, subject to the acceptance by the Advisor.

AFN evaluates and selects investments for inclusion in Client portfolios only after applying their internal due diligence process. AFN’s investment strategy is primarily long-term focused, but the Advisor may buy, sell or re-allocate positions that have been held less than one year to meet the objectives of the Client or due to market conditions. AFN may recommend, on occasion, redistributing investment allocations to diversify the portfolio. AFN may recommend specific positions to increase sector or asset class weightings. The Advisor may recommend employing cash positions as a possible hedge against market movement. AFN may recommend selling positions for reasons that include, but are not limited to, harvesting capital gains or losses, business or sector risk exposure to a specific security or class of securities, overvaluation or overweighting of the position[s] in the portfolio, change in risk tolerance of Client, generating cash to meet Client needs, or any risk deemed unacceptable for the Client’s risk tolerance.

AFN will provide investment advisory services and portfolio management services and will not provide securities custodial or other administrative services. At no time will AFN accept or maintain custody of a Client’s funds or securities, except for the authorized deduction of the Advisor’s fees. All Client assets will be managed within their designated brokerage account or pension account, pursuant to the Client investment advisory agreement.

Managed Account Programs

AFN may recommend to Clients that all or a portion of their portfolio be implemented by utilizing one or more unaffiliated money managers participating in a managed accounts program at the Client's Custodian (the "Program Sponsor"). The Client will then enter into a program and investment advisory agreement with the Program Sponsor and the participating money manager[s]. The Advisor will assist and advise the Client in establishing investment objectives for the account, the selection of the money manager[s], and defining any restrictions on the account. AFN will continue to provide oversight of the Client's account[s] and ongoing monitoring of the activities of the unaffiliated money managers.

These money managers will develop an investment strategy to meet those objectives by identifying appropriate investments and monitoring such investments. In consideration for such services, the Program Sponsor will charge a program fee that includes the investment advisory fee of the money managers, the administration of the program and trading, clearance and settlement costs. The Program Sponsor will add AFN's investment advisory fee (described below in Item 5) and will deduct the overall fee from the Client account, generally at the start of each calendar quarter. The asset-based program fee is tiered and varies depending on the size of the account, the asset class of the underlying securities and the sub-advisor selected. AFN does not receive any compensation from these unaffiliated money managers or the Program Sponsor, other than AFN's investment advisory fee (described in Item 5).

The Client, prior to entering into an agreement with a Program Sponsor, will be provided with the Program Sponsor's Form ADV Part 2A (or a brochure that makes the appropriate disclosures). In addition, AFN and its Client will agree in writing that that selected Program Sponsor will manage the Client's account on a discretionary basis.

Selection of Other Advisors

AFN may periodically recommend and refer clients to unaffiliated money managers or investment advisors ("Other Advisor") at AFN's discretion or the Client's request. Through this arrangement, the Client will then enter into an advisory agreement with that Other Advisor to which that Other Advisor will assist and advise the Client in establishing investment objectives and develop an investment strategy to meet those objectives by identifying appropriate investments and monitoring such investments. In consideration for such Other Advisor services, the Other Advisor will receive an investment advisory fee, billed based on the fee schedule the Client establishes with the Other Advisor.

AFN will receive a portion of the investment advisory fee for the solicitation and referral of the Client to the Other Advisor, and may assist the Client in completing their account opening paperwork. AFN may also assist in the development of the initial policy recommendations and managing the Client's relationship with the Other Advisor.

The Client, prior to entering into an agreement with the Other Advisor, will be provided with the advisor's Form ADV Part 2A (or a brochure that makes the appropriate disclosures).

Financial Planning, Consulting and Advisory Services

AFN will typically provide a variety of financial planning services to individuals, families and businesses, pursuant to the terms of the written agreement between the Advisor and the Client.

For individual planning engagements, AFN employs a goals-driven custom financial planning process, which includes a detailed Cash Flow Analysis, Evaluation of Existing Holdings, an Investment Policy Statement ("IPS") and Custom Allocation Design. Services are offered in several areas of a Client's financial situation, depending on their goals, objectives and financial situation.

Generally, such financial planning services will involve preparing a financial plan or rendering a financial consultation for clients based on the Client's financial goals and objectives. This planning or consulting may encompass one or more areas of need, including, but not limited to investment planning, retirement planning, personal savings, education savings and other areas of a Client's financial situation.

A financial plan developed for or financial consultation rendered to the Client will usually include general recommendations for a course of activity or specific actions to be taken by the Client. For example,

recommendations may be made that the Client start or revise their investment programs, commence or alter retirement savings, establish education savings and/or charitable giving programs. AFN may also refer Clients to an accountant, attorney or other specialist, as appropriate for their unique situation. For certain financial planning engagements, the Advisor will provide a written summary of Client's financial situation, observations, and recommendations. For consulting or ad-hoc engagements, the Advisor may not provide a written summary. Plans or consultations are typically completed within six months of contract date, assuming all information and documents requested are provided promptly.

For corporate Client engagements, AFN provides corporate and executive and employee benefits services that include:

- Entity Planning
- Compensation consulting, and Short-, Intermediate-, and Long-term Incentive Planning
- Qualified Planning with Defined Contribution, Defined Benefit, and Employee Stock Ownership Plans
- Elective / Voluntary Plans
- Non-Qualified Planning including Deferred Compensation Plans (DCPs) and SERPs
- Risk Management Planning
- Business Continuation Planning and Exit Strategies
- Company, Executive and/or Employee Wealth Management Services
- Executive and Employee Financial Planning Services

Financial planning, consulting and/or advisory recommendations may pose a potential conflict between the interests of the Advisor and the interests of the Client. Clients are not obligated to implement any recommendations made by the Advisor or maintain an ongoing relationship with the Advisor. If the Client elects to act on any of the recommendations made by the Advisor, the Client is under no obligation to effect the transaction through the Advisor.

Retirement Plan Advisory and Consulting Services

AFN provides retirement plan advisory and consulting services ("Plan Services") to the sponsors of each plan (herein the "Plan Sponsor" and "Plan", respectively). AFN will customize its advice to the needs of each Client or Plan, as appropriate. AFN provides the following services to its Clients as outlined the in Client agreement.

Pension/Retirement Plan Consulting Services - AFN provides the following Plan Services:

- Plan Fiduciary Services
- Communication and Education

Plan Fiduciary Services - AFN serves as either a 3(21) or 3(38) Fiduciary in support of the Plan Sponsor, depending on the terms of the agreement with the Plan. AFN provides the following Plan Fiduciary Services pursuant to the terms of the Advisor's agreement with each Plan Sponsor:

- Vendor Analysis
- Employee Enrollment and Education Tracking
- Investment Policy Statement
- Investment Monitoring
- Investment Discretion (3(38) engagements only)
- Performance Reports
- Ongoing Investment Recommendation and Assistance
- ERISA 404(c) Assistance
- Benchmarking Services

Communication and Education - AFN provides Communication and Education to the Plan and its Participants, pursuant to the terms of the Advisor's agreement with each Plan Sponsor:

- Direct employee contact by phone, e-mail or letter upon eligibility to promote enrollment

- Investment education
- Comprehensive financial planning
- Regular on-site advisor visits with staff for account updates and reviews
- Periodic company-wide employee survey of retirement plan understanding
- Customer satisfaction surveys
- Periodic employee group education opportunities

C. Client Account Management

Prior to engaging AFN to provide investment advisory services, each Client is required to enter into one or more agreements with the Advisor that define the terms, conditions, authority and responsibilities of the Advisor and the Client. These services may include:

- Establishing an Investment Policy – AFN, in connection with the Client, may develop a policy or formal IPS that summarizes the Client's investment goals and objectives along with the broad strategy[ies] to be employed to meet the objectives.
- Asset Allocation – AFN will develop a strategic asset allocation that is targeted to meet the investment objectives, time horizon, financial situation and tolerance for risk for each Client.
- Portfolio Construction – AFN will develop a portfolio for the Client that is intended to meet the stated goals and objectives of the Client.
- Investment Management and Supervision – AFN will provide investment management and ongoing oversight of the Client's portfolio and overall account.

D. Wrap Fee Programs

AFN typically pays the transaction fees for Client accounts as part of its overall investment advisory fees (See Item 5 – Fees and Compensation). The inclusion of these transaction costs into the investment advisory fee is generally considered a "wrap fee program". While traditional wrap fee programs often have a defined set of investment options and uniform trading practices, AFN *customizes* its investment advisory services for its Clients. AFN's Wrap Fee Program merely provides for these services under a single annualized fee. A copy of this Wrap Fee Brochure is attached as Appendix 1 to this Disclosure Brochure.

E. Assets Under Management

As of the December 31, 2015, AFN manages approximately \$330,000,000 in assets, including approximately \$300,000,000 in discretionary assets and \$30,000,000 in non-discretionary assets.

Item 5 – Fees and Compensation

The following paragraphs detail the fee structure and compensation methodology for services provided by the Advisor. Each Client shall sign one or more agreements that detail the responsibilities of AFN and the Client.

A. Fees for Advisory Services

Investment Management Services

Investment advisory fees are paid quarterly, in advance of each calendar quarter, pursuant to the terms of the investment advisory agreement. Investment advisory fees are based on the market value of assets under management at the end of the preceding quarter. Investment Advisory Fees range from an annual rate of 3.00% to 1.15% based on the size and complexity of the Client relationship. Clients with smaller accounts and/or multiple objectives may be charged a higher fee. Please note that Clients may be able to obtain services for lower rates for investment management services from sources other than AFN.

The investment advisory fee in the first quarter of service is prorated to the inception date of the account[s] to the end of the first quarter. Fees may be negotiable at the discretion of the Advisor. The Client's fees will take into consideration the aggregate assets under management with Advisor. All securities held in accounts managed by AFN will be independently valued by the designated Custodian. AFN will not have the authority or responsibility to value portfolio securities.

Managed Accounts Programs

Fees for Clients participating in managed accounts programs will include AFN's investment advisory fee above plus the Program Sponsors Fee. Fees are generally calculated by the Program Sponsor and remitted to the Advisor.

Selection of Other Advisors

For Clients referred by the Advisor to an unaffiliated investment advisor, the Client's fee will be deducted from the Client's account[s] with the respective manager and a portion of the investment advisory fee will be provided to AFN. Please see Item 14 for additional details.

Financial Planning, Consulting and Advisory Services

AFN offers financial planning or consulting services on a fixed fee basis, based on the nature, complexity and duration of the services to be provided to the Client. The Scope of Work and associated costs are provided to the Client prior to engaging in these services.

The Advisor's fee is exclusive of, and in addition to, brokerage fees, transaction fees, and other related costs and expenses, which may be incurred by the Client. However, the Advisor shall not receive any portion of these commissions, fees, and costs. The hourly fees are determined after considering many factors, such as the level and scope of the services.

Retirement Plan Advisory and Consulting Services

Fees for Retirement Plan Advisory and Consulting Services are billed either as a percentage of assets advised under the Plan or at a fixed annual rate. The Advisor's fees are negotiable and vary based on the size and complexity of a Plan as well as the scope of services to be provided.

B. Fee Billing

Investment Management Services

Investment advisory fees will be calculated by the Advisor or its delegate and deducted from the Client's account[s] at the Custodian. The Advisor shall send an invoice to the Custodian indicating the amount of the fees to be deducted from the Client's account[s] at the respective quarter end date. The amount due is calculated by applying the quarterly rate (annual rate divided by 4) to the average assets under management with AFN for the quarterly period. Clients will be provided with a statement, at least quarterly, from the Custodian reflecting deduction of the investment advisory fee.

It is the responsibility of the Client to verify the accuracy of these fees as listed on the Custodian's brokerage statement as the Custodian does not assume this responsibility. Clients provide written authorization permitting AFN to be paid directly from their accounts held by the Custodian as part of the investment advisory agreement and separate account forms provided by the Custodian.

Managed Accounts Programs

Clients participating in a managed accounts program will be billed in accordance to the agreement with the respective Program Sponsor or advisor. Program Sponsors will add AFN's investment advisory fee and deduct the overall fee from the Client's account[s].

Financial Planning, Consulting and Advisory Services

Financial planning, consulting and advisory fees are typically invoiced in one of three ways:

- 1) An upfront retainer fee
- 2) A flat fee often invoiced 50% upon execution of the financial planning, consulting or advisory agreement and 50% upon receipt of the agreed-upon deliverable for a specific project, period of time, and/or set fee.
- 3) On-going Fee for ongoing service and support, typically billed quarterly in arrears.

Retirement Plan Advisory and Consulting Services

Fees for Plan Services are either deducted from the assets of the Plan or paid directly by the Plan Sponsor based on the terms of the agreement between the Advisor and the Plan/Plan Sponsor.

C. Other Fees and Expenses

Clients may incur certain fees or charges imposed by third parties, other than AFN, in connection with investment made on behalf of the Client's account[s].

For Clients in the AFN Wrap Fee Program, all normal custodial and execution fees charged by the Custodian are included in the Client's investment advisory fee as noted above. Clients are responsible for all custodial and securities execution fees charged by the Custodian and executing broker-dealer for services provided outside the AFN Wrap Fee Program. In this situation, the investment advisory fee charged by AFN is separate and distinct from these custody and execution fees.

In addition, all fees paid to AFN for investment advisory services are separate and distinct from the expenses charged by mutual funds and exchange-traded funds to their shareholders, if applicable. These fees and expenses are described in each fund's prospectus. These fees and expenses will generally be used to pay management fees for the funds, other fund expenses, account administration (e.g., custody, brokerage and account reporting), and a possible distribution fee. A Client could invest in these products directly, without the services of AFN, but would not receive the services provided by AFN which are designed, among other things, to assist the Client in determining which products or services are most appropriate to each Client's financial situation and objectives. Accordingly, the Client should review both the fees charged by the fund[s] and the fees charged by RPg to fully understand the total fees to be paid.

D. Advance Payment of Fees and Termination

Investment Management Services

AFN is compensated for its services in advance the quarter in which investment advisory services are rendered. Either party may terminate the investment advisory agreement with AFN, at any time, by providing advance written notice to the other party. The Client shall be responsible for investment advisory fees up to and including the effective date of termination. Upon termination, the Advisor will refund any unearned, prepaid investment advisory fees from the effective date of termination to the end of the quarter. The Client's investment advisory agreement with the Advisor is non-transferable without the Client's written approval.

Managed Accounts Programs

In the event that a Client should wish to terminate their relationship with a managed accounts program, the terms for termination will be set forth in the respective agreements between the Client and the Program Sponsor. AFN will assist the Client with the termination and transition as appropriate.

Financial Planning, Consulting and Advisory Services

AFN may be partially compensated for planning, consulting and advisory services in advance performing services. Either party may terminate the agreement with the Advisor, at any time, by providing written notice to the other party. In addition, the Client may terminate the agreement within five (5) business days of signing the Advisor's financial planning or consulting agreement at no cost to the Client. After the five-day period, the Client will incur charges for bona fide advisory services rendered to the point of termination and such fees will be due and payable by the Client. Upon termination, the Client shall be billed for actual hours logged on the planning project times the agreed-upon hourly rate or in the case of a fixed fee, the percentage completion of the engagement. For engagements based on a retainer, the fee due is the percentage of the period in which the services were rendered, up to and including the effective date of termination. Refunds will be given on a pro-rata basis.

Retirement Plan Advisory and Consulting Services

Fees for Plan Services are either billed quarterly in advance or at the end of the quarter in which services are provided, depending on the terms of the agreement between the Advisor and the Plan/Plan Sponsor. Either party may terminate an agreement with advance written notice to the other party. Upon termination, the Advisor will refund any unearned, prepaid fees from the effective date of termination to the end of the quarter. The Client's agreement with the Advisor is non-transferable without the Client's written approval.

E. Compensation for Sales of Securities

AFN, as a registered investment advisor, does not buy or sell securities to generate securities commissions and does not receive any compensation for securities transactions in any Client account, other than the investment advisory fees noted above. Advisory Persons of AFN may also be registered representatives of a broker-dealer or licensed as an insurance professional. In either of these separate capacities, an Advisory Person (and AFN indirectly) may receive compensation for securities or investments implemented outside of AFN's fee-based services described above. At no time will AFN earn both a commission and an ongoing advisory fee on the same assets. Please see Item 10 below.

Item 6 – Performance-Based Fees and Side-By-Side Management

AFN does not charge performance-based fees for its investment advisory services. The fees charged by AFN are as described in Item 5 – Fees and Compensation above and are not based upon the capital appreciation of the funds or securities held by any Client. AFN does not manage any proprietary investment funds or limited partnerships (for example, a mutual fund or a hedge fund) and has no financial incentive to recommend any particular investment options to its Clients.

Item 7 – Types of Clients

AFN offers investment advisory services to individuals, high net worth individuals, corporate clients and retirement plans in California and other states. The relative percentage of each type of Client is available on AFN's Form ADV Part 1. These percentages will change over time. AFN generally does not impose a minimum account size for establishing a relationship.

Item 8 – Methods of Analysis, Investment Strategies and Risk of Loss

A. Methods of Analysis

AFN primarily employs both fundamental and technical analysis methods in developing investment strategies for its Clients. Research and analysis from AFN is derived from numerous sources, including financial media companies, third-party research materials, Internet sources, and review of company activities, including annual reports, prospectuses, press releases and research prepared by others. As noted above, AFN generally employs a long-term investment strategy for its Clients, as consistent with their financial goals. AFN will typically hold all or a portion of a security for more than a year, but may hold for shorter periods for the purpose of rebalancing a portfolio or meeting the cash needs of Clients. At times, AFN may also buy and sell positions that are more short-term in nature, depending on the goals of the Client and/or the fundamentals of the security, sector or asset class.

B. Risk of Loss

Investing in securities involves certain investment risks. Securities may fluctuate in value or lose value. Clients should be prepared to bear the potential risk of loss. AFN will assist Clients in determining an appropriate strategy based on their tolerance for risk and other factors noted above. However, there is no guarantee that a Client will meet their investment goals.

Fundamental analysis utilizes economic and business indicators as investment selection criteria. These criteria are generally ratios and trends that may indicate the overall strength and financial viability of the entity being analyzed. Assets are deemed suitable if they meet certain criteria to indicate that they are a strong investment with a value discounted by the market. While this type of analysis helps the Advisor in evaluating a potential investment, it does not guarantee that the investment will increase in value. Assets meeting the investment criteria utilized in the fundamental analysis may lose value and may have negative investment performance. The Advisor monitors these economic indicators to determine if adjustments to strategic allocations are appropriate.

Technical analysis involves the analysis of past market data rather than specific company data in determining the recommendations made to clients. Technical analysis may involve the use of charts to identify market patterns and trends, which may be based on investor sentiment rather than the fundamentals of the company. The

primary risk in using technical analysis is that spotting historical trends may not help to predict such trends in the future. Even if the trend will eventually reoccur, there is no guarantee that AFN will be able to accurately predict such a reoccurrence. More details on the Advisor's review process are included in Item 13.

Each Client engagement will entail a review of the Client's investment goals, financial situation, time horizon, tolerance for risk and other factors to develop an appropriate strategy for managing a Client's account. Client participation in this process, including full and accurate disclosure of requested information, is essential for the analysis of a Client's account. The Advisor shall rely on the financial and other information provided by the Client or their designees without the duty or obligation to validate the accuracy and completeness of the provided information. It is the responsibility of the Client to inform the Advisor of any changes in financial condition, goals or other factors that may affect this analysis.

The risks associated with a particular strategy are provided to each Client in advance of investing Client accounts. The Advisor will work with each Client to determine their tolerance for risk as part of the portfolio construction process.

Options Contracts

Investments in options contracts have the risk of losing value in a relatively short period of time. Option contracts are leveraged instruments that allow the holder of a single contract to control many shares of an underlying stock. This leverage can compound gains or losses. The Advisor primarily utilizes option strategies to reduce portfolio risk through covered call options or collar strategies.

A *covered call* is an options strategy whereby an investor holds a long position in an asset and writes (sells) call options on that same asset in an attempt to generate increased income from the asset. This is often employed when an investor has a short-term neutral view on the asset and for this reason hold the asset long and simultaneously have a short position via the option to generate income from the option premium.

An *options collar strategy* is protective options strategy that is implemented after a long position in a stock has experienced substantial gains. It is created by buying an out of the money put option while simultaneously writing (selling) an out of the money call option.

Management Through Similarly Managed Accounts

AFN often manages Client portfolios by allocating portfolio assets among various securities on a discretionary basis using one or more of its proprietary investment strategies (collectively referred to as "investment strategy"). In so doing, AFN buys, sells, exchanges and/or transfers securities based upon the investment strategy. AFN's management using the investment strategy complies with the requirements of Rule 3a-4 of the Investment Company Act of 1940, as amended. Rule 3a-4 provides similarly managed accounts, such as the investment strategy, with a safe harbor from the definition of an investment company. Securities in the investment strategy may be exchanged and/or transferred without regard to a Client's individual tax ramifications. As further discussed in response to Item 12.B. (below), AFN allocates investment opportunities among its clients on a fair and equitable basis.

Past performance is not a guarantee of future returns. Investing in securities and other investments involve a risk of loss that each Client should understand and be willing to bear. Clients are reminded to discuss these risks with the Advisor.

Item 9 – Disciplinary Information

AFN and its Advisory Persons value the trust you place in us. As we advise all Clients, we encourage you to perform the requisite due diligence on any advisor or service provider in which you partner. Our backgrounds are on the Investment Adviser Public Disclosure website at www.adviserinfo.sec.gov by searching for our firm name or by our CRD # 160322. You may also research the background of AFN's personnel (herein "Advisory Persons"). Mr. Ellen, President of AFN has events to disclose that are viewable on this site. Mr. Ellen entered into a stipulation and consent with the State of New York Insurance Department related to the failure to provide an affirmative answer on the New York insurance licensing questionnaire relating to a temporary suspension of his

CFP designation. Mr. Ellen's CFP designation was suspended for two years and had been reinstated in August 2005. Mr. Ellen paid a monetary fine of \$500 and was thereafter licensed with the New York Insurance Division.

Item 10 – Other Financial Industry Activities and Affiliations

Broker-Dealer Affiliation

Certain Supervised Persons of AFN, each in their individual capacity, are also registered representatives of United Planners Financial Services of America ("United Planners"), a registered securities broker-dealer, member of the Financial Industry Regulatory Authority ("FINRA") and the Securities Investor Protection Corporation ("SIPC"). Should recommendations be implemented through a Supervised Person's separate capacity as registered representative, the Supervised Person (and AFN indirectly) may receive commissions on those assets placed with United Planners. AFN and its Supervised Persons will not receive both a commission and an ongoing investment advisory fee on the same assets. If assets are implemented through United Planners, an investment advisory fee will not be assessed. The Advisor may charge for financial planning or consulting engagements that result in product implementations through United Planners. Commissions paid through United Planners may be higher or lower than at other broker/dealers. Additionally, account maintenance costs and transaction costs may be higher or lower at United Planners than at other broker/dealers. Clients are not obligated to implement recommendations through AFN, its Supervised Persons or through United Planners.

Insurance Agency Affiliations

Certain Supervised Persons of AFN are also licensed insurance professionals. Insurance sales are implemented separate and apart from a Supervised Person's role with AFN. As an insurance professional, a Supervised Person may receive customary commissions and other related revenues from the various insurance companies whose products are sold. Commissions generated by insurance sales do not offset regular advisory fees. This may cause a conflict of interest in recommending certain products of the insurance companies. Clients are under no obligation to implement any recommendations made by AFN or its Supervised Persons.

Relationship with Dynasty Financial Partners, LLC

AFN maintains a business relationship with Dynasty Financial Partners, LLC ("Dynasty"), which provides the Advisor with operational and back office support including access to a network of service providers. Through the Dynasty network of service providers, AFN has access to discounts on trading technology, reporting, custody, brokerage, compliance and other related services. While AFN believes this open architecture structure for operational services best serves the interests of its advisory Clients, this relationship may potentially present certain conflicts of interest due to the fact that Dynasty retains a portion of the platform or other third party fees paid by the Advisor or Clients for the services referenced above. In light of the foregoing, AFN seeks at all times to ensure that any material conflicts are addressed on a fully-disclosed basis and handled in a manner that is aligned with its Clients' best interests. AFN does not receive any portion of the fees paid directly to Dynasty, its affiliates or the service providers made available through Dynasty's platform. In addition, the Advisor reviews all such relationships, including the service providers engaged through Dynasty, on an ongoing basis in an effort to ensure Clients are receiving competitive rates in relation to the quality and scope of the services provided.

Client Relationships

The Advisor may utilize services provided by certain business Clients and/or refer other Clients to certain business Clients. Prior to engaging in such activities, the Advisor will disclose any potential conflicts of interest to the Client.

Item 11 – Code of Ethics, Participation or Interest in Client Transactions and Personal Trading

A. Code of Ethics

AFN has implemented a Code of Ethics that defines our fiduciary commitment to each Client. This Code of Ethics applies to all persons associated with AFN (our "Supervised Persons"). The Code of Ethics was developed to provide general ethical guidelines and specific instructions regarding our duties to you, our Client. AFN and its personnel owe a duty of loyalty, fairness and good faith towards each Client. It is the obligation of AFN associates to adhere not only to the specific provisions of the Code, but also to the general principles that guide

the Code. The Code of Ethics covers a range of topics that address employee ethics and conflicts of interest. To request a copy of our Code of Ethics, please contact us at (818) 264-4644 or via email at dbecerra@afn-net.com.

B. Personal Trading with Material Interest

AFN allows our Supervised Persons to purchase or sell the same securities that may be recommended to and purchased on behalf of Clients. AFN does not act as principal in any transactions. In addition, the Advisor does not act as the general partner of a fund, or advise an investment company. AFN does not have a material interest in any securities traded in Client accounts.

C. Personal Trading in Same Securities as Clients

AFN allows our Supervised Persons to purchase or sell the same securities that may be recommended to and purchased on behalf of Clients. Owning the same securities we recommend (purchase or sell) to you presents a potential conflict of interest that, as fiduciaries, we must disclose to you and mitigate through policies and procedures. As noted above, we have adopted, consistent with Section 204A of the Investment Advisers Act of 1940, a Code of Ethics, which addresses insider trading (material non-public information controls) and personal securities reporting procedures. When trading for personal accounts, Supervised Persons of AFN may have a conflict of interest if trading in the same securities. The fiduciary duty to act in the best interest of its Clients can potentially be violated if personal trades are made with more advantageous terms than Client trades, or by trading based on material non-public information. This risk is mitigated by AFN requiring reporting of personal securities trades by its Supervised Persons for review by the Supervised Persons's supervisor or the CCO. We have also adopted written policies and procedures to detect the misuse of material, non-public information. In addition the Code of Ethics governs Gifts and Entertainment given by and provided to the Advisor, outside employment activities of Supervised Persons, Employee reporting, sanctions for violations of the Code of Ethics, and records retention requirements for various aspects of the Code of Ethics.

D. Personal Trading at Same Time as Client

While AFN allows our Supervised Persons to purchase or sell the same securities that may be recommended to and purchased on behalf of Clients, such trades are typically aggregated with Client orders or traded afterwards. At no time will AFN or any Supervised Person transact in any security to the detriment of any Client.

Item 12 – Brokerage Practices

A. Recommendation of Custodian[s]

AFN does not have discretionary authority to select the broker-dealer/custodian for custodial and execution services or the administrator for defined contribution accounts. The Client will select the broker-dealer or custodian (herein the "Custodian") to safeguard Client assets and authorize AFN to direct trades to the Custodian as agreed in the Investment Advisory Agreement. Further, AFN does not have the discretionary authority to negotiate commissions on behalf of our Clients on a trade-by-trade basis.

Where AFN does not exercise discretion over the selection of the Custodian, it may recommend a Custodian to Clients for execution and/or custodial services. As noted in Item 10, Advisory Persons of AFN are also registered representatives of United Planners, which necessitates that United Planners keep and maintain certain records and perform other compliance functions in relation to the advisory activities of AFN. These obligations require United Planners to coordinate with and have the cooperation of the Custodian[s] recommended by AFN. Accordingly, United Planners has established a limited list of custodians in which AFN may recommend.

AFN will typically recommend that Client utilize Charles Schwab, Inc., through its Advisor Services division (herein "Schwab"), as the primary Custodian. Clients are not obligated to use the recommended Custodian and will not incur any extra fee or cost associated with using a broker not recommended by AFN. Following are some of the benefits that AFN and its Clients derive from AFN's relationship with Schwab.

Services that Benefit You.

Schwab's institutional brokerage services include access to a broad range of investment products, execution of securities transactions, and custody of Client assets. The investment products available through Schwab include

some to which we might not otherwise have access or that would require a significantly higher minimum initial investment by our Clients. Schwab's services described in this paragraph generally benefit the Client and the Client's account[s].

Services that May Not Directly Benefit You.

Schwab also makes available to AFN other products and services that benefit us but may not directly benefit the Client or your account[s]. These products and services assist AFN in managing and administering our Clients' accounts. Schwab provided AFN with investment research and also makes available software and other technology that:

- provide access to Client account data (such as duplicate trade confirmations and account statements);
- facilitate trade execution and allocate aggregated trade orders for multiple Client accounts;
- provide pricing and other market data;
- facilitate payment of our fees from our Clients' accounts; and
- assist with back-office functions, recordkeeping and Client reporting.

Services that Generally Benefit Only Us.

Schwab also offers other services intended to help AFN manage and further develop our business enterprise. These services include:

- educational conferences and events
- technology, compliance, legal, and business consulting;
- publications and conferences on practice management and business succession; and
- access to employee benefits providers, human capital consultants and insurance providers.

Schwab may provide some of these services itself. In other cases, it will arrange for third-party vendors to provide the services to AFN. Schwab may also discount or waive its fees for some of these services or pay (reimburse) all or a part of a third party's fees. Schwab may also provide us with other benefits such as occasional business entertainment of our personnel.

As discussed above, certain Supervised Persons in their respective individual capacities, are registered representatives of United Planners. These Advisory Persons are subject to FINRA Rule 3040, which restricts registered representatives from conducting securities transactions away from United Planners without prior consent. United Planners has approved Schwab as a Custodian option for these Advisory Persons.

Following are additional details regarding the brokerage practices of the Advisor:

1. Soft Dollars - Soft dollars are revenue programs offered by broker-dealers whereby an advisor enters into an agreement to place security trades with the broker in exchange for research and other services. **AFN does not participate in soft dollar programs sponsored or offered by any broker-dealer. However, AFN does receive economic benefit from Schwab resulting from their institutional relationship and a commitment of a level of assets on the Schwab platform (See Item 14.).**

2. Brokerage Referrals - AFN does not receive any compensation from any third party in connection with the recommendation for establishing a brokerage account.

3. Directed Brokerage - All Clients are serviced on a "directed brokerage basis", where AFN will place trades within the established account[s] at the Custodian designated by the Client. Further, all Client accounts are traded within their respective brokerage account[s]. The Advisor will not engage in any principal transactions (i.e., trade of any security from or to the Advisor's own account) or cross transactions with other Client accounts (i.e., purchase of a security into one Client account from another Client's account[s]). In selecting the Custodian, AFN will not be obligated to select competitive bids on securities transactions and does not have an obligation to seek the lowest available transaction costs. These costs are determined by the designated Custodian.

B. Aggregating and Allocating Trades

The primary objective in placing orders for the purchase and sale of securities for Client accounts is to obtain the most favorable net results taking into account such factors as 1) price, 2) size of order, 3) difficulty of execution,

4) confidentiality and 5) skill required of the broker. AFN will execute its transactions through an unaffiliated broker-dealer selected by the Client. AFN may aggregate orders in a block trade or trades when securities are purchased or sold through the same broker-dealer for multiple (discretionary) accounts. If a block trade cannot be executed in full at the same price or time, the securities actually purchased or sold by the close of each business day must be allocated in a manner that is consistent with the initial pre-allocation or other written statement. This must be done in a way that does not consistently advantage or disadvantage particular Client accounts.

Item 13 – Review of Accounts

A. Frequency of Reviews

Securities in Client accounts are monitored on a regular and continuous basis by Advisory Persons of AFN under the supervision of the Chief Executive Officer and the Chief Compliance Officer. Formal reviews are generally conducted at least annually or more or less frequently depending on the needs of the Client.

B. Causes for Reviews

In addition to the investment monitoring noted in Item 13.A., each Client account shall be reviewed at least annually. Reviews may be conducted more or less frequently at the Client's request. Accounts may be reviewed as a result of major changes in economic conditions, known changes in the Client's financial situation, and/or large deposits or withdrawals in the Client's account. The Client is encouraged to notify AFN if changes occur in his/her personal financial situation that might adversely affect his/her investment plan. Additional reviews may be triggered by material market, economic or political events.

C. Review Reports

The Client will receive brokerage statements no less than quarterly from the Custodian. These brokerage statements are sent directly from the Custodian to the Client. The Client may also establish electronic access to the Custodian's website so that the Client may view these reports and their account activity. Client brokerage statements will include all positions, transactions and fees relating to the Client's account[s]. The Advisor may also provide Clients with periodic reports regarding their holdings, allocations, and performance.

Item 14 - Client Referrals and Other Compensation

A. Compensation Received by AFN

AFN, as a registered investment advisor, does not receive commissions or other compensation from product sponsors, broker dealers or any un-related third party. Supervised Persons of AFN, in their separate capacity, may receive additional compensation as noted in Item 10 – Other Financial Industry Activities and Affiliations. AFN may refer Clients to various third parties to provide certain financial services necessary to meet the goals of its Clients. Likewise, AFN may receive referrals of new Clients from a third-party.

Participation in Institutional Advisor Platform

AFN has established an institutional relationship with Schwab to assist the Advisor in managing Client accounts. Access to Schwab is provided at no charge to the Advisor. AFN receives an economic benefit from Schwab in the form of the support products and services it makes available to AFN and other independent investment advisors that have their Clients maintain accounts at Schwab. These products and services, how they benefit us, and the related conflicts of interest are described above (see Item 12 – Brokerage Practices). The availability to AFN of Schwab's products and services is not based on AFN or its advisory persons giving particular investment advice, such as buying particular securities for our Clients.

Selection of Other Advisors

AFN may refer Clients to unaffiliated money managers, as detailed in Item 4. In such arrangements, AFN has a potential conflict of interest in that AFN will receive a portion of the unaffiliated money manager or investment advisor's fee collected from the Client for the referral of the Client and the relationship management support provided by AFN. To mitigate this conflict of interest, AFN will not charge investment advisory fees on assets referred to an unaffiliated manager under such arrangements.

B. Client Referrals from Solicitors

If an unaffiliated solicitor introduces a Client to AFN, AFN may pay that solicitor a referral fee in accordance with the requirements of Rule 206(4)-3 of the Investment Advisers Act of 1940, and any corresponding state securities law requirements. The solicitor will disclose the nature of the solicitor relationship with AFN at the time of the solicitation. In addition, the solicitor will provide each prospective client with a copy of this Disclosure Brochure, and a copy of the written disclosure statement from the solicitor to the Client disclosing the terms and conditions of the Program between AFN and the solicitor, including the compensation the solicitor will receive from AFN.

Item 15 – Custody

AFN does not accept or maintain custody of any Client accounts, other than the authority granted to us by Clients to deduct our investment advisory fees. All Clients must place their assets with a qualified custodian. Clients are required to select their own custodian to retain their funds and securities and direct AFN to utilize the Custodian for the Client's security transactions. AFN encourages Clients to review statements provided by the Custodian. For more information about custodians and brokerage practices, see "Item 12 - Brokerage Practices."

Item 16 – Investment Discretion

AFN generally has discretion over the selection and amount of securities to be bought or sold in Client accounts without obtaining prior consent or approval from the Client. However, these purchases or sales may be subject to specified investment objectives, guidelines, or limitations previously set forth by the Client and agreed to by AFN. Discretionary authority will only be authorized upon full disclosure to the Client. The granting of such authority will be evidenced by the Client's execution of an investment advisory agreement containing all applicable limitations to such authority. All discretionary trades made by AFN will be in accordance with each Client's investment objectives and goals.

Item 17 – Voting Client Securities

AFN does not accept proxy-voting responsibility for any Client. Clients will receive proxy statements directly from the Custodian. The Advisor will assist in answering questions relating to proxies, however, the Client retains the sole responsibility for proxy decisions and voting.

Item 18 – Financial Information

Neither AFN, nor its management has any adverse financial situations that would reasonably impair the ability of AFN to meet all obligations to its Clients. Neither AFN, nor any of its advisory persons, has been subject to a bankruptcy or financial compromise. AFN is not required to deliver a balance sheet along with this Disclosure Brochure, as the firm does not collect fees of \$1,200 or more for services to be performed six months or more in advance.

Item 4 – Services Fees and Compensation

A. Services

AFN provides customized wealth advisory services for its Clients. The AFN Wrap Fee Program (the “Wrap Fee Program”) is a fee Program that includes the investment advisory services provided by AFN along with the normal trading costs for securities transactions. AFN has negotiated transaction costs with the Custodian for a flat basis point fee instead of a per transaction charge for each Client account.

AFN provides customized investment advisory solutions for its Clients, which are described in detail on Item 4 of the attached Form ADV2A – Disclosure Brochure. The Wrap Fee Program is not a different investment approach or service offering. It is simply a combined fee.

Details of this Wrap Fee Program are contained in this Appendix 1, but often reference back to the Form ADV2A – Disclosure Brochure which provides all details regarding the advisory services of AFN. **Please see Item 4 – Advisory Services of the Disclosure Brochure for details on AFN’s investment philosophy and related services.**

B. Program Costs

Investment advisory fees are paid quarterly, in advance of each calendar quarter, pursuant to the terms of the investment advisory agreement. Investment advisory fees are based on the market value of assets under management at the end of the preceding quarter. Investment advisory fees range from an annual rate of 3.00% to 1.15% based on the size and complexity of the Client relationship. Clients with smaller accounts and/or multiple objectives may be charged a higher fee. AFN does not charge performance-based fees. Certain Clients may have fees schedules or methodologies that vary from above.

Services provided under this Wrap Fee Program may cost the Client more or less than paying for investment management services and transaction costs separately. The Frequency of trading, size of accounts and the securities used to construct a portfolio are factors that drive the overall cost of managing a portfolio. Additional information regarding fees are included in Item 5 of Form ADV Part 2A – Disclosure Brochure.

AFN provides this Wrap Fee Program to provide a single fee that includes investment management and all normal securities transactions costs associated with AFN investment strategies. The Wrap Fee Program does not include securities transaction fees for Client-directed transactions. Further, the Wrap Fee Program does not include the underlying expenses of mutual funds and exchange-traded funds, which are deducted directly from these investments. Please see Item C. Fees below as well as Item 5.C. of the Disclosure Brochure. **Please see Item 5 – Fees and Compensation.**

C. Fees

The AFN Wrap Fee Program includes typical securities trading costs incurred in connection with the discretionary investment management services provided by AFN. Securities transaction fees for Client directed trades are borne by the Client. There are other fees charged by unaffiliated third parties that Clients should fully understand. Please see Item 5.C. – Other Fees and Expenses in the Disclosure Brochure (included with this Wrap Fee Brochure).

D. Compensation

AFN is the sponsor and portfolio manager of this Wrap Fee Program. AFN receives investment advisory fees paid by Clients for participating in the Wrap Fee Program and pays the Custodian for the costs associated with the normal trading activity in the Client’s account[s].

Item 5 – Account Requirements and Types of Clients

AFN offers investment advisory services to high net worth individuals, trusts, estates, charities, pension plans and institutional clients. AFN generally does not impose a minimum account size for establishing a relationship. **Please see Item 7 of the Disclosure Brochure for additional details.**

Item 6 – Portfolio Manager Selection and Evaluation

A. Portfolio Manager Selection

AFN serves as sponsor and as portfolio manager for the services under this Wrap Fee Program. AFN may also select unaffiliated investment advisors that have separate fee schedules.

B. Related Persons

AFN personnel serve as portfolio managers for all advisory accounts, including accounts under this Wrap Fee Program. AFN does not serve as a portfolio manager for any third party wrap fee programs.

C. Supervised Persons

AFN Supervised Persons serve as portfolio managers for all accounts, including the services described in this Wrap Fee Brochure. Details of the advisory services provided are included in Item 4.A. of the Disclosure Brochure.

B. Methods of Analysis and Risk of Loss
