Item 2-Educational Background and Business Experience

Riyad Said (b. 3.2.1957) graduated from Johns Hopkins University in 1978 with a Bachelor of Arts in Economics and then proceeded to get his Master of Science from Stanford University in Management Science and Engineering-Economic Systems in 1982. In the last 10 years of his career Riyad has worked for Fannie Mae (2002-2007), where as director of business development he led several strategic business development initiatives in Fannie Mae's Single Family Mortgage Business, Sanford C. Bernstein & Co. (2007-2010), where he was a wealth advisor and worked with individual investors and business owners, and in 2010 he joined Wells Fargo Advisors, LLC as an investment advisor working with individual investors and business owners. In June of 2014, Riyad left Wells Fargo Advisors for an opportunity to be the Chief Investment Officer and Managing Member of TA Capital Management, LLC. TA Capital provides independent, fee-only investment management.
