In this capacity, Ms. Johnson may recommend securities products offered by FPS as part of an investment portfolio in a brokerage account. If clients purchase these products through Ms. Johnson, she may receive customary commissions in her separate capacity as a registered representative of FPS. Additionally, Ms. Johnson may receive a portion of 12b-1 fees from mutual funds that pay such fees, if the mutual funds are held in accounts not subject to advisory agreements. The receipt of such additional compensation may give Ms. Johnson an incentive to recommend investment products based on the compensation received, rather than on client investment needs.
