## **Item 2. Educational Background and Business Experience**

**Louis Jaffe.** Louis Jaffe, born in 1969, is the President of the Adviser. Prior to co-founding the Adviser, Mr. Jaffe worked at Deutsche Bank for 24 years. Most recently, he was a Managing Director and Head of the Institutional Client Group Debt Americas, a role he held for seven years. In this role, Mr. Jaffe had an active dialogue with some of the world's largest investors about their investment strategies and portfolios, bringing to bear the full resources of Deutsche Bank's preeminent fixed income franchise to assist these clients in navigating the markets. He managed a team of roughly 200 people responsible for the distribution of all fixed income products including interest rate, credit, emerging markets, securitized products, foreign exchange, listed derivatives and structured solutions. Previously Mr. Jaffe was the Head of the Integrated Credit Sales Group, which included the Investment Grade, High Yield and Convertible bonds, Leverage loans, Distressed debt and Structured Products Sales desks. At Deutsche Bank, Mr. Jaffe was a member of the North America corporate banking and securities executive committee, institutional client group global executive committee, markets graduate advisory board, and Deutsche Bank matched savings plan and cash account pension plan investment committee. Mr. Jaffe worked at Bankers Trust from 1991 to 1999 as a member of the credit derivatives group, when the firm was acquired by Deutsche Bank. He sits on the Board of the JCCA, UJA Wall Street Strategic Council and Advisory Council for Park Avenue Synagogue. Mr. Jaffe earned a BA in Political Science/Psychology from Syracuse University in 1991.
