Item 3: Disciplinary Information¹

There are no legal or disciplinary events material to the evaluation of Mr. Kahn.

Item 4: Other Business Activities

Mr. Kahn is registered with more than one Registered Investment Advisor (“RIA”) firms. Currently, Mr. Kahn is registered as an Investment Advisor Representative (“IAR”) with Alpha Analytics, LLC in addition to our firm. A conflict of interest may arise as a result of being an IAR for multiple RIA’s. To mitigate this conflict, Mr. Kahn, as a fiduciary, will act in the client’s best interest. Furthermore, any services that may be offered through the outside RIAs will remain separate from our firm’s advisory services and are governed under a separate agreement. Clients of AlphaNext, LLC will not be actively solicited to the outside RIAs. Additionally, Mr. Kahn owns interest in Alpha Analytics, LLC.

¹ Note: Our firm may, under certain circumstances, rebut the presumption that a disciplinary event is material. If an event is immaterial, we are not required to disclose it. When we review a legal or disciplinary event involving the advisor to determine whether it is appropriate to rebut the presumption of materiality, we consider all of the following factors: (1) the proximity of advisor to the advisory function; (2) the nature of the infraction that led to the disciplinary event; (3) the severity of the disciplinary sanction; and (4) the time elapsed since the date of the disciplinary event. If we conclude that the materiality presumption has been overcome, we prepare and maintain a file memorandum of our determination in our records. We follow SEC rule 204-2(a)(14)(iii) and similar state rules.

Item 5: Additional Compensation

Mr. Kahn does not receive any other economic benefit for providing advisory services in addition to advisory fees.

Item 6: Supervision

Robert Kahn is the sole owner and Chief Compliance Officer and as such has no internal supervision placed over him. He is, however, bound by our firm's Code of Ethics.

Item 7: Requirements for State-Registered Advisers

Mr. Kahn has not been involved in any arbitration claim alleging damages in excess of \$2,500. Furthermore, he has neither been involved in nor found liable in any civil, self-regulatory organization, or administrative proceeding nor has been the subject of any bankruptcy petitions.
