Prior to Forest, Brian was a Manager at True Partners Consulting, a Chicago-based tax consulting firm, for five years specializing in corporate tax consulting and tax provision automation through various software mediums. Brian has been with Forest since 2015 and his role is Managing Director. Brian is in charge of overseeing national company growth, leading client investment due diligence, all aspects of client service, and running on-site tailored employee education. Brian also holds a Series 65 License. The minimum qualifications required for the Series 65 License include passing the Series 65 exam.

Mallory Grove (“Mallory”) earned her Bachelor’s Degree in Accountancy and a Master’s Degree in Accountancy from the University of Illinois.
