Item 4 Advisory Business

- A. Describe your advisory firm, including how long you have been in business. Identify your principal owner(s).**

Firm Description

Wealth Strategist Partners, LLC (“Wealth Strategist Partners”, the “Firm”, “we”, or “us”), a Delaware limited liability company, provides investment and wealth management advisory services, including an outsourced Chief Investment Officer service, to individuals and families of significant net worth, as well as to their trustees and investment committees. For each client, Wealth Strategist Partners creates custom tailored investment solutions rooted in our core investment philosophy, integrating all aspects of wealth management and providing transparency, accountability and control.

Wealth Strategist Partners had its origins as the investment office for the Lucas family, formed upon the sale of the family’s business, Carnation Company, in 1985. Wealth Strategist Partners was formed in 2006 and became a registered investment adviser in 2011. Today, Wealth Strategist Partners serves a carefully chosen group of like-minded families, still including our founding family, of which two of our principals are members, as disclosed further below in Item 11.B.

Wealth Strategist Partners’ three most senior investment professionals each have over 30 years’ investment experience. All have a total commitment to and uncommon experience with families, and share with our clients the experience of long term stewardship of taxable wealth. We are principals serving principals, typically investing alongside our clients.

Principal Owners/Ownership Structure

Wealth Strategist Partners is owned by Co-Managing Partner and Chief Investment Officer Stuart Lucas, Co-Managing Partner Rodney Goldstein and Chief Operating Officer and Chief Compliance Officer Susan Lucas.

- B. Describe the types of advisory services you offer. If you hold yourself out as specializing in a particular type of advisory service, such as financial planning, quantitative analysis, or market timing, explain the nature of that service in greater detail. Wealth Strategist Partners provides investment advisory and wealth management services, including an outsourced chief investment officer service, to individuals and families who are large enough to need a customized solution and can benefit from shared scale and expertise. The Firm focuses on clients that typically have \$100 million of investable assets or more. Wealth Strategist Partners works with each client to codify long term investment goals in the context their wealth is intended to play in their lives. We seek to create for each client a comprehensive multi-asset class investment strategy that is integrated with each client’s total family enterprise, including its objectives, tax situation, estate plans, culture and governance. Often, our clients have concentrated holdings, such as ownership of a family business; these circumstances are carefully considered in the formulation of plans for a client’s investment of financial assets.

Once objectives are clarified, we work with each client to set up an investment strategy and process, and to put in place effective infrastructure, including performance reporting.

Wealth Strategist Partners does not make individual security purchases; rather, the Firm recommends investments with independent investment managers and/or independently managed investment products, including separately managed accounts, mutual funds, exchange traded funds and collective investment vehicles such as private fund limited partnerships. Wealth Strategist Partners' senior investment advisers have deep experience across multiple asset classes.

We do not provide tax, legal or accounting advice, but coordinate closely with our clients' administrative teams and third-party subject matter experts to anticipate problems and deliver solutions.

Wealth Strategist Partners is a non-discretionary adviser; we make specific recommendations to our clients, but do not have authority to make investment decisions for our clients. Wealth Strategist Partners does not have custody of our clients' assets. We work with custodian financial institutions chosen by our clients; we frequently lead searches for improved custody and reporting services for our clients. We believe that this division of responsibilities protects the security of our clients' assets.

In addition, Wealth Strategist Partners is engaged to provide wealth management strategy consulting, which is separate and distinct from our advisory services described above. Wealth Strategist Partners also provides wealth management education services in the U.S. and Europe to wealthy families, primarily in cooperation with the University of Chicago Booth School of Business. From time to time, Wealth Strategist Partners also offers custom wealth management education programs, typically to individual families. We do not consider these education services to be advisory in nature; rather, we believe that these services further Wealth Strategist Partners' mission of serving wealthy families. Finally, Wealth Strategist Partners is engaged to provide family business and family governance consulting, which is separate and distinct from our advisory services described above.

C. Explain whether (and, if so, how) you tailor your advisory services to the individual needs of clients. Explain whether clients may impose restrictions on investing in certain securities or types of securities.

As principals serving principals, we understand that investing resides within a holistic wealth management strategy and a broader family context that is informed by family values, tax, spending, investment experience, risk management and opportunity. Our clients often own operating businesses or hold concentrated positions that are legacies of family businesses or large real estate holdings. At Wealth Strategist Partners, each client relationship is uniquely structured, from investment portfolio and strategy to administration and communication process. We work with each client to establish a detailed investment policy, including determining investment goals and risk tolerance, establishing asset allocation parameters, establishing cash flow and liquidity requirements, and setting reasonable expectations for investment returns. Based on the risk and return objectives set forth in each client's investment policy, the Firm recommends investments to create a diversified portfolio that best fits with the client's goals and priorities and the opportunity set presented by changing market conditions.

To create customized, diversified investment portfolios, we identify and recommend independent investment managers and investment products in a range of asset classes. We monitor each of the recommended investments, including each investment's asset class and exposure and periodically

recommend rebalancing, tactically shifting focus and new investments as client circumstances change and/or market events dictate. Wealth Strategist Partners works with trustees, family offices, other professional staff and/or the client directly to design custom performance measurement systems which enable them to conduct performance reporting, portfolio evaluation and investment administration.

Wealth Strategist Partners does not participate in wrap fee programs.

As of December 31, 2019, Wealth Strategist Partners managed \$287,811,602 in regulatory assets under management, all managed on a non-discretionary basis.

Item 5 Fees and Compensation

- A. Describe how you are compensated for your advisory services. Provide your fee schedule. Disclose whether the fees are negotiable.**

Wealth Strategist Partners is paid a fee in consideration for the investment management advisory services we provide to our clients. Fees are negotiated as a fixed rate based on a percentage of a client’s assets under management and depend on each client’s specific circumstances. We determine each client’s fee in our sole discretion generally at the time a relationship is established. Fees are billed to clients quarterly in arrears. Clients pay a pro rata portion of the management fee for any quarter during which they either become a new client or the client relationship is terminated.

For consulting services, we are paid a fee based on time, risk, value-added and the nature of the advice required. For educational services, we are paid a fee per course-day delivered, plus costs incurred, depending on whether the course is a university-based open-enrollment course or a private course for a family.

- B. Describe whether you deduct fees from clients’ assets or bill clients for fees incurred. If clients may select either method, disclose this fact. Explain how often you bill clients or deduct your fees.**

Wealth Strategist Partners generally bills clients for services rendered or incurred, quarterly in arrears, or, depending on the nature of the services provided, partially at the outset and partially at the completion of a project.

- C. Describe any other types of fees or expenses clients may pay in connection with your advisory services, such as custodian fees or mutual fund expenses. Disclose that**

clients will incur brokerage and other transaction costs, and direct clients to the section(s) of your brochure that discuss brokerage.

Wealth Strategist Partners does not charge our clients related to routine out-of-pocket expenses or other usual expenses incurred by us in the performance of our services. If we anticipate incurring unusual or extraordinary expenses, we agree to discuss such expenses with the client and to provide an estimate of the same, in advance, for the purpose of obtaining such client's approval.

In addition, clients typically incur third-party investment management, brokerage, custodial, administration, reporting/performance measurement and other transaction fees in connection with the implementation of their investment management strategy. These additional fees are negotiated between the client and each third party engaged to perform such services. Wealth Strategist Partners has no discretion in the negotiation of these fees. However, those clients using Charles Schwab & Co. ("Schwab") as its custodian are able to avail themselves of previously negotiated pricing between Wealth Strategist Partners and Schwab. See also "Brokerage Practices" in Item 12 of this brochure. Additionally, Wealth Strategist Partners has negotiated reduced fees with several private fund investment managers, all of the benefits of which are passed through to the clients.

As mentioned above, clients generally pay fees quarterly in arrears, or, depending on the nature of the services provided, partially at the outset and partially at the completion of a project.

Neither Wealth Strategist Partners nor any of its supervised persons accepts compensation for the sale of securities or other investment products.

Wealth Strategist Partners does not accept any performance-based fees.

Item 7 Types of Clients

Wealth Strategist Partners' clients are ultra-high net worth individuals and families, including their family limited partnerships, family offices, investment committees and related trustees with a particular focus on taxable assets. For new investment management clients, we generally require a minimum account size of \$100 million in investible assets. We have accepted clients with less than \$100 million in our sole discretion.

Item 8 Methods of Analysis, Investment Strategies and Risk of Loss

A. Describe the methods of analysis and investment strategies you use in formulating investment advice or managing assets. Explain that investing in securities involves risk of loss that clients should be prepared to bear.

Wealth Strategist Partners works with individuals and families (and their affiliated investment structures) of significant wealth. We hand make each client relationship, portfolio investment and communication process. Wealth Strategist Partners' investment analysis focuses on research to develop investment themes and the identification and evaluation of investment managers and investment products we believe are likely to perform well as these themes mature. Our investment strategy and implementation recommendations are based on a nuanced understanding of each client's specific situation. We then advise that clients implement investments with the recommended managers/products within the framework of each client's investment policy and market conditions.

Our investment philosophy is based on fundamental investment analysis. Each of our senior investment professionals has more than 30 years of investment management and research experience, and uncommon experience with families. Our approach to identifying asset classes and investment managers in which to invest is research intensive and adjusted to the specific characteristics of each situation. We offer full open architecture for each client's portfolios. In evaluating asset classes, investment managers and investment products, we regularly review literature on the nature of the public and private securities markets, financial newspapers and other business publications, research materials prepared by others and manager reports. Wealth Strategist Partners' investment professionals attend investment fund meetings, meet one-on-one with and correspond with investment managers and seek out practitioners and subject matter experts around the world about investments, valuation, industry dynamics, economics, politics, demographics, technological innovation and related investment topics.

We believe that taxable investors require a different approach to risk and reward. We focus on meeting each client's specific objectives, measured as the return that actually accrues to a client net of all forms of friction. Taxable investors' long-term success requires a coordinated approach to investment. Investment value creation, as well as both tax and estate value creation, all impact our clients' multi-generational wealth objectives. Too often, friction costs overwhelm value added from public markets security selection. Thus, we recommend low cost, diversified, tax efficient portfolios as a central

component of clients' investment strategies. We believe that the potential for investment alpha is most likely found in less efficient markets and therefore focus our investment research in these areas.

While our clients' portfolios are customized to each client, most portfolios we recommend involve a combination of public equity managers, private equity fund managers, other investment managers and other financial service products. Wealth Strategist Partners believes that in efficient public equity markets, the probability of investment managers consistently adding value through active selection of stocks in broadly diversified portfolios is low, and any value added net of fees and taxes is likely to be at best modestly positive relative to passive strategies. In addition, publicly traded securities, both stocks and bonds, carry a variety of systemic and specific risks. Therefore, when selecting or recommending managers or investment products in efficient public markets, Wealth Strategist Partners usually prefers broadly diversified, low-cost investment portfolios that limit the specific risk of any particular company. We focus our research on identifying investment opportunities where the combination of inefficient markets, differentiated investment strategies and proficient investment managers create greater possibilities for outperformance net of fees and taxes; often, these recommendations are in private markets.

As appropriate to each client's objectives and risk tolerance, Wealth Strategist Partners recommends investments with selected private equity and related funds (including certain distressed debt, real estate and venture capital funds) which have considerable illiquidity risk and often hold concentrated portfolios. These types of funds may participate in less efficient markets with greater pricing anomalies, which may benefit or disadvantage either the buyer or the seller. Today, a great deal of expertise is applied to the marketing of new private equity funds, and the number of funds has grown considerably; these factors make it increasingly difficult to differentiate firms truly exceptional at investing from those that are superb marketers.

The independent investment managers or investment products recommended inherently have their own risk factors. While Wealth Strategist Partners performs detailed due diligence and monitors the managers and/or investment products that it recommends, there is no assurance that our analysis of investment themes or investment managers will be correct, or that our clients' investments with such managers or products will be free of fraud, abuse or other anticipated or unanticipated risks. Furthermore, Wealth Strategist Partners provides its investment advice on a non-discretionary basis and with the expectation that our recommendations for manager selection and shifts in asset allocation will be acted upon by that client's financial administrator in a timely manner. If this is not the case, our accountability for performance and our effectiveness will be reduced. It is also possible that a client or the client's independent advisers will selectively implement Wealth Strategist Partners' recommendations in such a way that the performance experienced by the client may diverge from the performance the client would have experienced had all of our recommendations been acted upon in the same manner as recommended.

Before recommending any manager or investment product to our clients, we conduct extensive due diligence. The due diligence process includes direct research such as examining underlying governing documents and offering materials, the investment team's experience, sophistication and depth, and the firm's operational processes and infrastructure, as well as indirect methods of analysis, such as reference checks and public filings. Further, there is often an additional level of diligence performed by the custodians who hold assets for a client. Most, if not all, custodians perform their own independent review of a client's third-party managers prior to allowing such managers on the custodian's platform, if applicable.

Wealth Strategist Partners is extremely selective when recommending hedge funds due to the lack of transparency, the prevalence of high fees, a tendency toward tax-inefficient trading strategies, and risks that are not generally apparent, including cross-collateralization of liabilities. Wealth Strategist Partners recommends investments in market capitalization, industry- or geography-specific funds to gain exposure in markets that we believe are particularly attractive, or with managers we believe have valuable skills and other resources that are difficult to replicate.

Despite this extensive due diligence, it is impossible to be aware of all of the risks of investing in any particular manager or investment product. Clients should be prepared to bear a loss of their investment.

B. For each significant investment strategy or method of analysis you use, explain the material risks involved. If the method of analysis or strategy involves significant or unusual risks, discuss these risks in detail. If your primary strategy involves frequent trading of securities, explain how frequent trading can affect investment performance, particularly through increased brokerage and other transaction costs and taxes.

There are many market-related and other factors, some of which cannot be anticipated, that could result in a client losing a portion or all of its investment or prevent an account from generating profits. The data that we review is generally considered reliable but cannot be guaranteed, nor have we verified its accuracy. In addition, the data that we review is sometimes subjective in nature and open to interpretation. Even if the data and our interpretation of the data is correct, there may be other factors that determine the value of a portfolio other than those considered in fundamental analysis.

Principal Investment Risk

No investment is free of risk. Current and prospective clients are cautioned that investments in securities involve risk of loss, including the possibility of a complete loss of the amount invested, and that they should be prepared to bear these risks. Based on the types of investments that we recommend, all clients should be aware of certain risk factors, which include, but are not limited to, the following:

Investing in Securities Involves Risk of Loss that Clients Should Be Prepared to Bear. A client may lose money (both principal and any earnings) or fail to make money on an investment. We cannot guarantee that we will achieve a client's investment objectives.

Fixed Income Risk. The issuer of a fixed income security may not be able to make interest and principal payments when due. Generally, the lower the credit rating of a security, the greater the risk that the issuer will default on its obligation. If a rating agency gives a debt security a lower rating, the value of the debt security will decline because investors will demand a higher rate of return. As nominal interest rates rise, the value of fixed income securities is likely to decrease. A nominal interest rate is the sum of a real interest rate and an expected inflation rate.

Alternative Investments Risk. We recommend to clients the use of alternative investments, such as investments in real estate funds, private equity funds or venture capital funds. The underlying investment funds may utilize highly speculative investment techniques, including leverage, highly

concentrated portfolios, senior securities positions, control positions and illiquid investments. The underlying investment funds may also utilize derivative instruments to attempt to hedge the risks associated with certain of their investments. Such derivative transactions have the potential to expose the assets of such investment funds to the risks of material financial loss, which may in turn adversely affect the financial results of the client. While recommended investments in alternative asset managers have benefits for our clients, the performance of alternative asset managers can be more volatile than managers of publicly traded securities, both on an absolute basis and relative to market benchmarks. In addition, alternative managers are generally less regulated. Therefore, there is considerably greater risk of loss and analytical error when investing in alternative asset managers. In addition, some alternative investments are illiquid, which typically makes it difficult or impossible to determine the price or timing to exit from an investment or manager.

Clients who invest in such investment funds will pay Wealth Strategist Partners' advisory fees and those of the underlying investment managers, and certain other fees and expenses of underlying investment funds in which the client invests. Investors in such investment funds typically also pay carried interest, performance or incentive allocations to an underlying manager or sponsor of an underlying investment fund in which they invest. Clients receive information regarding the fees, expenses and risks of an alternative manager directly from such manager when determining whether or not to invest with the manager.

No Right to Control Third Parties Investment Products. We have no opportunity to control the day-to-day operations of the investment managers and investment products we recommend for our clients. Most investment managers have the authority to change the level of risk in their products after clients invest; even if such a change becomes apparent and is troubling to us, it may not be possible or practical for the client to sell such investments.

Highly Volatile Markets. The prices of financial instruments in which a client may invest can be highly volatile. Price movements of forward and other derivative contracts in which a client may be invested are influenced by, among other things: interest rates; changing supply and demand relationships; trade, fiscal, monetary and exchange control programs and policies of governments; and national and international political and economic events and policies. Each client account is subject to the risk of failure of any of the exchanges on which their respective positions trade or of their clearinghouses.

Exchange Traded Funds. A client may invest in exchange-traded funds ("ETFs"), which are shares of publicly traded unit investment trusts, open-end funds or depository receipts that seek to track the performance and dividend yield of specific indices or companies in related industries. These indices may be either broad-based, sector or international. However, ETF shareholders are generally subject to the same risk as holders of the underlying securities they are designed to track. ETFs are also subject to certain additional risks, including, without limitation, the risk that their prices may not correlate perfectly with changes in the prices of the underlying securities they are designed to track and the risk of trading in an ETF halting due to market conditions or other reasons based on the policies of the exchange upon which the ETF trades. In addition, a client may bear, along with other shareholders of an ETF, its pro rata portion of the ETF's expenses, including management fees.

Cybersecurity Risk and Identity Theft. Wealth Strategist Partners, its clients and service providers and other market participants increasingly depend on complex information technology and communications systems to conduct business functions. These systems are subject to a number of different threats or risks that could adversely affect the Firm and its clients, despite the efforts of service providers to

adopt technologies, processes and practices intended to mitigate these risks and protect the security of their computer systems, software, networks and other technology assets, as well as the confidentiality, integrity and availability of information belonging to the Firm and its clients. For example, unauthorized third parties may attempt to improperly access, modify, disrupt the operations of, or prevent access to the systems of the Firm, its clients, their service providers or data within these systems. Third parties may also attempt to fraudulently induce employees, customers, third-party service providers or other users of such systems to disclose sensitive information to gain access to confidential data. In addition, these systems may be subject to damage or interruption from computer viruses, network failures, computer and telecommunication failures, infiltration by unauthorized persons and security breaches, usage errors by their respective professionals, power outages and catastrophic events such as fires, tornadoes, floods, hurricanes and earthquakes

Although Wealth Strategist Partners has implemented various measures to manage risks relating to these types of events, if these systems are compromised, become inoperable for extended periods of time or cease to function properly, Wealth Strategist Partners and/or a service provider thereof would have to make a significant investment to fix or replace system components. A successful penetration or circumvention of the security of such systems could result in the loss or theft of data or assets, the inability to access electronic systems, loss or theft of proprietary information or corporate data, physical damage to a computer or network system or costs associated with system repairs. Such incidents could cause Wealth Strategist Partners to incur regulatory penalties, reputational damage, additional compliance costs or financial loss.

Economic Disruptions Due to Coronavirus. The recent spread of COVID-19 (the “coronavirus”) in certain countries, including the United States, has shown an ability to result in a broad-based economic decline and significant market volatility. This is a new and developing threat and therefore presents material uncertainty and risk with respect to our clients’ performance and financial results. The global impact of the outbreak has been rapidly evolving, and while the nature of the economic impact is expected to be most directly felt in countries experiencing more significant rates of infection, the nature of the global economy and supply chains means that even countries that remain at relatively low levels of infection are likely to experience market volatility and general economic declines. Because of the unpredictability of the virus’ spread, as well as potential development and distribution of a vaccine to materially alter such spread, it is unclear as to how long such conditions are likely to exist or what the ultimate extent of such damage will be; however, in both cases, the total impact is expected to be magnified the longer or more widespread the pandemic becomes.

Aside from the broad effects on the economy, the coronavirus may also have specific implications for the Firm’s operations and activities of its personnel, which can range from employees needing to work from home to more significant impacts such as illness and restrictions on non-essential travel. The Firm expects to institute procedures, as it deems appropriate, to deal with operational impacts from the coronavirus. Many of these procedures are expected to mirror procedures currently contained in the Firm’s Business Continuity Plan for dealing with other significant business disruption events.

Further, no additional fees are charged surrounding these investments and any investment recommendations made will be within each client's agreed-upon investment criteria.

For some clients, and solely upon such client's request, we recommend or manage a search for custodians. However, we have no financial interest and receive no benefit from the custodian and no additional compensation from a client for these recommendations.

From time to time, Wealth Strategist Partners receives training, information, promotional material, meals, gifts, entertainment, prize drawings or other perquisites from vendors and others with whom we do business or to whom we make referrals. However, at no time will we accept any benefits, gifts, entertainment or other arrangements that are conditioned on directing individual client transactions to a specific security, product or provider.

Code of Ethics

As fiduciaries, Wealth Strategist Partners and its supervised persons have certain legal obligations to put clients' interests ahead of their own. Wealth Strategist Partners has adopted a written code of ethics pursuant to Rule 204A-1 of the Advisers Act based on principles of openness, honesty, integrity and trust that sets forth the standards of conduct expected of supervised persons. The code of ethics includes a prohibition on insider trading and outlines strict policies that dictate how any material nonpublic information is treated. The code of ethics addresses personal trading and reporting of personal securities transactions, gifts and entertainment and outside business activities, among other topics. Upon hire and at least once a year, each Wealth Strategist Partners supervised person is required to acknowledge the code of ethics and agree to be bound by it.

Supervised persons of Wealth Strategist Partners who violate the code of ethics will be subject to remedial actions, including, but not limited to, censure, suspension or termination. Supervised persons are also required to promptly report any violations of the code of ethics of which they become aware.

Participation or Interest in Client Transactions

Wealth Strategist Partners' principals invest in investment products or with investment managers that we also recommend to our clients. In addition, some of our principals are direct or indirect beneficiaries of family entities for which Wealth Strategist Partners is the investment adviser. We often recommend the same investments to family entities as we recommend to other clients. We do not believe that these investment practices create a conflict of interest but rather reflect an alignment of interest between us and our clients.

Because we do not trade securities on behalf of our clients, we do not engage in principal or agency cross transactions on behalf of our clients.

Conflicts of Interest

Certain inherent conflicts of interest may arise from the fact that we will carry on substantial investment activities for multiple clients simultaneously. We may recommend investment transactions for certain clients whose investments differ from investments recommended for other clients, even though their investment objectives may be the same or similar. This can occur due to different timing of client account opening or funding/withdrawals, as well as differences in client account sizes, investment objectives and guidelines and various other differences among our clients and their respective accounts. We believe that the potential conflicts among client accounts are mitigated by the nature of our investment program, as described above, which generally focuses on personalized client investment objectives and recommending a relatively small number of investment managers and investment products.

As mentioned throughout this brochure, principals and supervised persons of Wealth Strategist Partners invest (either in their individual accounts or through accounts they control) in many of the

same investment managers and investment products that we recommend to our clients. Wealth Strategist Partners has negotiated reduced fees with several private fund investment managers, all of the benefits of which are passed through to the clients. Additionally, Wealth Strategist Partners' principals serve on the limited partner advisory committees of some of the private funds which we recommend to our clients (and in which such principals also personally invest). We do not believe serving on limited partner advisory committees creates a conflict of interest in that these are not paid positions and only serve further to align our interests with our clients. In addition, Stuart Lucas also serves on the boards of various client investment vehicles. Further, we, along with some of our clients, have a small investment in the general partner entity of one investment manager in which we have recommended that our clients invest. Finally, Stuart, Melissa and Susan Lucas serve as trustees or members of the general partner on some of the Lucas family investment entities.

If any matter arises that Wealth Strategist Partners determines in its good faith constitutes an actual conflict of interest, we will take such actions as are necessary or appropriate to address the conflict.

Personal Trading

Our personal trading policies contained within the code of ethics are designed to ensure that no client is disadvantaged by the transactions executed by a supervised person in his or her personal account and that supervised persons in no respect misappropriate any benefits belonging to a client. In rare cases, Wealth Strategist Partners' business may provide Wealth Strategist Partners and its supervised persons with access to material nonpublic ("insider") information. Our supervised persons are prohibited from trading, either personally or on behalf of others, in securities while in possession of material nonpublic information or communicating material nonpublic information to others. The code of ethics establishes guidelines for personal trading requirements, insider trading and reporting of personal securities transactions, including certain pre-clearance and reporting obligations.

In its role as an investment adviser to its clients, Wealth Strategist Partners and its principals and supervised persons make investment recommendations to their clients. As mentioned above, Wealth Strategist Partners' principals and supervised persons trade and invest for their own accounts (either in their individual accounts or through accounts they control) in the same securities as those in which they invest on behalf of their clients. Also as noted above, we believe that investing in this way furthers the alignment of interests we have with our clients, rather than creating any conflict. Our code of ethics has procedures designated to ensure that supervised persons do not enter into transactions in their personal accounts which could materially disadvantage our clients. We maintain a restricted list of issuers about which we have or may have material nonpublic information. Pre-clearance is required by supervised persons for certain personal securities transactions, including trading in restricted list securities, initial public offerings and certain limited offerings. In addition, our code of ethics requires supervised persons to submit monthly or quarterly brokerage account statements, as applicable, for review. The Chief Compliance Officer reviews these account statements on a quarterly basis in order to identify any insider trading or conflicts of interest.

We do not receive any consideration in exchange for this recommendation; rather, Wealth Strategist Partners believes, after due diligence, that Schwab offers a combination of services that are best suited for our clients, taking into account Wealth Strategist Partners' non-discretionary relationships with its clients and the types of assets in which our clients typically invest. We do not engage in soft dollar benefits.

Reports are written and are delivered either electronically or via hard copy, as per each client's stated preference.
