## **Item 3 Disciplinary Information**

On September 22, 2017, Marshall Eichenauer, Jr. and Sagent Wealth Management agreed to settle a matter in which the SEC alleged that they violated the Advisers Act, by failing to disclose Mr. Eichenauer's conflict of interest or obtain investor's consent, prior to causing the Sagent Private Investment Fund to make loans to Sagent Wealth Management.

As described in the settlement, Eichenauer and Sagent do not admit to these allegations, nor do they deny them.

#### **Item 4      Other Business Activities**

Mr. Eichenauer holds a Real Estate Brokers License with the California Bureau of Real Estate and Life-Only and Accident and Health licenses with the California Department of Insurance.

#### **Item 5      Additional Compensation**

It is anticipated that Mr. Eichenauer's primary compensation will come from the Investment Advisory services he performs for Sagent Wealth Management and that the overwhelming majority of his time will be spent on these activities. However, Mr. Eichenauer may also devote a portion of his time to and receive compensation from his activities as an California Life Insurance Agent and a California Real Estate Broker.

In some cases, clients of Sagent Wealth Management may wish to retain Mr. Eichenauer to assist them with the purchase of Life Insurance and or to act as a broker in a real estate transaction, although they have no obligation to do so. In these cases, Mr. Eichenauer may receive compensation for these services in addition to the compensation that he receives from providing Investment Advisory services for Sagent Wealth Management. Before receiving compensation for Insurance or Real Estate services, clients of Sagent Wealth Management will be notified in writing and will be asked to acknowledge such notification in writing.

#### **Item 6      Supervision**

As the Owner and Managing Partner of Sagent Wealth Management, is responsible for his own supervision.
