This activity requires 80 hours per month. These products are not offered to Capital Synergy Partners clients.

Snider Management Inc.

Mr. Snider receives rental income from properties owned in Madison & Sun Prairie, WI.

Optomis

Mr. Snider receives brokerage commissions on group and individual health insurance, dental insurance, and fixed life insurance products sold under Optomis. Mr. Snider also receives referral fees for payroll services offered to business clients through Optomis.

As a representative of Capital Synergy Partners and an independent life and health insurance agent, Capital Synergy Partners will notify the client that:
