FSC is a diversified financial services company registered with the Financial Industry Regulatory Authority ("FINRA") as a broker-dealer engaged in the offer and sale of securities products. I may recommend the purchase of securities offered by FSC. If you purchase these products from me, I will receive normal commissions and may receive other indirect forms of compensation which may be in addition to customary advisory fees. As such, I will have an incentive to sell you commissionable products in addition to providing you with advisory services when such commissionable products may not be in your best interest.

While my security sales are reviewed for suitability by an appointed supervisor, you should be aware of the incentives I have to sell certain securities products and are encouraged to ask me about any conflict presented.

I am also a licensed insurance agent and may recommend that you purchase insurance from me. I established PPG Pension Administrators, LLC., a Third-Party Retirement Plan Administrator (TPA), On April 4, 2014. I own 60% of PPG Pension Administrators, LLC and Aminah Williams who is a Plan Administrator, owns the remaining 40%. Ms. Aminah Williams is actively involved in the day to day operation of the firm.

I have also purchased a commercial real estate property in the State of Virginia with a friend/client in 2005. The client resides in the State of Virginia. This transaction was completed through an equal ownership LLC named Fairway of Virginia. This property was sold in May 2012 and the Fairway of Virginia, LLC was dissolved and ceased operation.

In an effort to ensure that my outside business activities do not interfere with or otherwise compromise my relationship with you, all outside business activities that I engage in are reviewed and approved by an appointed supervisor.
