## **Item 3. Disciplinary Information**

While serving as head trader of Oppenheimer's equity trading desk, Mr. Zucker was responsible for trading securities on the New York Stock Exchange ("NYSE") for the firm's account. On April 8<sup>th</sup> and 9<sup>th</sup> of 1998, Mr. Zucker authorized the purchase of some securities for the firm account. Shortly thereafter, he authorized their sale in order to mitigate potential losses for the firm. These trades were all sanctioned by the firm's compliance officers. Without admitting or denying any allegations, Mr. Zucker consented to findings by the NYSE hearing panel that he violated exchange rules by not adhering to just and equitable principles of trade insofar as his actions had the effect of creating an appearance of active trading in those securities. On June 17, 2003, the NYSE hearing panel imposed a censure and a fine of \$45,000. (Exchange Hearing Panel Decision 03-119).
