ITEM 2 - EDUCATIONAL BACKGROUND AND BUSINESS EXPERIENCE

Education: Mr. Howe received his undergraduate degree from Tufts University and a graduate degree from Columbia University (with a specialization in international business).

Business Background: Prior to founding Old Hill in 1996, Mr. Howe was a Managing Director at Nomura Securities in New York from 1990 to 1995 where he oversaw the \$40 billion Government Business Unit, which included U.S. Treasury and Agency trading, Repo and Money Markets as well as the Canadian Fixed Income operations. Prior to joining Nomura, Mr. Howe was a Senior Vice President at Kidder Peabody, where he managed and traded fixed income securities for seven years.

ITEM 3 – DISCIPLINARY INFORMATION

Haas, COO and Portfolio Manager, Peter Faigl, Senior Portfolio Manager, and Richard Martorella as Chief Financial Officer and Chief Compliance Officer. Mr. Howe as Chief Investment Officer of Old Hill, has overall responsibility for the investments of the private funds managed by Old Hill. Richard Martorella is responsible for periodically reviewing OHP's investment activities for compliance with the investment strategies and investment guidelines set forth in offering documents provided to investors in the private funds managed by Old Hill. Clients or prospective clients may contact Richard Martorella, at (203) 656-3004, regarding the supervision of Mr. Howe.

Mr. Martorella attends weekly portfolio meetings where existing positions and potential deals are discussed and thus, Mr. Martorella is aware of any new transactions Mr. Howe is considering. Mr. Martorella reviews portfolio attribution on a monthly basis and confirms that all portfolio managers, including Mr. Howe, sign off on their portfolio valuations.
