## **ITEM 3 DISCIPLINARY INFORMATION**

Ms. Hernandez was suspended by FINRA on September 15, 2020 for failure to honor an arbitration award obtained by her former employer for amounts owed to the employer on a promissory note in the amount of \$159,363.92 plus interest. The suspension was lifted on February 1, 2021 when Ms. Hernandez filed a petition for Chapter 7 bankruptcy protection. The petition is pending.

## **ITEM 4 OTHER BUSINESS ACITIVITIES**

Ms. Hernandez holds a series 7 and 66 securities licenses but is not currently associated with any broker-dealer or investment adviser other than Entrefolio Wealth Management.

Ms. Hernandez is not engaged in any additional outside business activities requiring a substantial amount of her time.

Ms. Hernandez does not receive any economic benefits from any non-client for providing advisory services.
