MATERIAL CHANGES (Item 2)

On July 28, 2010, the United States Securities and Exchange Commission published "Amendments to Form ADV" which amends the disclosure document that the Firm provides to clients as required by applicable rules and regulations. This ADV-Part 2 Disclosure Brochure is an updated document prepared according to the new requirements and rules. This section of the brochure will discuss only specific material changes that are made to the Disclosure Brochure and provide readers with a summary of such changes.

In the past our firm has offered or delivered information about our qualifications and business practices to clients on at least an annual basis. Pursuant to new rules, we will ensure that you receive a summary of any material changes to this and subsequent Disclosure Brochures within 120 days after our fiscal year ends. Our fiscal year ends on December 31 so you will receive the summary of material changes no later than April 30 each year. At that time, we will also offer or provide a copy of the most current Disclosure Brochure. We may also provide other ongoing disclosure information about material changes as necessary.

The material changes in this brochure from the last annual updating amendment of Stavis & Cohen Private Wealth on December 30, 2021 are described below. Material changes relate to the Firm's advisory business/operations, policies, practices, affiliations and/or conflicts of interests only.

Advisory Business (Item 4)

We have revised our disclosures to reflect a new ownership structure. On 12/31/2021, Stavis & Cohen Private Wealth LLC became a wholly owned subsidiary of CI Private Wealth US, LLC (CI Private Wealth), an indirect majority-owned subsidiary of CI Financial Corp (CI or CI Financial) (TSX: CIX; NYSE: CIXX). CI Financial is an independent public company based in Canada offering global wealth management and asset management advisory services. None of CI Financial or CI Private Wealth has a role in the day-to-day management of Stavis & Cohen Private Wealth LLC. See additional disclosures in Item 10.

Other Financial Industry Activities and Affiliations (Item 10)

We have revised our disclosure to reflect financial industry affiliations as a result of our new ownership structure and affiliation with CI Financial and CI Private Wealth. CI Financial, through CI Private Wealth or other indirect subsidiaries, also owns other registered investment advisers, tax preparation service companies, and financial services-related companies located in the U.S. and Canada (CI Affiliates). Some CI Affiliates manage or advise private funds, investment companies or other investment vehicles as disclosed in their respective Form ADVs.

Stavis & Cohen Private Wealth LLC operates independently of other CI Affiliates. Certain individuals of Stavis & Cohen Private Wealth LLC sit on an informal advisory board of CI Private Wealth which was created to inform executive management about business initiatives of the CI Private Wealth business. This advisory board is comprised of business leaders from various of the registered investment advisers owned by CI Private Wealth and does not have the power to control the management of Stavis & Cohen Private Wealth LLC. Stavis & Cohen Private Wealth LLC does not have any referral arrangements or other reciprocal arrangements with other CI Affiliates.

ADVISORY BUSINESS (Item 4)

The principals of Stavis & Cohen Private Wealth have operated an investment advisor and wealth management business since its registration with the United States Securities and Exchange Commission ("SEC") in September 2009.

On 12/31/2021, Stavis & Cohen Private Wealth LLC became a wholly owned subsidiary of CI Private Wealth US, LLC (CI Private Wealth), an indirect majority-owned subsidiary of CI Financial Corp (CI or CI Financial) (TSX: CIX; NYSE: CIXX). CI Financial is an independent public company based in Canada offering global wealth management and asset management advisory services. None of CI Financial or CI Private Wealth has a role in the day-to-day management of Stavis & Cohen Private Wealth LLC. See additional disclosures in Item 10.

As a financial planning pioneer with more than twenty-five years of experience in the industry, Deborah Stavis is among early Certified Financial Planners®. Since 1984, she has demonstrated a commitment to financial literacy by teaching retirement, investment, and estate planning courses at the Rice University Susanne M. Glasscock School of Continuing Studies. In 1996, she founded and operated a nationally recognized, Houston-based financial planning and investment firm.

In 2009, Deborah decided to revolutionize the delivery of financial advisory services by launching a new firm. In searching for the right partner to bring this innovative solution to families, Deborah sought former colleague, Eddie Cohen, with whom she pioneered fee-based financial planning in Houston for a Fortune 500 company in 1982. Eddie ultimately chose to specialize in investments and went on to help run a broker-dealer for a major insurance company. He was then recruited to the Philadelphia area where he served many roles in a privately-owned investment boutique that grew from \$2 billion to \$10 billion in assets under management during his nine-year tenure. He left with the goal of interfacing regularly and more directly with clients and to own and operate his own firm.

Upon sharing their passion to provide a wider menu of services than either had ever been able to provide before and a need to deepen their commitment to client services, the decision to reunite was easy. After sixty years of collective experience, Deborah and Eddie share the belief that a privately-owned and operated financial services boutique is the best environment in which to serve their clients.

GENERAL DESCRIPTION OF PRIMARY ADVISORY SERVICES

The following are brief descriptions of our primary advisory services. A more detailed description of our services is provided in the Fees and Compensation section, so that you can review the description of services and description of fees in a side-by-side manner. Any client who has not received a copy of the Stavis & Cohen Private Wealth's written Disclosure Brochure at least forty-eight (48) hours prior to executing an agreement for advisory services will have five (5) business days subsequent to executing the agreement to terminate the Firm's advisory services without penalty.

Financial Planning Services - Stavis & Cohen Private Wealth provides advisory services in the form of financial planning services. Financial planning services do not involve the active management of client accounts, but instead focuses on a client's overall financial situation. Financial planning can be described as helping individuals determine and

set their long-term financial goals through investments, income and estate tax planning, asset allocation, risk management, retirement planning, and other areas. The role of a financial planner is to find ways to help the client understand his/her overall financial situation and help the client set financial objectives.

Asset Management Services - Stavis & Cohen Private Wealth provides advisory services in the form of asset management services which may be referred to as investment management services. Asset management services involve providing clients with on-going supervision over client accounts. This means that Stavis & Cohen Private Wealth will regularly monitor a client's account and make trades in client accounts. Additionally, Stavis & Cohen Private Wealth provides investment management services to the participants of 401k plans. These assets are held by the named custodian of the plan sponsor who is the participant's employer in most cases.

Outside Money Managers - Stavis & Cohen Private Wealth provides advisory services by referring clients to outside, or unaffiliated, money managers that are registered or exempt from registration as investment advisors. Third-party money managers are responsible for regularly monitoring client accounts and making trades in client accounts.

Tax Preparation Services – Stavis and Cohen Private Wealth offers certain tax preparation services for individuals, business entities, investment partnerships, trusts, estates, and private foundations. Clients may utilize our tax professionals for preparation services but are not required to do so.

LIMITS ADVICE TO CERTAIN TYPES OF INVESTMENTS

Stavis & Cohen Private Wealth provides investment advice on the following types of investments:

- No-Load Mutual Fund Shares (no sales charge)
- Load-Waived Mutual Fund Shares (sales charge waived)
- Exchange-listed securities (e.g. stocks)
- Securities traded over-the-counter (e.g. stocks)
- Fixed income securities (e.g. bonds)
- Closed-End Funds and Exchange Traded Funds (ETFs)
- Corporate debt securities (other than commercial paper)
- Certificates of deposit
- Municipal securities
- Variable life insurance
- Variable annuities
- United States government securities
- Interests in partnerships or Investment Trusts (e.g. real estate, oil & gas, private equity, hedge funds, managed futures, etc)

Clients that are “accredited investors” as defined under Rule 501 of the Securities Act of 1933, as amended, may invest in certain private placement securities, which may include debt, equity, and/or pooled investment vehicles when consistent with the client’s investment objectives. When Stavis & Cohen Private Wealth recommends that the client invest in private placement securities, Stavis & Cohen Private Wealth receives no additional compensation but will continue to receive applicable investment advisory fees on the client’s assets under management. Stavis & Cohen Private Wealth does not provide advice on foreign issues, warrants, commercial paper, options contracts on securities or commodities, or futures contracts on tangibles or intangibles.

When providing asset management services, we typically construct each client’s account holdings using mutual funds, ETFs, and/or equities to build diversified portfolios. It is not our typical investment strategy to attempt to time the market but we may increase cash holdings modestly as deemed appropriate, based on your risk tolerance and our expectations of market behavior. We may modify our investment strategy to accommodate special situations such as low basis stock, stock options, legacy holdings, inheritances, closely held businesses, collectibles, or special tax situations. (Please refer to the section referring to the Methods of Analysis, Investment Strategies and Risk of Loss for more information.)

Stavis & Cohen Private Wealth utilizes the FSC Wealth Management Platform (WMP) – Advisor Managed Portfolio Program (AMP) which allows Stavis & Cohen to provide comprehensive investment management of your assets through the application of asset allocation as well as the provision of execution, clearing and custodial services through Pershing LLC (“Pershing”). For further AMP details, please see the Advisor Managed Portfolios Wrap Fee Program Brochure. We provide this brochure to you prior to or congruent with your enrollment in the AMP. Please read it thoroughly before investing.

Retirement Plan Rollover Recommendations - When Stavis & Cohen Private Wealth provides investment advice about your retirement plan account or individual retirement account (“IRA”) including whether to maintain investments and/or proceeds in the retirement plan account, roll over such investment/proceeds from the retirement plan account to a IRA or make a distribution from the retirement plan account, we acknowledge that Stavis & Cohen Private Wealth is a “fiduciary” within the meaning of Title I of the Employee Retirement Income Security Act (“ERISA”) and/or the Internal Revenue Code (“IRC”) as applicable, which are laws governing retirement accounts. The way Stavis & Cohen Private Wealth makes money creates conflicts with your interests, so Stavis & Cohen Private Wealth operates under a special rule that requires Stavis & Cohen Private Wealth to act in your best interest and not put our interest ahead of you.

Under this special rule’s provisions, Stavis & Cohen Private Wealth must, as a fiduciary to a retirement plan account or IRA under ERISA/IRC:

- Meet a professional standard of care when making investment recommendations (e.g., give prudent advice);
- Never put the financial interests of Stavis & Cohen Private Wealth ahead of you when making recommendations (e.g., give loyal advice);
- Avoid misleading statements about conflicts of interest, fees, and investments;
- Follow policies and procedures designed to ensure that Stavis & Cohen Private Wealth gives advice that

is in your best interest;

- Charge no more than is reasonable for the services of Stavis & Cohen Private Wealth; and
- Give the client basic information about conflicts of interest.

To the extent we recommend you rollover your account from a current retirement plan account to an individual retirement account managed by Stavis & Cohen Private Wealth, please know that Stavis & Cohen Private Wealth and our investment adviser representatives have a conflict of interest.

We can earn increased investment advisory fees by recommending that you roll over your account at the retirement plan to an IRA managed by Stavis & Cohen Private Wealth. We will earn fewer investment advisory fees if you do not roll over the funds in the retirement plan to an IRA managed by Stavis & Cohen Private Wealth.

Thus, our investment adviser representatives have an economic incentive to recommend a rollover of funds from a retirement plan to an IRA which is a conflict of interest because our recommendation that you open an IRA account to be managed by our firm can be based on our economic incentive and not based exclusively on whether or not moving the IRA to our management program is in your overall best interest.

We have taken steps to manage this conflict of interest. We have adopted an impartial conduct standard whereby our investment adviser representatives will

- (i) provide investment advice to a retirement plan participant regarding a rollover of funds from the retirement plan in accordance with the fiduciary status described below,
- (ii) not recommend investments which result in Stavis & Cohen Private Wealth receiving unreasonable compensation related to the rollover of funds from the retirement plan to an IRA, and
- (iii) fully disclose compensation received by Stavis & Cohen Private Wealth and our supervised persons and any material conflicts of interest related to recommending the rollover of funds from the retirement plan to an IRA and refrain from making any materially misleading statements regarding such rollover.

When providing advice to you regarding a retirement plan account or IRA, our investment advisor representatives will act with the care, skill, prudence, and diligence under the circumstances then prevailing that a prudent person acting in a like capacity and familiar with such matters would use in the conduct of an enterprise of a like character and with like aims, based on the investment objectives, risk, tolerance, financial circumstances, and a client's needs, without regard to the financial or other interests of Stavis & Cohen Private Wealth or our affiliated personnel.

TAILOR ADVISORY SERVICES TO INDIVIDUAL NEEDS OF CLIENTS

Stavis & Cohen Private Wealth's services are always provided based on the individual needs of each client. This means, for example, that you are given the ability to impose restrictions on the accounts we manage for you, including specific investment selections and sectors. We work with each client on a one-on-one basis through interviews and questionnaires to determine the client's investment objectives and suitability information.

CLIENT ASSETS MANAGED BY STAVIS & COHEN PRIVATE WEALTH

The amount of client assets advised by Stavis & Cohen Private Wealth totaled \$753,825,767 as of December 31, 2021; \$679,872,913 of these assets are managed on a discretionary basis and \$73,952,854 are advised on a non-discretionary basis.

FEES AND COMPENSATION (Item 5)

In addition to the general information provided in the Advisory Business section, this section provides additional details regarding our firm's services along with descriptions of each service's fees and compensation arrangements.

FINANCIAL PLANNING SERVICES

Stavis & Cohen Private Wealth provides its clients with a broad range of financial planning services, which includes non-investment related matters. Stavis & Cohen Private Wealth charges a fixed fee for these services. Stavis & Cohen Private Wealth's financial planning fees are negotiable, but generally range from \$5,000 to \$50,000 on a fixed fee basis, depending upon the level and scope of the services and the professional rendering the financial planning services. In certain circumstances there may arise a service that necessitates an hourly rate. In such case the rate would be charged at \$250 per hour.

Prior to engaging Stavis & Cohen Private Wealth to provide financial planning services, you will generally be required to enter into a written agreement with Stavis & Cohen Private Wealth setting forth the terms and conditions of the engagement and describing the scope of the services to be provided and the portion of the fee that is due from you prior to Stavis & Cohen Private Wealth commencing services. Stavis & Cohen Private Wealth generally requires the financial planning fee to be paid upon entering the written agreement. Either party may terminate the agreement per the terms of the contract. In the event you terminate Stavis & Cohen Private Wealth's financial planning services, the balance of Stavis & Cohen Private Wealth's unearned fees (if any) will be refunded to you. If termination occurs within five business days of entering into an agreement for such services, you are entitled to a full refund.

In performing its services, Stavis & Cohen Private Wealth will not be required to verify any information received from the client or from the client's other professionals (e.g., attorney, accountant, etc.) and is expressly authorized to rely on such information. Stavis & Cohen Private Wealth may recommend the services of itself, its Advisory Affiliates in their individual capacities as registered representatives of a broker-dealer, and/or other professionals to implement its recommendations. You are advised that a conflict of interest exists if Stavis & Cohen Private Wealth recommends its own services. You are under no obligation to act upon any of the recommendations made by Stavis & Cohen Private Wealth under a financial planning engagement and/or engage the services of any such recommended professional, including Stavis & Cohen Private Wealth itself. You retain absolute discretion over all such implementation decisions and are free to accept or reject any of Stavis & Cohen Private Wealth's recommendations. Moreover, you are advised that it remains your responsibility to promptly notify the Firm if there is ever any change in your financial situation or investment objectives.

for the purpose of reviewing, evaluating, or revising the Firm's previous recommendations and/or services.

INVESTMENT MANAGEMENT SERVICES

In the event you determine to engage Stavis & Cohen Private Wealth to provide investment management services, Stavis & Cohen Private Wealth will provide its investment management services on a fee basis. If engaged, Stavis & Cohen Private Wealth charges an annual fee based upon a percentage of the market value of the assets being managed by Stavis & Cohen Private Wealth. Stavis & Cohen Private Wealth's annual fee is exclusive of, and in addition to brokerage commissions, transaction fees, and other related costs and expenses incurred by the client. However, Stavis & Cohen Private Wealth will not receive any portion of these commissions, fees, and costs. Stavis & Cohen Private Wealth's annual fee is charged quarterly, in advance, based upon the market value of the assets on the last day of the previous quarter. The annual fee varies depending upon the market value of the assets under management and the type of investment management services to be rendered, as follows:

For the initial quarter of investment management services, the first quarter's fees will be calculated on a pro rata basis. The Agreement between Stavis & Cohen Private Wealth and the client will continue in effect until terminated by either party pursuant to the terms of the Agreement. Stavis & Cohen Private Wealth's annual fee will be prorated through the date of termination and any remaining balance will be charged to or refunded to the client, as appropriate, in a timely manner.

Stavis & Cohen Private Wealth generally imposes a minimum portfolio value for its investment management services. Stavis & Cohen Private Wealth, in its sole discretion, may negotiate to waive its stated account minimum or charge a lesser management fee based upon certain criteria (e.g., anticipated future earning capacity, anticipated future additional assets, dollar amount of assets to be managed, related accounts, account composition, pre-existing client, account retention, pro bono activities, etc.).

Stavis & Cohen Private Wealth offers advice on the various types of investments listed above. However, Stavis & Cohen Private Wealth intends to primarily allocate its clients' investment management assets on a discretionary and/or a non-discretionary basis among model portfolios which may utilize mutual funds, exchange traded funds (ETFs) and Independent Managers (as defined below) in accordance with the investment objectives of the client.

As further discussed in the following sections, Stavis & Cohen Private Wealth generally recommends that clients utilize the brokerage and clearing services of Pershing, LLC through Pershing Investment Manager Services ("Pershing") for investment management accounts. In the case of a 401k plan participant, the brokerage and clearing services are

chosen by the plan sponsor of which Stavis & Cohen Private Wealth has no control.

Stavis & Cohen Private Wealth may only implement its investment management recommendations after the client has arranged for and furnished Stavis & Cohen Private Wealth with all information and authorization regarding accounts with appropriate financial institutions. Financial institutions will include, but are not limited to, Pershing, any other broker-dealer recommended by Stavis & Cohen Private Wealth, broker-dealer directed by the client, trust companies, banks etc. (collectively referred to herein as the "Financial Institution(s)"). 401k plan participant accounts are established at the Custodian chosen by the plan sponsor and Stavis & Cohen Private Wealth has no control of that choice.

You may incur certain charges imposed by the Financial Institution(s) and other third parties such as fees charged by Independent Managers (as defined below), custodial fees, charges imposed directly by a mutual fund or exchange traded fund in the account, which will be disclosed in the fund's prospectus (e.g., fund management fees and other fund expenses), deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions. Additionally, for assets outside of any wrap fee programs, you may incur brokerage commissions and transaction fees. Such charges, fees and commissions are exclusive of and in addition to Stavis & Cohen Private Wealth's investment management fee. The Firm may bill 401k plan participants directly for management fees if the plan sponsor cannot authorize its plan administrator to direct debit the plan participant's 401k account after appropriate participant authorization.

Stavis & Cohen Private Wealth's Agreement and/or the separate agreement with the Financial Institution(s) may authorize Stavis & Cohen Private Wealth through the Financial Institution(s) to debit your account for the amount of Stavis & Cohen Private Wealth's fee and to directly remit that management fee to Stavis & Cohen Private Wealth in accordance with applicable custody rules. The Financial Institution(s) recommended by Stavis & Cohen Private Wealth has agreed to send a statement to each client, at least quarterly, indicating all amounts disbursed from the account including the amount of management fees paid directly to Stavis & Cohen Private Wealth.

For certain clients, Stavis & Cohen Private Wealth may manage client portfolios by allocating portfolio assets among various investments on a discretionary basis using one or more of its proprietary investment strategies (collectively referred to as "investment strategy"). In so doing, Stavis & Cohen Private Wealth will buy, sell, exchange and/or transfer investments based upon the investment strategy.

Stavis & Cohen Private Wealth's management using the investment strategy has been designed to comply with the requirements of Rule 3a-4 of the Investment Company Act of 1940, as amended. Rule 3a-4 provides similarly-managed accounts, such as the investment strategy, with a safe harbor from the definition of an investment company. In accordance with Rule 3a-4, the following features have been specifically included in Stavis & Cohen Private Wealth's management using the investment strategy:

1. **Initial Interview** - an initial interview is conducted with each client to determine the client's financial circumstances, goals, acceptable levels of risk, any reasonable restrictions on the management of their account, and other relevant circumstances;

2. **Individual Treatment** - the client's account is managed on the basis of the client's financial circumstances and investment objectives;
3. **Consultation** - an Advisory Affiliate of Stavis & Cohen Private Wealth knowledgeable about the client's account will be reasonably available to consult with the client relative to the status and management of their account;
4. **Notice of Transactions** - the client will receive notice of all transactions in their Quarterly Statement - the client will be provided with a quarterly statement containing a description of all activity in the their account;
5. **Ability to Impose Restrictions** - the client will have the ability to impose reasonable restrictions on the management of their account, including the ability to instruct Stavis & Cohen Private Wealth not to purchase certain securities or types of securities;
6. **No Pooling** - the client's beneficial interest in a security does not represent an undivided interest in all the securities held by the custodian, but rather represents a direct and beneficial interest in the securities which comprise the client's account;
7. **Separate Account** - a separate account is maintained for the client with the custodian; and
8. **Ownership** - each client retains indicia of ownership of the account (e.g. right to withdraw securities or cash, exercise or delegate proxy voting, and receive transaction confirmations).

In addition to the foregoing, clients may, in writing, place reasonable limitations upon Stavis & Cohen Private Wealth's discretionary authority. The investment strategy may involve an above-average portfolio turnover that could negatively impact upon the net after-tax gain experienced by an individual client. Securities in the investment strategy are usually exchanged and/or transferred without regard to a client's individual tax ramifications. Certain investment opportunities that become available to Stavis & Cohen Private Wealth's clients may be limited. For example, various mutual funds or insurance companies may limit the ability of Stavis & Cohen Private Wealth to buy, sell, exchange or transfer securities consistent with its investment strategy. As further discussed in following sections, in order to meet its fiduciary duties to all of its clients, Stavis & Cohen Private Wealth will endeavor to allocate investment opportunities among its clients on a fair and equitable basis. Participation in Stavis & Cohen Private Wealth's investment strategy carries additional risk to clients in that a mutual fund may unilaterally restrict and/or prohibit Stavis & Cohen Private Wealth's trading activities thus prohibiting it from managing the assets consistent with the investment strategy.

NON-DISCRETIONARY INVESTMENT MANAGEMENT SERVICES

Stavis & Cohen Private Wealth also renders non-discretionary investment management services to clients relative to: (1) variable life/annuity products that they may own, and/or (2) their individual employer-sponsored retirement plans. In so doing, Stavis & Cohen Private Wealth may direct or recommend the allocation of client assets among the various mutual fund subdivisions that comprise the variable life/annuity product or the retirement plan. The client assets will be maintained at either the specific insurance company that issued the variable life/annuity product which is owned by the client, or at the custodian designated by the sponsor of the client's retirement plan.

GENERAL INFORMATION FOR ADVISORY SERVICES

You may make additions to and withdrawals from your account at any time. If assets that exceed \$10,000 are deposited into your account after the inception of a quarter, the fee payable with respect to such assets will be prorated based on the number of days remaining in the quarter. You may withdraw account assets on notice to Stavis & Cohen Private Wealth, subject to the usual and customary securities settlement procedures. For partial withdrawals in excess of \$10,000 within a billing period, Stavis & Cohen Private Wealth will credit its unearned fee. Please be advised that Stavis & Cohen Private Wealth designs its portfolios as long-term investments and asset withdrawals may impair the achievement of your investment objectives.

Additions may be in cash or securities provided that Stavis & Cohen Private Wealth reserves the right to liquidate any transferred securities or decline to provide advisory services for particular securities in a client's account. Stavis & Cohen Private Wealth may consult with you about the options and ramifications of transferring securities. However, you are advised that when transferred securities are liquidated, they are subject to transaction fees, fees assessed at the mutual fund level (e.g. contingent deferred sales charge) and/or tax ramifications.

Stavis & Cohen Private Wealth's clients are advised to promptly notify the Firm if there are ever any changes in their financial situation or investment objectives or if they wish to impose any reasonable restrictions upon Stavis & Cohen Private Wealth's management services.

Neither Stavis & Cohen Private Wealth nor any client may assign the Agreement without the consent of the other party. Transactions that do not result in a change of actual control or management of Stavis & Cohen Private Wealth will not be considered an assignment.

RECOMMENDATION OF THIRD-PARTY MONEY MANAGERS

Stavis & Cohen Private Wealth acts as a solicitor and allows its Adviser Representatives to refer clients to unaffiliated third party investment advisory firms offering asset management and other investment advisory services. As a result, Stavis & Cohen Private Wealth is paid the solicitation fee charged and collected by the third-party Investment Adviser in the form of solicitor fees or consulting fees. Each solicitation arrangement is performed pursuant to a written solicitation agreement and is in compliance with SEC Rule 206(4)-3 and applicable state securities rules and regulations.

Through this program, Adviser Representatives will assist you with identifying your risk tolerance and investment objectives. The Adviser Representative will recommend third party Investment Advisers in relation to your stated investment objectives and risk tolerance. You may select a recommended third-party Investment Adviser firm based upon your needs. You will enter into an agreement directly with the unaffiliated third-party Investment Adviser who will provide asset management services.

Adviser Representatives are available to answer questions you may have regarding your account and act as the communication conduit between you and the third-party Investment Adviser. Third party Investment Advisers may take discretionary authority to determine the securities to be purchased and sold for your account. Neither Stavis &

Cohen Private Wealth nor its associated persons will have any trading authority with respect to a client's managed account with the third-party Investment Adviser(s).

Third party managed programs generally have account minimum requirements that will vary from Investment Adviser to Investment Adviser. Account minimums are generally higher on fixed income accounts than equity-based accounts. A complete description of the third party Investment Adviser's services, fee schedules and account minimums will be disclosed in the third party Investment Adviser's Form ADV Part 2A Disclosure Brochure, or if a wrap fee program, in the Part 2A – Appendix 1 Wrap Fee Program Brochure (formerly Schedule H Disclosure Brochure), or similar Disclosure Brochure which will be provided to clients at the time an agreement for services is executed and the account is established. Client reports will depend upon the third-party Investment Adviser.

While the actual fee charged to you will vary depending on the third-party investment utilized, the portion retained by Stavis & Cohen Private Wealth in the form of solicitor fees or consulting fees will not exceed 1.25%. Overall management fees charged to any client through this program will include the portion retained by the third-party Investment Adviser and therefore may exceed 1.25%. All fees are calculated and collected by the selected third-party Investment Adviser firm who will be responsible for delivering Stavis & Cohen Private Wealth's portion of the client fee to the Firm.

Clients may incur additional charges including but not limited to, mutual fund sales loads, 12(b)-1 fees and surrender charges, and IRA and qualified retirement plan fees. Stavis & Cohen Private Wealth will not receive any portion of such commissions or fees. Stavis & Cohen Private Wealth is only compensated by the consulting fee as described above. Stavis & Cohen Private Wealth receives no other compensation in connection with a client's account.

While Stavis & Cohen Private Wealth consistently reviews the performance of numerous third-party investment firms, Stavis & Cohen Private Wealth enters into relationships with only a select number of third-party Investment Advisers that pass the Firm's due diligence process. Third party Investment Advisers recommended by Stavis & Cohen Private Wealth must be registered or exempt from registration in the state where the client resides.

Clients are advised that investment Adviser Representatives may have a conflict of interest by only offering those third-party Investment Advisers that have agreed to pay a portion of their advisory fee to Stavis & Cohen Private Wealth and have met the conditions of Stavis & Cohen Private Wealth's due diligence review. Clients are advised that there may be other third-party managed programs that may be suitable to the client that may be more or less costly. No guarantees can be made that client's financial goals or objectives will be achieved. Further, no guarantees of performance can be offered.

TAX PREPARATION SERVICES

Stavis & Cohen Private Wealth offers certain tax preparation services. Prior to engaging Stavis & Cohen Private Wealth for Tax Preparation services, you will be required to enter into a written agreement with Stavis & Cohen Private Wealth which sets forth the terms and conditions of the engagement and describes the scope of the services to be provided. Tax

preparation fees will be on a stand-alone and separate fee basis. Tax Preparation fees will generally range from \$500 - \$15,000 and are dependent upon the scope and complexity of the tax returns and related complexity of client needs.

It is the client's responsibility to ensure Stavis & Cohen Private Wealth and its Adviser Representative have been furnished complete copies of all documents that establish and govern the plan and evidencing the client's authority to retain Stavis & Cohen Private Wealth as an Investment Adviser. Clients must promptly furnish to Stavis & Cohen Private Wealth any amendments to the plan and if any amendment affects the rights or obligations of Stavis & Cohen Private Wealth, such amendments will be binding on Stavis & Cohen Private Wealth and its Adviser Representative only when agreed to by the Firm in writing.

Clients must maintain appropriate ERISA bonding coverage for their managed account(s) and must include within the coverage of the bond Stavis & Cohen Private Wealth, its Adviser Representatives and their personnel as may be required by law.

PERFORMANCE-BASED FEES AND SIDE-BY-SIDE MANAGEMENT (Item 6)

Performance-based fees can be defined as fees based on a share of capital gains on or capital appreciation of the assets held within a client's account.

Stavis & Cohen Private Wealth generally provides investment advice to the following types of clients:

- Individuals
- High-Net Worth Individuals
- Pension or Profit Sharing Plans
- Trusts, estates, or charitable organizations
- Corporations or business entities other than those listed above

All clients are required to execute an agreement for services in order to establish a client arrangement with Stavis & Cohen Private Wealth and/or separately with a third-party money manager, or the sponsor of third-party money manager platforms.

MINIMUM INVESTMENT AMOUNTS REQUIRED

As a condition for starting and maintaining a relationship for the provision of financial planning and/or investment management services, Stavis & Cohen Private Wealth generally imposes a minimum portfolio size of \$2,000,000. Stavis & Cohen Private Wealth, in its sole discretion, may accept clients with smaller portfolios based upon certain criteria including anticipated future earning capacity, anticipated future additional assets, dollar amount of assets to be managed, related accounts, account composition, pre-existing client, account retention, and pro bono activities. Stavis & Cohen Private Wealth will only accept clients with less than the minimum portfolio size if, in our sole opinion, the smaller portfolio size will not cause a substantial increase of investment risk beyond the client's identified risk tolerance. Stavis & Cohen Private Wealth may aggregate the portfolios of family members to meet the minimum portfolio size.

Additionally, certain Independent Manager(s) may impose more restrictive account requirements and varying billing practices than Stavis & Cohen Private Wealth. In such instances, Stavis & Cohen Private Wealth may alter its corresponding account requirements and/or billing practices to accommodate those of the Independent Manager(s) or wrap fee program sponsor.

METHODS OF ANALYSIS, INVESTMENT STRATEGIES AND RISK OF LOSS (Item 8)

METHODS OF ANALYSIS

Stavis & Cohen Private Wealth uses the following methods of analysis in formulating investment advice:

Fundamental - A method of evaluating a security by attempting to measure its intrinsic value by examining related economic, financial and other qualitative and quantitative factors. Fundamental analysts attempt to study everything that can affect the security's value, including macroeconomic factors (like the overall economy and industry conditions) and individually specific factors (like the financial condition and management of companies). The end goal of performing fundamental analysis is to produce a value that an investor can compare with the security's current price in hopes of figuring out what sort of position to take with that security (underpriced = buy, overpriced = sell or short). This method of security analysis is considered to be the opposite of technical analysis. Fundamental analysis is about using real data to evaluate a security's value. Although most analysts use fundamental analysis to value stocks, this method of valuation can be used for just about any type of security.

Technical - A method of evaluating securities by analyzing statistics generated by market activity, such as past prices and volume. Technical analysts do not attempt to measure a security's intrinsic value, but instead use charts and other tools to identify patterns that can suggest future activity. Technical analysts believe that the historical performance of stocks and markets may be indications of future performance.

INVESTMENT STRATEGIES

Stavis & Cohen Private Wealth uses the following investment strategies when managing client assets and/or providing investment advice:

- Long-term purchases. Investments held at least a year.
- Short-term purchases. Investments sold within a year.

USE OF PRIMARY METHOD OF ANALYSIS OR STRATEGY

Through a research-driven process, we identify major trends in economic and market indicators, along with geopolitical forces, to uncover risks and opportunities in the global investment landscape. We receive a continuous flow of research from multiple sources. Based on an ever-changing economic landscape, we then adapt our asset allocation to match our current global economic outlook, using a disciplined quantitative and qualitative methodology. While the allocations are strategic in nature, our process allows us to be extremely nimble. Once we have determined the appropriate asset allocation, we select from the universe of portfolio managers to identify those that are among best in class for each asset category. We monitor the changing market environment and make portfolio adjustments to help capitalize on opportunities and minimize risk. While efforts are made to mitigate risks, the investment strategy is no guarantee of future results and there is a risk of loss of capital.

RISK OF LOSS

Past performance is not indicative of future results. Therefore, you should never assume that future performance of any specific investment or investment strategy will be profitable. Investing in securities (including stocks, mutual funds, ETFs, bonds, etc) involves risk of loss. Further, depending on the different types of investments there may be varying degrees of risk. You should be prepared to bear investment loss including loss of original principal.

Because of the inherent risk of loss associated with investing, we are unable to represent, guarantee, or even imply that our services and methods of analysis can or will predict future results, successfully identify market tops or bottoms, or insulate you from losses due to market corrections or declines. - **Market Risk** – Either the stock market as a whole, or the value of an individual company, goes down resulting in a decrease in the value of client investments. This is also referred to as systemic risk.

OTHER FINANCIAL INDUSTRY ACTIVITIES AND AFFILIATIONS (Item 10)

We have revised our disclosure to reflect financial industry affiliations as a result of our new ownership structure and affiliation with CI Financial and CI Private Wealth. CI Financial, through CI Private Wealth or other indirect subsidiaries, also owns other registered investment advisers, tax preparation service companies, and financial services-related

companies located in the U.S. and Canada (CI Affiliates). Some CI Affiliates manage or advise private funds, investment companies or other investment vehicles as disclosed in their respective Form ADVs.

Stavis & Cohen Private Wealth LLC operates independently of other CI Affiliates. Certain individuals of Stavis & Cohen Private Wealth LLC sit on an informal advisory board of CI Private Wealth which was created to inform executive management about business initiatives of the CI Private Wealth business. This advisory board is comprised of business leaders from various of the registered investment advisers owned by CI Private Wealth and does not have the power to control the management of Stavis & Cohen Private Wealth LLC. Stavis & Cohen Private Wealth LLC does not have any referral arrangements or other reciprocal arrangements with other CI Affiliates.

Stavis & Cohen Private Wealth is not and does not have a related company that is a (1) broker/dealer, municipal securities dealer, government securities dealer or broker, (2) investment company or other pooled investment vehicle (including a mutual fund, closed-end investment company, unit investment trust, private investment company or "hedge fund," and offshore fund), (3) futures commission merchant, commodity pool operator, or commodity trading advisor, (4) banking or thrift institution, (5) accountant or accounting firm, (6) lawyer or law firm, (7) insurance company or agency, (8) pension consultant, (9) real estate broker or dealer, or (10) sponsor or syndicator of limited partnerships.

OTHER BUSINESS ACTIVITIES

Stavis & Cohen Private Wealth provides its clients with a broad range of comprehensive financial planning services (which may include non-investment related matters). Stavis & Cohen Private Wealth may charge a separate fee for these services which will be agreed upon prior to rendering the services.

Certain of Stavis & Cohen Private Wealth's advisory affiliates, including Deborah Stavis, in their individual capacities, are also licensed insurance agents with various insurance companies, and in such capacity, may recommend, on a commission basis, the purchase of certain insurance products. Stavis & Cohen Private Wealth does permit its Advisory Affiliates, in their individual capacities as licensed insurance agents, to sell insurance products to its investment advisory clients. A conflict of interest may exist to the extent that Stavis & Cohen Private Wealth recommends the purchase of insurance products where Stavis & Cohen Private Wealth's Advisory Affiliates receive insurance commissions or other additional compensation.

Any requested brokerage services will be provided under a commission-based brokerage account with FSC Securities Corp ("FSC"). Under such an arrangement, you may implement securities transactions through Deborah Stavis in her capacity as a registered representative of FSC, a diversified financial services company registered with the Financial Industry Regulatory Authority ("FINRA") as a broker-dealer engaged in the offer and sale of security products. Brokerage commissions may be charged by FSC to affect these securities transactions and thereafter, a portion of these commissions may be paid by FSC to Deborah Stavis. Prior to effecting any securities transactions, you will be required to enter into a new account agreement with FSC. The brokerage commissions charged by FSC may be higher or lower than those charged by other broker-dealers. These commission-based brokerage accounts represent a small number of accounts and are used as an accommodation for unique client considerations.

The receipt of commissions creates an incentive to recommend those products for which a commission will be received. Consequently, the objectivity of the advice rendered to clients could be biased. This potential conflict of interest is

controlled by discussing with clients both the advantages and disadvantages of establishing commission-based account with FSC versus a fee-based advisory account through Stavis & Cohen Private Wealth. The potential conflict of interest is further controlled by exclusively utilizing a discounted commission schedule for all non-advisory accounts. Please be aware that you are under no obligation to purchase products or services recommended by us or members of our Firm in connection with providing you with any advisory service that we offer.

Additionally, ongoing 12b-1 fees that would normally be received for mutual fund purchases from the mutual fund company during the period that you maintain the mutual fund investment will be refunded in the Advisor Managed

Portfolio (AMP) accounts to eliminate the potential conflict of interest that could exist to the extent that Stavis & Cohen Private Wealth recommends the purchase of securities where commissions or other additional compensation would have been received as a result of Stavis & Cohen Private Wealth's recommendations. Any 12b-1 fees for accounts serviced by Deborah Stavis are refunded back to the client by the fund company in the respective AMP account on a periodic basis. Stavis & Cohen Private Wealth maintains records of all 12b-1 fee refunds to clients.

Certain product sponsors may provide Stavis & Cohen Private Wealth with other economic benefits as a result of the recommendation or sale of the product sponsors' investments. The economic benefits received by Stavis & Cohen Private Wealth from product sponsors can include but are not limited to, financial assistance or the sponsorship of conferences and educational sessions, marketing support, incentive awards, payment of travel expenses, and tools to assist Stavis & Cohen Private Wealth in providing various services to clients. Although Stavis & Cohen Private Wealth endeavors at all times to put the interest of their clients ahead of those of Stavis & Cohen Private Wealth's officers, directors, or representatives ("affiliated persons"), these arrangements present a conflict of interest which could affect judgment when recommending investment products.

For accounts covered by ERISA (and such others that Stavis & Cohen Private Wealth, in its sole discretion deems appropriate), Stavis & Cohen Private Wealth may modify the foregoing commission arrangement to allow for its investment advisory services to be rendered on a fee-offset basis. In this scenario, Stavis & Cohen Private Wealth may offset its fees by an amount equal to the aggregate commissions and 12b-1 fees earned by Stavis & Cohen Private Wealth's Advisory Affiliates in their individual capacities as registered representatives of FSC.

In an effort to ensure that my outside business activities do not interfere with or otherwise compromise my relationship with you, all outside business activities that I engage in are reviewed and approved by an appointed supervisor.

THIRD-PARTY MONEY MANAGERS

As described in the section regarding Advisory Business, as well as the section regarding Fees and Compensation, Stavis & Cohen Private Wealth has formed relationships with independent, third-party money managers.

Stavis & Cohen Private Wealth may recommend clients work directly with third-party money managers. When we refer clients to a third-party money manager, you need to know that our firm will receive a portion of the fee charged by the third-party money manager. Therefore, there may be a conflict of interest in that we will generally recommend third-

party money managers that will agree to compensate our firm by paying us a portion of the fees billed to your account managed by the third-party money manager.

CODE OF ETHICS (Item 11)

CODE OF ETHICS SUMMARY

Stavis & Cohen Private Wealth has adopted a code of ethics that sets forth the standards of conduct expected of its associated persons and requires compliance with applicable securities laws ("Code of Ethics"). In accordance with Section 204A of the Advisers Act, our Code of Ethics contains written policies reasonably designed to prevent the unlawful use of material non-public information by Stavis & Cohen Private Wealth or any of our associated persons. The Code of Ethics also requires that certain of the Firm personnel (called "Access Persons") report their personal securities holdings and transactions and obtain pre-approval of certain investments such as initial public offerings and limited offerings. You may contact the Firm to request a copy of our Code of Ethics.

When Stavis & Cohen Private Wealth is purchasing or considering for purchase any security on behalf of a client, no Access Person may affect for themselves or for their immediate family (e.g., spouse, minor children, and adults living in the same household as the Access Person) a transaction in that security prior to the completion of the purchase or until a decision has been made not to purchase such security. Similarly, when Stavis & Cohen Private Wealth is selling or considering the sale of any security on behalf of a client, no Access Person may affect for themselves or for their immediate family (e.g., spouse, minor children, and adults living in the same household as the Access Person) a transaction in that security prior to the completion of the sale or until a decision has been made not to sell such security. These requirements are not applicable to: (i) direct obligations of the Government of the United States; (ii) money market instruments, bankers' acceptances, bank certificates of deposit, commercial paper, repurchase agreements and other high quality short-term debt instruments, including repurchase agreements; (iii) shares issued by mutual funds or money market funds; (iv) ETFs based in a broad market index; and (v) shares issued by unit investment trusts that are invested exclusively in one or more mutual funds.

AFFILIATE AND EMPLOYEE PERSONAL SECURITIES TRANSACTIONS DISCLOSURE

Stavis & Cohen Private Wealth or its associated persons may buy or sell for their personal accounts, investment products identical to those recommended to clients. This creates a potential conflict of interest. It is the express policy of Stavis & Cohen Private Wealth that all persons associated in any manner with the firm must place the interests of our clients ahead of their own when implementing personal investments. Stavis & Cohen Private Wealth and its associated persons will not buy or sell securities for their personal account(s) where their decision is derived, in whole or in part, by information obtained as a result of his/her employment unless the information is also available to the investing public upon reasonable inquiry. In order to minimize this conflict of interest, securities recommended by Stavis & Cohen Private Wealth are generally widely held and publicly traded.

BROKERAGE PRACTICES (Item 12)

You are under no obligation to act on the financial planning recommendations of Stavis & Cohen Private Wealth. If the Firm assists in the implementation of any recommendations, we are responsible to ensure that you receive the best execution possible.

Except as provided for in any applicable wrap fee program, the brokerage commissions and/or transaction fees charged by Pershing or any other designated broker-dealer are exclusive of and in addition to Stavis & Cohen Private Wealth's fee. Factors which the Firm considers in recommending Pershing or any other broker-dealer, to clients include the broker-dealer's respective financial strength, reputation, execution, pricing, research, and service. Pershing enables Stavis & Cohen Private Wealth to obtain certain mutual funds without transaction charges and other securities at nominal transaction charges. The commissions and/or transaction fees charged by Pershing may be higher or lower than those charged by other broker-dealers.

The commissions paid by Stavis & Cohen Private Wealth's clients will comply with the Firm's duty to obtain "best execution." However, a client may pay a commission that is higher than another qualified broker-dealer might charge to affect the same transaction where the Firm determines, in good faith, that the commission is reasonable in relation to the value of the brokerage and research services received. In seeking best execution, the determinative factor is not the lowest possible cost, but whether the transaction represents the best qualitative execution, taking into consideration the full range of a broker-dealer's services, including among others, the value of research provided, execution capability, commission rates, and responsiveness. Consistent with the foregoing, while the Firm will seek competitive rates, it may not necessarily obtain the lowest possible commission rates for client transactions.

If you request Stavis & Cohen Private Wealth to arrange for the execution of securities brokerage transactions for your account, the Firm will direct such transactions through broker-dealers that the Firm reasonably believes will provide best execution. The Firm will periodically and systematically review its policies and procedures regarding recommending broker-dealers to its client in light of its duty to obtain best execution.

401k plan participant account brokerage execution is determined by the plan sponsor. The Firm does not have the ability, nor does the participant, to direct the brokerage execution of the 401k plan participant's transaction. Best execution of these transactions is determined by the plan sponsor or the plan sponsor's named fiduciary adviser.

You may direct Stavis & Cohen Private Wealth in writing to use a particular broker-dealer to execute some or all transactions for your account. In that case, you are responsible for negotiating terms and arrangements for your account with that broker-dealer, and Stavis & Cohen Private Wealth will not seek better execution services or prices from other broker-dealers or be able to "batch" client transactions for execution through other broker-dealers with orders for other accounts managed

by the Firm (as described below). As a result, if you have directed use of a particular broker-dealer, you may pay higher commissions or other transaction costs or greater spreads, or receive less favorable net prices, on transactions for your account than would otherwise be the case. Subject to its duty of best execution, Stavis & Cohen Private Wealth may decline a client's request to direct brokerage if, in the Firm's sole discretion, such directed brokerage arrangements would result in additional operational difficulties or violate restrictions imposed by other broker-dealers (as further discussed below).

As discussed above, certain Advisory Affiliates in their respective individual capacities are registered representatives of FSC. These Advisory Affiliates are subject to FINRA Rule 3040 which restricts registered representatives from conducting securities transactions away from their broker-dealer unless FSC provides written consent. Therefore, clients are advised that certain Advisory Affiliates may be restricted to conducting securities transactions through FSC unless they first secure written consent from FSC to execute securities transactions through a different broker-dealer. Under FSC's internal supervisory policies, absent written consent from or separation from FSC, these Advisory Affiliates are prohibited from executing securities transactions through any broker-dealer other than FSC. Stavis & Cohen Private Wealth is cognizant of its duty to obtain best execution and has implemented policies and procedures reasonably designed in such pursuit.

Stavis & Cohen Private Wealth may receive from Pershing, without cost to the Firm, computer software and related systems support, which allow Stavis & Cohen Private Wealth to better monitor client accounts maintained at Pershing. Stavis & Cohen Private Wealth may receive the software and related support without cost because Stavis & Cohen Private Wealth renders investment management services to clients that maintain assets at Pershing. The software and related systems support may benefit the Firm, but not its clients directly. In fulfilling its duties to its clients, Stavis & Cohen Private Wealth endeavors at all times to put the interests of its clients first. Clients should be aware, however, that the Firm's receipt of economic benefits from a broker-dealer may create a conflict of interest since these benefits may influence the Firm's choice of broker-dealer over another broker-dealer that does not furnish similar software, systems support, or services.

Additionally, Stavis & Cohen Private Wealth may receive the following benefits from Pershing: receipt of duplicate client confirmations and bundled duplicate statements; access to a trading desk that exclusively services its Pershing participants; access to block trading which provides the ability to aggregate securities transactions and then allocate the appropriate shares to client accounts; and access to an electronic communication network for client order entry and account information.

HANDLING TRADE ERRORS

Stavis & Cohen Private Wealth has implemented procedures designed to prevent trade errors; however, trade errors in client accounts cannot always be avoided. Consistent with its fiduciary duty, it is the policy of the Firm to correct trade errors in a manner that is in your best interest. In cases where you (the client) cause the trade error, you will be responsible for any loss resulting from the correction. Depending on the specific circumstances of the trade error, you may not be able to receive any gains generated as a result of the error correction. In all situations where

you do not cause the trade error, you will be made whole and any loss resulting from the trade error will be absorbed by Stavis & Cohen Private Wealth if the error was caused by the Firm. If the error is caused by the broker-dealer, the broker-dealer will be responsible for handling the trade error. If an investment gain results from the correcting trade, the gain will remain in your account unless the same error involved other client account(s) that should also receive the gains and it is not permissible for all clients to retain the gain. Stavis & Cohen Private Wealth may also confer with you to discuss if there is any reason that you should forego the gain (e.g., due to tax reasons), and the Firm will not benefit or profit from trade errors.

BLOCK TRADING POLICY

Transactions implemented by Stavis & Cohen Private Wealth for client accounts are generally affected independently, unless the firm decides to purchase or sell the same securities for several clients at approximately the same time. This process is referred to as aggregating orders, batch trading or block trading and is used by the Firm when it believes such action may prove advantageous to clients. When the Firm aggregates client orders, the allocation of securities among client accounts will be done on a fair and equitable basis. Typically, the process of aggregating client orders is done in order to achieve better execution, to negotiate more favorable commission rates or to allocate orders among clients on a more equitable basis in order to avoid differences in prices and transaction fees or other transaction costs that might be obtained when orders are placed independently. Under this procedure, transactions will be averaged as to price and will be allocated among the firm's clients in proportion to the purchase and sale orders placed for each client account on any given day. When the Firm determines to aggregate client orders for the purchase or sale of securities, including securities in which Stavis & Cohen Private Wealth may invest, the Firm will do so in accordance with the parameters set forth in the SEC No-Action Letter, SMC Capital, Inc. It should be noted, Stavis & Cohen Private Wealth does not receive any additional compensation or remuneration as a result of aggregation.

REVIEW OF ACCOUNTS (Item 13)

ACCOUNT REVIEWS AND REVIEWERS

For those clients to whom Stavis & Cohen Private Wealth provides investment management services, the Firm monitors those portfolios as part of an ongoing process while regular account reviews are conducted on at least a quarterly basis. All investment advisory clients are encouraged to discuss their needs, goals, and objectives with Stavis & Cohen Private Wealth and to keep the Firm informed of any changes thereto. The Firm will contact ongoing investment advisory clients at least annually to review its previous services and/or recommendations and to discuss the impact resulting from any changes in the client's financial situation and/or investment objectives.

For those clients to whom Stavis & Cohen Private Wealth provides financial planning services, reviews are conducted on an "as needed" basis. Such reviews are conducted by one of the Firm investment adviser representatives.

STATEMENTS AND REPORTS

Unless otherwise agreed upon, clients are provided with transaction confirmation notices and regular summary account statements directly from the broker-dealer or custodian for the client accounts. Those clients to whom Stavis & Cohen Private Wealth provides investment advisory services will also receive a report from Stavis & Cohen Private Wealth that may include such relevant account and/or market-related information such as an inventory of account holdings and account performance on a quarterly basis.

Those clients to whom Stavis & Cohen Private Wealth provides financial planning services will receive reports from Stavis & Cohen Private Wealth summarizing its analysis and conclusions as requested by the client or otherwise agreed to in writing by Stavis & Cohen Private Wealth.

CLIENT REFERRALS AND OTHER COMPENSATION (Item 14)

Stavis & Cohen Private Wealth solicits for and directs clients to third-party money managers. Stavis & Cohen Private Wealth will be compensated via a fee share from the advisors to which it directs those clients, as further described in Item 5 "Fees and Compensation" and Item 10 "Other Financial Industry Activities and Affiliations" hereof and as memorialized in the contract between Stavis & Cohen Private Wealth and the third-party adviser.

Stavis & Cohen Private Wealth does not directly or indirectly compensate any non-advisory personnel for client referrals.

CUSTODY (Item 15)

Custody, as it applies to investment advisors, has been defined by regulators as having access or control over client funds and/or securities. In other words, custody is not limited to physically holding client funds and securities. If an investment advisor has the ability to access or control client funds or securities, the investment advisor is deemed to have custody and must ensure proper procedures are implemented.

Stavis & Cohen Private Wealth is deemed to have custody of client funds and securities whenever Stavis & Cohen Private Wealth is given the authority to have fees deducted directly from client accounts. However, this is the only form of custody Stavis & Cohen Private Wealth will ever maintain. It should be noted that authorization to trade in client accounts is not deemed by regulators to be custody. In cases where the Firm is advising 401k plan participant assets, the Firm is not in possession of the participant's user name and password. Transactions in the participant's account takes place through an order entry system that ensures Stavis & Cohen Private Wealth does not have the ability to make transfers or instruct the Custodian to make transfers out of the participant's account thereby avoiding custody.

For accounts in which Stavis & Cohen Private Wealth is deemed to have custody, the firm has established procedures to ensure all client funds and securities are held at a qualified custodian in a separate account for each client under that client's name. Clients or an independent representative of the client will direct, in writing, the establishment of all accounts and therefore are aware of the qualified custodian's name, address and the manner in which the funds or securities are maintained. Finally, account statements are delivered directly from the qualified custodian to each client, or the client's independent representative, at least quarterly. Clients should carefully review those statements and are urged to compare the statements against reports received from Stavis & Cohen Private Wealth. When clients have questions about their account statements, they should contact Stavis & Cohen Private Wealth or the qualified custodian preparing the statement.

INVESTMENT DISCRETION (Item 16)

Through its asset management services and upon receiving written authorization from a client, Stavis & Cohen Private Wealth will maintain limited trading authorization over client accounts. Upon receiving written authorization from the client, Stavis & Cohen Private Wealth may implement trades on a **discretionary** basis. When discretionary authority is granted, Stavis & Cohen Private Wealth will have the authority to determine the type of securities, the amount of securities that can be bought or sold, and the broker or dealer to be used for the client's portfolio without obtaining the client's consent for each transaction.

If you decide to grant trading authorization on a **non-discretionary** basis, we will be required to contact you prior to implementing changes in your account. Therefore, you will be contacted and required to accept or reject our investment recommendations including:

- The security being recommended
- The number of shares or units
- Whether to buy or sell

Once the above factors are agreed upon, Stavis & Cohen Private Wealth will be responsible for making decisions regarding the timing of buying or selling an investment and the price at which the investment is bought or sold. If your accounts are managed on a non-discretionary basis, you need to know that if you are not able to be reached or are slow to respond to our request, it can have an adverse impact on the timing of trade implementations, and we may not achieve the optimal trading price.

All clients have the ability to place reasonable restrictions on the types of investments that may be purchased in an account. Clients may also place reasonable limitations on the discretionary power granted to our firm so long as the limitations are specifically set forth or included as an attachment to the client agreement.

VOTING CLIENT SECURITIES (Item 17)

Stavis & Cohen Private Wealth does not currently accept proxy voting authority for client securities.

FINANCIAL INFORMATION (Item 18)

Appendix A – Professional Designation Qualifications

CERTIFIED FINANCIAL PLANNER (CFP®)

The CERTIFIED FINANCIAL PLANNER™, CFP® and federally registered CFP (with flame design) marks (collectively, the “CFP® marks”) are professional certification marks granted in the United States by Certified Financial Planner Board of Standards, Inc. (“CFP Board”). The CFP® certification is a voluntary certification; no federal or state law or regulation requires financial planners to hold CFP® certification. It is recognized in the United States and a number of other countries for its (1) high standard of professional education; (2) stringent code of conduct and standards of practice; and (3) ethical requirements that govern professional engagements with clients. Currently, more than 62,000 individuals have obtained CFP® certification in the United States.

To attain the right to use the CFP® marks, an individual must satisfactorily fulfill the following requirements:

Education – Complete an advanced college-level course of study addressing the financial planning subject areas that CFP Board’s studies have determined as necessary for the competent and professional delivery of financial planning services, and (since 2007) attain a Bachelor’s Degree from a regionally accredited United States college or university (or its equivalent from a foreign university). CFP Board’s financial planning subject areas include insurance planning and risk management, employee benefits planning, investment planning, income tax planning, retirement planning, and estate planning;

Examination – Pass the comprehensive CFP® Certification Examination. The examination, administered in 10 hours over a two-day period, includes case studies and client scenarios designed to test one’s ability to correctly diagnose financial planning issues and apply one’s knowledge of financial planning to real world circumstances;

Experience – Complete at least three years of full-time financial planning-related experience (or the equivalent, measured as 2,000 hours per year); and

Ethics – Agree to be bound by CFP Board’s *Standards of Professional Conduct*, a set of documents outlining the ethical and practice standards for CFP® professionals.

Individuals who become certified must complete the following ongoing education and ethics requirements in order to maintain the right to continue to use the CFP® marks:

Continuing Education – Complete 30 hours of continuing education hours every two years, including two hours on the *Code of Ethics* and other parts of the *Standards of Professional Conduct*, to maintain competence and keep up with developments in the financial planning field; and

Ethics – Renew an agreement to be bound by the *Standards of Professional Conduct*. The Standards prominently require that CFP® professionals provide financial planning services at a fiduciary standard of care. This means CFP® professionals must provide financial planning services in the best interests of their clients.

CERTIFIED PUBLIC ACCOUNTANT (CPA)

A Certified Public Accountant (CPA) primarily provides financial audit services, including attesting to the reasonableness of disclosures, freedom from material misstatements and adherence to applicable generally accepted accounting principles. To become a CPA, a candidate must pass the Uniform Certified Public Accountant Examination set by the American Institute of Certified Public Accountants and administered by the National Association of State Boards of Accountancy. Typically, eligibility to sit for the examination requires a candidate to have a Bachelor's Degree that includes a minimum number of qualifying credit hours in accounting and business administration plus an additional one year of studies. Candidates are also required to have public accounting work experience, with minimum requirements varying from state to state. Applicants for CPA status must also complete a special examination on ethics, including a review of state specific rules for professional practice. All CPAs are required to take continuing education courses. The requirements vary by state but usually require 120 hours of continuing education every three years with at least 20 hours taken every year. Many states require CPAs to take an ethics course during every renewal period, with courses ranging from 2-8 hours.

ENROLLED AGENT (EA)

An Enrolled Agent (EA) has earned the privilege of practicing (representing taxpayers) before the Internal Revenue Service (IRS). Candidates become Enrolled Agents by either passing a written examination or through IRS experience. Candidates taking the Special Enrollment Examination must achieve passing scores on all parts of the exam, apply for enrollment and pass a background check to ensure they have not and are not engaged in any conduct that would justify suspension or disbarment of an attorney, Certified Public Accountant or Enrolled Agent from practicing before the IRS. Candidates can also become an Enrolled Agent by having (1) a minimum of 5 years continuous employment with the IRS in which they were regularly engaged in applying and interpreting provisions of the Internal Revenue Code and regulations relating to income, estate, gift, employment or excise taxes and (2) a minimum of 5 years continuous employment with the IRS in which they were regularly engaged in applying and interpreting regulations relating to qualified retirement plan matters. Candidates applying for enrollment by experience must also pass a background check.

CHARTERED LIFE UNDERWRITER (CLU)

The Chartered Life Underwriter (CLU) designation is issued by The American College. A candidate for designation must have 3 years of full-time business experience within the 5 years before the designation is awarded. Candidates must complete 5 core and 3 elective courses and pass a proctored exam for each course. Designates must complete 30 hours of continued education every 2 years.
