From 1997 to 1999, Ms. Santaella served as lead of LatAm Equity Research/ Steel Equity Analyst for Santander Investment Securities Inc. in New York, NY. approximately 62.5 hours per month to conduct this business but not during regular securities trading hours. In terms of the real estate assets that she manages, it includes: two apartments that she owns in New York City and that she rents out. She also has exposure to three different multifamily buildings as an investor in three different LLC's. These multi-family properties are located in Houston, TX, Savannah, GA and Nashville, TN. In addition, Ms. Santaella has passive investments in Senior Living Fund, LLC which is a fund that invests in senior living properties throughout the United States.

Outside of the real estate segment, Ms. Santaella has a private equity investment in Brilliant Light Power, Inc. as a passive investor. This company is engaging in developing clean sources of energy.

She is involved in no other non-investment-related business or occupation that represents a substantial source of her income or involves a substantial amount of her time.
