Item 2 – Educational Background and Business Experience

Hendrik F. Jordaan, President and CEO of One Thousand & One Voices Management, LLC

Mr. Jordaan, 52, holds a Bachelor of Science and Juris Doctor from Southern Methodist University. Mr. Jordaan over 20 years of experience in the private equity and mergers/acquisitions industry. Mr. Jordaan was a former partner and Global Chair of the Private Equity Investments and Buyout Practice at Morrison & Foerster LLP from September 2010 until March 2013. Prior to that, Mr. Jordaan was a partner at Holme Roberts & Owen LLP in Denver, where he was Global Managing Partner of the firm's Corporate and M&A Groups.

Item 3 – Legal or Disciplinary Events:

The staff of the SEC's Enforcement Division is conducting an investigation with respect to the activities of One Thousand & One Voices Management LLC ("1K1V") and Family Legacy Capital Credit Management LLC ("FLC"). The investigation was initiated through a subpoena directed to 1K1V and FLC in August 2021. As of this time, the SEC staff has not communicated to 1K1V or FLC that it has reached any conclusions in its investigation. Because of the uncertainty associated with the investigation, however, 1K1V and FLC and their private equity funds under management (the "Funds") have been adversely affected. For example, 1K1V, FLC and the Funds have incurred substantial legal fees and related expenses associated with the investigation. In addition, the SEC investigation is required to be disclosed to lenders and potential lenders to 1K1V and FLC and/or the Funds, which resulted in FLC deciding not to pursue a working capital line of credit and which could have a negative impact on lenders' willingness to provide financing in the future.

Item 4 – Other Business Activities:

Mr. Jordaan is not actively engaged in any investment-related business or occupation other than with One Thousand & One Voices Management, LLC and the relying advisors.

Item 5 – Compensation:

Mr. Jordaan does not receive additional compensation for advisory services from anyone who is not a client.

Item 6 – Supervision:

One Thousand & One Voices Management, LLC provides investment advisory and supervisory services in accordance with the firm's Policies and Procedures Manual. The firm's Chief Compliance Officer, Mr. Jordaan, is primarily responsible for the implementation of the firm's policies and procedures and overseeing the activities of One

Thousand & One Voices Management, LLC's supervised persons and the supervised persons of the relying advisors.
