Item 4 Other Business Activities

Wayne Hast is a registered representative of Coastal Equities Inc., an SEC registered broker/dealer. As a registered representative Wayne Hast may receive commissions, sales credits, distribution and/or service fees, and may potentially receive other types of variable transaction based compensation. Receiving variable transaction based compensation may give Wayne Hast an incentive to recommend investment products based on the compensation received, rather than on the client's needs.

Wayne Hast is the owner/operator of K. Wayne Hast & Co., and individually owned enterprise operating concession stands once a year at the Texas State Fair.

Item 5 Additional Compensation

Wayne Hast is also compensated on a commission basis by Coastal Equities, Inc. for brokerage transactions. As owner/operator of K. Wayne Hast & Co, Wayne Hast can earn additional compensation based on the profit/loss of the business.

Item 6 Supervision

Investment Advisor Representatives are supervised on an ongoing basis. All advisory accounts are monitored on a systematic random basis, are reviewed by the investment advisor representative, and reviewed no less than quarterly by a designated principal of the firm. More active accounts and larger accounts may be reviewed on a more frequent basis.

Supervision of investment advisor representatives consists of reviews of advisory accounts on a transactional basis to ensure that each transaction is (1) suitable to the respective client's investment objectives; (2) meets that client's quality standards; and (3) to make certain the activity is consistent with their financial profile.

All communications with advisory clients are also monitored and reviewed on an on-going basis to ensure the investment advice being given is appropriate for each advisory client.
