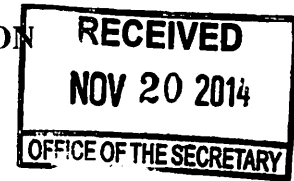

TO ASSIST SECRETARY WITH RECORD OF SERVICE**


NEIL J. WELCH, JR., pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Investigations Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. I am submitting this Declaration to supplement my previous Declaration which listed the wrong street number for respondent Ackeeox Corp., and to assist the Secretary in maintaining a record of service on the respondents in the above-captioned proceedings pursuant to Rule 141(a)(3).

2. The Division of Enforcement mailed the OIP to respondent Ackeeox Corp. (CIK No. 1129641) via Priority Mail Express, Label Tracking No. EG929802161US to the address shown on its most recent EDGAR filing of 2835 North Military Trail, West Palm Beach, FL 33409. The USPS tracking system confirms that delivery was attempted on November 18, 2014, and the package was undeliverable as

addressed. On November 19, 2014, I spoke by telephone with the West Palm Beach, FL Post Office, and they said the package was undeliverable without a suite number. I advised the Post Office that we did not have a suite number as none of the respondent's filings on Edgar showed a suite number. A true copy of the tracking confirmation is attached hereto.
