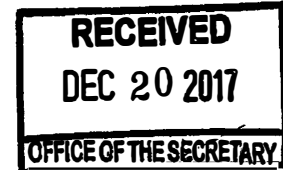

**DIVISION OF ENFORCEMENT'S MOTION TO COMMISSION TO DISMISS CLAIMS
AGAINST RESPONDENT STRATEGIC CONSULTING ADVISORS, LLC**

The Division of Enforcement ("Division"), pursuant to Rule of Practice 150, respectfully moves the Securities and Exchange Commission ("Commission") for an Order dismissing all claims made in this matter against Respondent Strategic Consulting Advisors, LLC ("SC Advisors") due to SC Advisor's status as a now-defunct entity.


In support of this Motion, the Division represents that SC Advisors was involuntarily dissolved as a limited liability company by the Illinois Secretary of States' office in February 2012 for failure to comply with that office's registration regulations. Based on the Division's inquiry, SC Advisors currently has no assets, operations or income. Accordingly, the Division believes it is appropriate to dismiss the claims previously instituted against SC Advisors, and seeks an Order of dismissal.

Due to prior activity in the case, such an Order will conclude this administrative proceeding.¹

For these reasons, the Division respectfully requests that the Commission issue an Order dismissing its claims against SC Advisors.


