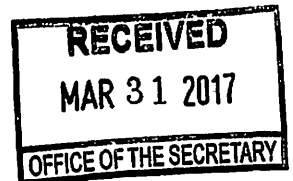

**DIVISION OF ENFORCEMENT'S NOTICE OF OBJECTION TO SUBMISSION BY
ABRAHAM CINTA**

The Division of Enforcement objects to the March 31, 2017 submission by Abraham Cinta, purportedly on behalf of Go EZ Corporation ("Go EZ"), requesting a new hearing date. The email submission, which Mr. Cinta did not serve on the Division of Enforcement ("Division"), claims that he is "CEO & Director" of Go EZ. However, Mr. Cinta informed the Staff of the Division ("Staff") on July 15, 2016 that he had resigned his positions as CEO and Director of Go EZ and was no longer affiliated with the company. *See* July 15, 2016 Email from A. Cinta, Hearing Exhibit 1-G, copy attached. Mr. Cinta should not be permitted to make any statements or submissions on behalf of Go EZ without first establishing his authority to do so.

In addition, Mr. Cinta's submission also falsely attempts to place blame for Go EZ's lack of operations on the Commission's April 4, 2016 trading suspension. The evidence submitted by the Staff at the March 16, 2017 hearing establishes that Go EZ's operations, to the extent it had any, ceased long before the April 4, 2016 trading suspension. *See, e.g.,* Hearing Exhibits 1, 1-U

to 1-X, 1-BB to 1-FF, 1-HH to 1-LL, 2, 2-A to 2-D (admitted at hearing on March 16, 2017; filed and served on March 22, 2017).

Finally, the Staff spoke with Go EZ's registered agent this afternoon, who confirmed that, if it had been unable to forward pleadings filed in this matter to Go EZ, it would have sent the Commission a letter indicating this. The registered agent estimated that we would have received any such notice within 4-5 days of serving the registered agent. As we have received no such notifications, it appears that the registered agent has been successfully forwarding the pleadings in this matter to Go EZ. Unfortunately, the registered agent was not authorized to release to the Staff the specific details of the method it used to forward the pleadings to Go EZ; but it would release them to Go EZ, who could easily provide evidence supporting its claim that the pleadings were not properly forwarded to it. Go EZ has not done so, and we urge the Court not to accept as true Mr. Cinta's vague and unsworn assertions that "the Company did not receive the notice" and "the Company might not be able to get any notice sent by mail," particularly without further evidence that he is actually speaking for Go EZ, who may well have received the notices and determined not to respond.

If the Court is inclined to schedule a new hearing as requested by Mr. Cinta, the Division would request that (1) the hearing be limited to Go EZ, as the other two Respondents have not responded to the Court's Order to Show Cause; and (2) an officer or director of Go EZ be required to appear in person at the hearing to testify under oath about his/her authority to speak for Go EZ, about Go EZ's operations and control persons, and about the statements in Go EZ's registration statement that are the subject of the Commission's Order Fixing Time and Place of Public Hearing and Instituting Proceedings Pursuant to Section 8(d) of the Securities Act of 1933. The Division also respectfully requests that the hearing not be scheduled for the week of

April 10-14, when the undersigned counsel for the Division will be traveling and unable to attend.

Finally, please let us know no later than June 22 whether Fang Ren, GEZC's other director, intends to produce documents in response to the subpoena issued to her in this examination, whether Ms. Fang is willing to participate in a voluntary telephonic interview with us, and what dates (after July 25), she would be available for such an interview.
