Dear Hon. Elliot,

My name is Talman Harris. I want to notify the commission that I received a certified mail on November 3rd 2017, at 11.30 a.m., regarding "Initial Decision" of a Bar.

Pursuant to a an scheduling order of which I could not partake on June 21, 2017, and a supposed civil charge, for which I was never served, I hereby alert your office once again, (first by certified mail in June 2017) and through Unit Counselor at Canaan Camp, who advised by conference on June 21, 2017 that I could not participate as I did not have a lawyer, and that I was never served a subpoena or law suit from the SEC., and that I have received no notices except one piece of letter in April 2017 notifying me of information of Mr. Alfaya who I do not know. I am hereby certifying that I am not in agreement of any of the SEC charges. Nor am I guilty of any of the charges. I have pleaded not guilty in a parallel investigation and trial with the DoJ, and have been granted an appeal by the courts for which oral arguments are scheduled on Dec. 7.2017.

I maintain, that I have not been formally served by the SEC. I was not a part of any court hearing with the SEC. I have never spoken to Mr. Enright of the SEC. I have nothing to plead not guilty to as I am unaware of the charges. And that the above captioned case which is sighted in the certified letter I received. I hereby plead not guilty. I have no way of defending myself against the proposed accusations which are purported to have occurred 10 years ago cited in the Bar Letter your office sent to me - except that I disagree and do not concur with any of the items listed.


As you may know, I was the CEO of a minority owned brokerage firm of Cambridge Alliance Capital, where I employed and maintained a spoteless brokerage record for nearly 2 decades. I maintain my innocence and would like the opportunity to properly defend myself against all allegations of which I am accused during the worst financial crisis of my generation in 2008.

Please advise, by certified mail. This is the only way that I receive mail at the camp. I am not represented by attorney. Please advise.

I have not received a fait and proper or constitutional due process of the laws of the US. Furthermore Mr. Enright has deceived the courts in his filing, and I have not been afforded the opportunity to defend myself.
