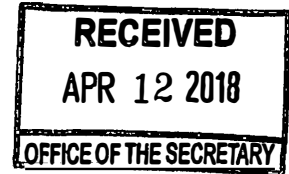

NEW GLOBAL ENERGY, INC.'S  
RESPONSE TO ORDER TO SHOW  
CAUSE

Respondent, New Global Energy, Inc., through undersigned counsel, hereby responds to the Securities and Exchange Commission's (the "Commission") April 3, 2018, *Order to Show Cause*, and says:

1.e Upon learning of the order instituting proceedings ("OIP"), undersigned counsel confirmed the date when New Global Energy, Inc. ("NGE") was served (March 20, 2018) and thereafter conferred with the Commission's counsel as to the correct response date to the OIP. A true and correct copy of the correspondence between the undersigned and the Commission's counsel is attached hereto as Exhibit "A".

2.e Undersigned counsel believed, based on conferring and agreement with the Commission's counsel that the answer to the OIP was due twenty (20) days after service. Clearly this was an inadvertent mistake on counsel's part and one for which NGE should not suffer.

3.e Irrespective of the foregoing, NGE will be filing its answer to the OIP on or before April 9, 2018, *i.e.*, before the response to the April 3, 2018 *Order to Show Cause* is due.

4.e Undersigned counsel apologizes to the Commission, as he was unaware that a motion for extension of time was required here. To the extent that one is required, please

consider this response to serve as a *nunc pro tunc* motion for an additional ten (10) days to respond to OPI, *i.e.*, up to and including April 9, 2018.

WHEREFORE, NGE requests entry of an order that NGE has shown good cause in response to the *Order to Show Cause*, NGE's registration should not be revoked at this time, and, to the extent required, NGE be granted an additional ten (10) days to respond to the OIP, *i.e.*, up to and including April 9, 2018.





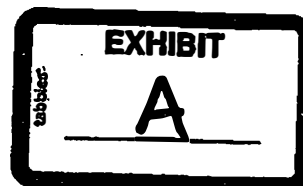

Jeff and Bob,

I received Jeff's message requesting that we reset our call planned for tomorrow. That is fine. I am out of the office all of next week, but available the following week for a call on April 2 at 1:00 pm EDT or you can propose a different time or date that works for you.

On the topic of depositions, I have been contacting witnesses and have tentative dates for two depositions of a representative of Island Stock Transfer on May 8 in Clearwater or Tampa Florida, and possibly Mike Cronin on May 9 or 10 in Winter Springs Florida, outside of Orlando. Please hold those three dates. I will need to work on travel arrangements and can confirm those dates during the week of April 2 and then send the deposition notices. I am working to set two depositions the week of May 14 in Colorado for a representative of Manhattan Transfer and possibly John Knight.

On the administrative proceedings against New Global, the Order Instituting Proceedings was sent by certified mail on March 16, to the registered agent in Wyoming. I have not yet received confirmation that it was served. I received an Order from Administrative Law Judge Elliott today setting a telephonic prehearing conference for May 15, 2018 at 2:00 pm Eastern. I will make arrangements the telephone conference.
