ORDER
SCHEDULING
BRIEFS

Treehouse Real Estate Investment Trust filed an application, pursuant to Section 19(d)(2) of the Securities Exchange Act of 1934,¹ for review of action taken by the New York Stock Exchange (“NYSE”). NYSE filed a copy of the index to the record on June 18, 2019, pursuant to Rule 420(e) of the Rules of Practice.²

Accordingly, IT IS ORDERED, pursuant to Rule 450(a) of the Rules of Practice,³ that a brief in support of the application for review shall be filed by August 8, 2019. A brief in opposition shall be filed by September 9, 2019, and any reply brief shall be filed by September 23, 2019.⁴ Pursuant to Rule 180(c) of the Rules of Practice, failure to file a brief in support of the application may result in dismissal of this review proceeding.⁵

Upon review of the application for review and the index to the record filed by NYSE, we direct the parties’ attention to Rules 154 and 452 of the Rules of Practice governing motions for

leave to adduce additional evidence.⁶ If the parties intend to conditionally rely on any such additional evidence in their opening or opposition briefs on the merits, they should move to adduce the additional evidence under Rule 452, appending the evidence sought to be adduced, no later than when they file those briefs. The parties shall file any opposition and reply to a Rule 452 motion within the deadlines provided by Rule 154(b) of the Rules of Practice.⁷
