SECURITIES EXCHANGE ACT OF 1934

The Securities and Exchange Commission (“Commission”) announced the temporary suspension, pursuant to Section 12(k) of the Securities Exchange Act of 1934 (the “Exchange Act”), of trading in the securities of Corestream Energy, Inc. (“Corestream”), formerly known as Zealous, Inc., of Las Vegas, Nevada, at 9:30 a.m. EDT on March 31, 2011, and terminating at 11:59 p.m. EDT on April 13, 2011.

The Commission temporarily suspended trading in the securities of Corestream because of a lack of current and accurate information about the company because it failed to file certain periodic reports with the Commission and because of questions regarding the accuracy and adequacy of publicly disseminated information concerning, among other thing, the acquisition of certain oil wells.

The Commission cautions brokers, dealers, shareholders, and prospective purchasers that they should carefully consider the foregoing information along with all other currently available information and any information subsequently issued by the company.

Further, brokers and dealers should be alert to the fact that, pursuant to Rule 15c2-11 under the Exchange Act, at the termination of the trading suspension, no quotation may be entered unless and until they have strictly complied with all of the provisions of the rule. If any broker or dealer has any questions as to whether or not he has complied with the rule, he should not enter any quotation but immediately contact the staff in the Division of Trading and Markets, Office of Interpretation and Guidance, at (202) 551-5777. If any broker or dealer is uncertain as to what is required by Rule 15c2-11, he should refrain from entering quotations relating to Corestream’s securities until such time as he has familiarized himself with the rule and is certain that all of its provisions have been met. If any broker or dealer enters any quotation which is in violation of the rule, the Commission will consider the need for prompt enforcement action.
