**ORDER OF SUSPENSION OF
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Evolucia, Inc. (CIK No. 1383006), a revoked Nevada corporation with its principal place of business listed as Bradenton, Florida with stock quoted on OTC Link (previously, "Pink Sheets") operated by OTC Markets Group, Inc. ("OTC Link") under the ticker symbol ILED, because it has not filed any periodic reports since the period ended September 30, 2014. On February 27, 2017, a delinquency letter was sent by the Division of Corporation Finance to Evolucia, Inc. requesting compliance with its periodic filing obligations, and Evolucia, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Legend International Holdings, Inc. (CIK No. 1132143), a void Delaware corporation with its principal place of business listed as Southbank, Victoria, Australia with stock quoted on OTC Link under the ticker symbol LGDIQ, because it has not filed any periodic reports since the period ended June 30, 2014. On August 29, 2016, a delinquency letter was sent by the Division of Corporation Finance to Legend International Holdings, Inc. requesting compliance with its periodic filing obligations, and Legend International Holdings, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of OSL Holdings, Inc. (CIK No. 1329957), a revoked Nevada corporation with its principal place of business listed as Yardley, Pennsylvania with stock quoted on OTC Link under the ticker symbol OSLH, because it has not filed any periodic reports since the period ended May 31, 2015. On February 27, 2017, a delinquency letter was sent by the Division of Corporation Finance to OSL Holdings, Inc. requesting compliance with its periodic filing obligations, and OSL Holdings, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on June 8, 2017, through 11:59 p.m. EDT on June 21, 2017.
