**ORDER OF SUSPENSION OF
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of CellCyte Genetics Corp. (CIK No. 1325279), a revoked Nevada corporation with its principal place of business listed as Bothell, Washington with stock quoted on OTC Link (previously, "Pink Sheets") operated by OTC Markets Group, Inc. ("OTC Link") under the ticker symbol CCYG, because it has not filed any periodic reports since the period ended September 30, 2014. On December 21, 2016, a delinquency letter was sent by the Division of Corporation Finance to CellCyte Genetics Corp. requesting compliance with its periodic filing obligations, and CellCyte Genetics Corp. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of China Pediatric Pharmaceuticals, Inc. (CIK No. 1354071), a revoked Nevada corporation with its principal place of business listed as Xi'an, Shaanxi Province, China with stock quoted on OTC Link under the ticker symbol CPDU, because it has not filed any periodic reports since the period ended March 31, 2014. On December 21, 2016, a delinquency letter was sent by the Division of Corporation Finance to China Pediatric Pharmaceuticals, Inc. requesting compliance with its periodic filing obligations, and China Pediatric Pharmaceuticals, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Hawker Energy, Inc. (CIK No. 1415286), a defaulted Nevada corporation with its principal place of business listed as Redondo Beach, California with stock quoted on OTC Link under the ticker symbol HWKR, because it has not filed any periodic reports since the period ended May 31, 2015. On December 29, 2016, a delinquency letter was sent by the Division of Corporation Finance to Hawker Energy, Inc. requesting compliance with its periodic filing obligations, and Hawker Energy, Inc. received the delinquency letter on January 3, 2017, but failed to cure its delinquencies.

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on August 29, 2017, through 11:59 p.m. EDT on September 12, 2017.
