**ORDER OF SUSPENSION OF
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Baltia Air Lines, Inc. (CIK No. 869187), a New York corporation with its principal place of business listed as Newburgh, New York with stock quoted on OTC Link (previously, "Pink Sheets") operated by OTC Markets Group, Inc. ("OTC Link") under the ticker symbol BLTA, because it has not filed any periodic reports since the period ended March 31, 2016. On February 27, 2018, a delinquency letter was sent by the Division of Corporation Finance to Baltia Air Lines, Inc. requesting compliance with its periodic filing obligations, and Baltia Air Lines, Inc. received the delinquency letter on March 6, 2018, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Graphite Corp. (CIK No.

1420239), a revoked Nevada corporation with its principal place of business listed as Valley Cottage, New York with stock quoted on OTC Link (previously, “Pink Sheets”) operated by OTC Markets Group, Inc. (“OTC Link”) under the ticker symbol GRPH, because it has not filed any periodic reports since the period ended September 30, 2015. On July 31, 2017, a delinquency letter was sent by the Division of Corporation Finance to Graphite Corp. requesting compliance with its periodic filing obligations, and Graphite Corp. received the delinquency letter on August 2, 2017, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Green Energy Management Services Holdings, Inc. (CIK No. 1164552), a forfeited Delaware corporation with its principal place of business listed as New York, New York with stock quoted on OTC Link under the ticker symbol GRMS, because it has not filed any periodic reports since the period ended December 31, 2014. On July 31, 2017, a delinquency letter was sent by the Division of Corporation Finance to Green Energy Management Services Holdings, Inc. requesting compliance with its periodic filing obligations, and Green Energy Management Services Holdings, Inc. received the delinquency letter on August 2, 2017, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of 24Holdings, Inc. (CIK No. 1025315), a void Delaware corporation with its principal place of business listed as New York, New York with stock quoted on OTC Link under the ticker symbol TWFH, because it has not filed any periodic reports since the period ended September 30, 2015.

On July 31, 2017, a delinquency letter was sent by the Division of Corporation Finance to 24Holdings, Inc. requesting compliance with its periodic filing obligations, and 24Holdings, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on May 8, 2018, through 11:59 p.m. EDT on May 21, 2018.
