**ORDER OF SUSPENSION OF
TRADING**

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of ColorStars Group (CIK No. 1418780), a Nevada corporation with its principal place of business listed as New Taipei City, Taiwan with stock quoted on OTC Link (previously, “Pink Sheets”) operated by OTC Markets Group, Inc. (“OTC Link”) under the ticker symbol CSTU, because it has not filed any periodic reports since the period ended December 31, 2016. On August 30, 2017, a delinquency letter was sent by the Division of Corporation Finance to ColorStars Group requesting compliance with its periodic filing obligations, and ColorStars Group did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Green Earth Technologies, Inc. (CIK No. 1433966), a void Delaware corporation with its principal place of business listed as Greenwich, Connecticut with stock quoted on OTC Link under the ticker symbol

GETG, because it has not filed any periodic reports since the period ended March 31, 2016. On August 30, 2017, a delinquency letter was sent by the Division of Corporation Finance to Green Earth Technologies, Inc. requesting compliance with its periodic filing obligations, and Green Earth Technologies, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Intellect Neurosciences, Inc. (CIK No. 1337905), a Delaware corporation with its principal place of business listed as Englewood Cliffs, New Jersey with stock quoted on OTC Link under the ticker symbol ILNS, because it has not filed any periodic reports since the period ended March 31, 2016. On August 30, 2017, a delinquency letter was sent by the Division of Corporation Finance to Intellect Neurosciences, Inc. requesting compliance with its periodic filing obligations, and Intellect Neurosciences, Inc. received the delinquency letter on September 5, 2017, but failed to cure its delinquencies.

It appears to the Securities and Exchange Commission that there is a lack of current and accurate information concerning the securities of Jishanye, Inc. (CIK No. 1569737), a delinquent Delaware corporation with its principal place of business listed as Kaohsiung City, Taiwan with stock quoted on OTC Link under the ticker symbol JSHY, because it has not filed any periodic reports since the period ended March 31, 2016. On August 30, 2017, a delinquency letter was sent by the Division of Corporation Finance to Jishanye, Inc. requesting compliance with its periodic filing obligations, and Jishanye, Inc. did not receive the delinquency letter due to its failure to maintain a valid address on

file with the Commission as required by Commission rules (Rule 301 of Regulation S-T, 17 CFR 232.301 and Section 5.4 of EDGAR Filer Manual).

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

Therefore, it is ordered, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on September 18, 2018, through 11:59 p.m. EDT on October 1, 2018.
