CIVIL PROCEEDINGS

FRANCIS R. RICHARDSON AND HIS COMPANIES ENJOINED

The Chicago Regional Office announced that on May 13 U.S. District Court Judge William Beatty, Southern District of Illinois, entered Final Judgments and Orders of Permanent Injunction enjoining Francis R. Richardson and his companies, Richardson Services Corp., doing business as Synergistic Financial Services, and Great Northern Financial Services, from violating the registration and antifraud provisions of the securities laws. The Court also ordered the defendants to provide an accounting to the Court or, in the alternative, submit an affidavit attesting to their current financial status. The defendants consented to the injunctions without admitting or denying the allegations in the Commission's complaint.

The complaint alleged that from November 1981 to March 1985, Richardson and his companies formed and sold interests in various limited partnerships, which were to acquire certain properties. In fact, the complaint alleged, the defendants never acquired the property. The complaint also alleged that the defendants made material misrepresentations and omissions regarding, among other things, the use of investor proceeds, the identities of the general partners, the commingling of investor funds, the financial status of Richardson's companies, and the existence of Cease and Desist Orders issued by various states. (SEC v. Francis R. Richardson, et al., SDIL, Civil File No. 86-5157, filed May 13, 1986). (LR-11109)
