## CIVIL PROCEEDINGS

---

### PERMANENT INJUNCTION ENTERED AGAINST ROBERT J. FISH AND LANA J. FISH

The Atlanta Regional and Miami Branch Offices announced that on June 23 Judge James C. Paine, U.S. District Court for the Southern District of Florida, entered Final Judgments of Permanent Injunction against Robert J. Fish and Lana J. Fish of Fort Lauderdale, Florida. The defendants were formerly the president and executive vice president, respectively, of Tevere, Inc., a Florida corporation located in Fort Lauderdale. Concurrent with the filing of the Commission's complaint, the defendants, without admitting or denying the allegations of the complaint, consented to the Final Judgments against them.

The Final Judgments enjoin the defendants from violating the antifraud provisions of the securities laws and from aiding and abetting violations of the books and records, accounting controls and reporting provisions of the Securities Exchange Act of 1934. The Final Judgment as to R. Fish also enjoins him from falsifying any book or record required to be maintained by Section 13(b)(2)(A) of the Exchange Act and from making false statements to an accountant in connection with an audit required by Section 13(b)(2) of the Exchange Act or the preparation of any report required to be filed with the Commission. ## CRIMINAL PROCEEDINGS

### JAMES MCGOVERN CONVICTED

Francis X. Hermann, U.S. Attorney for the District of Minnesota, and the Chicago Regional Office announced that on July 7 James Francis McGovern, former legal counsel to Flight Transportation Corporation, was convicted of two counts of violations of the antifraud provisions of the Securities Act of 1933 in connection with Flight's 1981 securities offering. Judge Donald Alsop found McGovern guilty based upon stipulated facts. Sentencing will be set at a later date. (U.S. v. James Francis McGovern, USDC DMN, Criminal No. 3-85-95). (LR-11161)

### NOTICE OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-86-6) to provide procedures for the book-entry exercise of warrant subscriptions by DTC participants. Publication of the proposal is expected to be made in the Federal Register during the week of July 14. (Rel. 34-23444)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval of proposed rule changes filed by the Philadelphia Stock and Chicago Board Options Exchanges. The rule changes (SR-Phlx-86-19 and SR-CBOE-86-20) establish 60-day pilots during which customer margin requirements in the respective exchanges' Canadian Dollar options will be reduced from the option premium plus 4% of the underlying contract value (minus the amount by which the option is out-of-the-money to a minimum of the current premium plus 3/4% of the underlying contract value) to the option premium plus 1% of the underlying contract value (minus the amount by which the option is out-of-the-money to a minimum of the current premium plus 1/2% of the underlying contract value). # TRUST INDENTURE ACT RELEASES

## CITICORP

A notice has been issued giving interested persons until August 11 to request a hearing on an application by Citicorp under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeships of The United States Trust Company under four existing indentures, and a pooling and servicing agreement dated May 1, 1986 under which certificates evidencing interests in a pool of mortgage loans have been issued, is not so likely to involve a material conflict of interest as to make it necessary to disqualify the Trust Company from acting as trustee. The Trust Company is currently acting as trustee under the following four indentures dated: (a) February 15, 1972, involving the issuance of floating rate notes, due 1989; (2) March 15, 1977, involving the issuance of various series of unsecured and unsubordinated notes; (3) August 25, 1977, involving the issuance of rising-rate notes, Series A; and (4) April 21, 1980, involving the issuance of various series of unsecured and unsubordinated notes. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45

days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
