ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS AGAINST ROBERT SCHWARZ, INC. AND ROBERT G. SCHWARZ

The Commission simultaneously instituted public proceedings against Robert Schwarz, Inc. (Adviser), a registered investment adviser, and Robert G. Schwarz, its president and sole shareholder, and accepted their Offers of Settlement. The Order alleges that: 1) the Adviser and Schwarz defrauded clients by using a corporate checking account to buy municipal bonds from broker-dealers and then resell them to individual clients, without disclosing to clients that, by engaging in these agency cross transactions, they were able, over a five year period, to siphon off undisclosed "commissions"; 2) Schwarz caused the Adviser to fail to register as a broker-dealer and to fail to confirm municipal bond transactions to clients in writing; and 3) Schwarz and the Adviser failed to maintain certain books and records and to make required disclosures in the Adviser's Form ADV. The Order imposed a thirty day working suspension on the Adviser and Schwarz, during which period they cannot accept a fee for their advisory activities; required the Adviser to relinquish custody of client funds; and ordered the respondents to adopt procedures to ensure compliance with the securities laws in the future. PROCEEDINGS AGAINST ZZZZ BEST CHIEF FINANCIAL OFFICER

The Commission issued an Order Instituting Proceedings and Opinion and Order Pursuant to Rule 2(e) of the Commission's Rules of Practice against Bruce T. Andersen, CPA. According to the Order, Andersen, formerly the Chief Financial Officer of ZZZZ Best Co., Inc. (Z Best), engaged in improper professional conduct and willfully violated the securities laws. Among other findings, the Order stated that Andersen participated in preparing a false Form SR misrepresenting the disposition of the proceeds of Z Best's initial public offering, falsified Z Best's accounting records, inflated assets reported in a Z Best press release, and made false representations to Z Best's independent accountants. Andersen, who consented to the Order without admitting or denying the findings, was permanently denied the privilege of appearing or practicing before the Commission as an accountant. FREEDOM OF INFORMATION ACT RELEASES

ORDER AFFIRMING AND REVERSING FOIA OFFICER'S DETERMINATION TO DENY ACCESS

The General Counsel sent a letter to Anthony J. Amato affirming in part and reversing in part the FOIA Officer's determination to deny access to certain information compiled by the Commission for law enforcement purposes concerning Computer Components Corporation. The General Counsel denied access under Exemption 7(A), 5 U.S.C. 552(b)(7)(A), to some of the information withheld by the FOIA Officer, and released certain information that the FOIA Officer had withheld pursuant to Exemption 7(A). CIVIL PROCEEDINGS

INJUNCTIVE ACTIONS AGAINST ROBERT SCHWARZ, INC. AND ROBERT G. SCHWARZ

The New York Regional Office announced the filing of a Complaint against Robert Schwarz, Inc. (Adviser) and Robert G. Schwarz, the Adviser's president and sole shareholder. The Complaint alleges that: 1) the Adviser and Schwarz defrauded clients by using a corporate checking account to buy municipal bonds from broker-dealers and then resell them to individual clients, without disclosing to clients that, by engaging in these agency cross transactions, they were able, over a five year period, to siphon off undisclosed "commissions"; 2) Schwarz caused the Adviser to fail to register as a broker-dealer and to fail to confirm municipal bond transactions to clients in writing; and 3) Schwarz and the Adviser failed to maintain certain books and records and to make required disclosures in the Adviser's Form ADV. The Adviser and Schwarz consented, without admitting or denying the Complaint's allegations, to being enjoined from further violations of certain provisions of the securities laws and to being ordered to disgorge \$7,500. [SEC v. Robert Schwarz, Inc. and Robert G. Schwarz, Civ. No. 90-3033 (ALJ)] (LR-12602)

PERMANENT INJUNCTION AGAINST CHERAMI NATURAL PET FOODS, INC. AND DAVID J. SMITH

The Denver Regional Office announced that, on August 31, the U.S. District Court for the District of Nevada entered a Final Judgment of Permanent Injunction against CherAmi Natural Pet Foods, Inc. (CherAmi) of Reno, Nevada and David J. Smith (Smith), the former president and chief executive officer of CherAmi. The Complaint alleged that CherAmi violated the antifraud and reporting provisions by failing to disclose in reports filed with the Commission material information concerning: (1) its change of control in September 1986; (2) a loan it made in 1986 of more than one-third of its available funds; (3) termination of its pet food business in 1987; and (4) its acquisition in 1988 of two subsidiaries. The Complaint also alleged that CherAmi violated the reporting provisions by failing to timely file several required reports and notices of late filing. Finally, the Complaint alleged that Smith caused all but two of the Company's alleged violations and, hence, was a direct violator of the antifraud provisions and an aider and abettor of the company's reporting violations.

The defendants consented to the entry of the Final Judgment without admitting or denying the allegations of the Complaint. [SEC v. CherAmi Natural Pet Foods, Inc. and David J. Smith, USDC Nevada, Case No. CV-N-90-386-BRT] (LR-12608)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
