INVESTMENT COMPANY ACT RELEASES

BARCLAYS BANK PLC

A conditional order has been issued under Section 6(c) of the Investment Company Act exempting Barclays Bank PLC from Section 17(f) of the Act to permit the maintenance of foreign securities and other assets of registered investment companies with Merck Finck & Co., a general partnership, of which Barclays is a general partner. (Rel. IC-18892; International Series Rel. 435 - August 12)

KEENE CORPORATION

A notice has been issued giving interested persons until September 8, 1992 to request a hearing on an application filed by Keene Corporation for an order under Sections 6(c) and 6(e) of the Investment Company Act excepting applicant from all provisions of the Investment Company Act except Sections 9(a), 17(a), 17(d), 17(e), 17(f) and 36-53 as if it were a registered investment company. The requested order will exempt applicant until the earlier of one year from the date of the requested order or such time as applicant would no longer be considered an investment company. (Rel. HOLDING COMPANY ACT RELEASES

NEW ENGLAND ELECTRIC SYSTEM, ET AL.

An order has been issued authorizing a proposal by New England Electric System (NEES), a registered holding company, and its wholly owned public-utility subsidiaries, Granite State Electric Company, Massachusetts Electric Company and the Narrangansett Electric Company, (collectively, Subsidiaries) for Subsidiaries to purchase, on the open market, from time to time through August 1, 2002, up to an aggregate total of 20,000 shares of NEES common stock and to pay the shares to their respective outside directors as additional compensation. (Rel. 35-25605)

CENTRAL POWER AND LIGHT COMPANY

An order has been issued authorizing a proposal by Central Power and Light Company, a subsidiary electric public-utility company of Central and South West Corporation, a registered holding company, to modify certain terms of its money market cumulative preferred stock and auction preferred stock to increase the maximum dividend rates on such stock. (Rel. 35-25606)

LISTING, DELISTING AND UNLISTED TRADING ACTIONS

UNLISTED TRADING PRIVILEGES SOUGHT

Notices have been issued giving interested persons until September 2, 1992 to comment on the applications of four exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. The exchanges and number of issues are as follows: Philadelphia Stock Exchange - 13 issues (Rel. 34-31023); Boston Stock Exchange - 5 issues (Rel. 34-31024); Pacific Stock Exchange - 7 issues (Rel. 34-31026); and Midwest Stock Exchange - 6 issues (Rel. 34-31027).

A notice has been issued giving interested persons until September 2, 1992 to comment on the application of the <u>Philadelphia Stock Exchange</u> for unlisted trading privileges in twenty-two over-the-counter issues. (Rel. 34-31025)

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of two exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchanges and are reported in the consolidated transaction reporting system. The exchanges and number of issues are as follows: Midwest Stock Exchange - 11 issues (Rel. 34-31028); and Pacific Stock Exchange - 14 issues (Rel. 34-31029).

WITHDRAWALS GRANTED

An order has been issued granting the application of Champion International Corporation to strike from listing and registration its Common Stock \$.50 Par Value; Rights to Purchase Preference Stock, Participating Cumulative Series, \$1 Par Value-which presently are attached to the Common Stock; Preference Stock, \$1.20 Cumulative Convertible Series, \$1 Par Value--all of which was redeemed on April 14, 1986; and Preference Stock, \$4.60 Cumulative Convertible, \$1 Par Value--all of which was redeemed on May 17, 1986, on the Pacific Stock Exchange. (Rel. 34-31030)

An order has been issued granting the application of Data Switch Corporation, T-Bar Incorporated to strike from listing and registration its 9% Convertible Subordinated Debentures, due 1996, on the <u>American Stock Exchange</u>. (Rel. 34-31031)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission approved on an accelerated basis a proposed rule change filed by the Boston Stock Exchange (SR-BSE-92-08) to extend for one year the BSE's specialist concentration policy pilot program. (Rel. 34-31037)

The Commission approved on an accelerated basis a proposed rule change filed by the Midwest Stock Exchange (SR-MSE-92-9) to extend its SuperMAX and Enhanced SuperMAX pilot programs for an additional six-month period. The SuperMAX program guarantees the execution price of small agency market orders received over the Midwest Automated Execution System (MAX) and automatically improves such orders from the consolidated best bid or offer according to certain pre-defined criteria. Publication of the release is expected in the <u>Federal Register</u> during the week of August 17. (Rel. 34-31038)

PROPOSED RULE CHANGES

A proposed rule change has been filed by the <u>American Stock Exchange</u> (SR-Amex-92-18) to provide for the listing and trading of Portfolio Depositary Receipts, securities which are interests in an open-ended, unit investment trust holding a portfolio of securities. Each Trust will provide investors with an instrument that closely tracks the underlying securities portfolio, trades like a share of common stock, and pays to holders periodic dividends proportionate to those paid with respect to the underlying portfolio of securities. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 17. (Rel. 34-31039)

The New York Stock Exchange filed a proposed rule change (SR-NYSE-92-14) to amend its Specialist Performance Evaluation Questionnaire. Publication of the proposal is expected in the <u>Federal Register</u> during the week of August 17. (Rel. 34-31032)

ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
