COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT PRAISES LEADERSHIP OF REPS. BLILEY, OXLEY, AND MARKEY AND SEC COMMISSIONER WALLMAN ON DECIMALIZATION ISSUE; SEC TO CONVENE MEETING OF MARKETS TO COORDINATE MOVE TO DECIMALS

On June 5, Chairman Levitt announced that the SEC will convene a meeting of industry officials within the next month to coordinate the move to quoting stock prices in decimals. Chairman Levitt praised U.S. Representatives Thomas Bliley, Michael Oxley, Edward Markey, and SEC Commissioner Steven Wallman for their leadership in promoting the benefits of decimal pricing. CHAIRMAN LEVITT CONGRATULATES THE NEW YORK STOCK EXCHANGE ON DECISION TO RECOGNIZE THE MARTIN LUTHER KING, JR. HOLIDAY

On June 5, Chairman Levitt congratulated the New York Stock Exchange for its decision to close every January on the annual Martin Luther King, Jr. holiday, which was made a legal public holiday by Congress in 1983 and was first celebrated in 1986 by proclamation of President Ronald Reagan. ENFORCEMENT PROCEEDINGS

AGREED FINAL JUDGMENT ENTERED AGAINST ROBERT COWAN AND COWAN ASSET MANAGEMENT, INC.

The Commission announced that on June 2 an Agreed Final Judgment was entered against Robert C. Cowan, individually and doing business as CS Investments Trust (CSI), and Cowan Asset Management, Inc., (CAMI), an investment adviser registered with the Commission. The Agreed Final Judgment permanently enjoins Cowan, individually and doing business as CSI, and CAMI from future violations of the antifraud provisions of the federal securities laws, and Cowan from aiding and abetting CAMI's violations. The Court also ordered Cowan to pay disgorgement in the amount of \$3,080,418, plus prejudgment interest, less the value of the assets he surrendered to the Special Master, as reflected in the Special Master's final report. Based on Cowan's demonstrated inability to pay, collection of the remaining

disgorgement is waived, and the Court will not order him to pay a civil penalty.

According to the complaint filed on November 5, 1996, Cowan raised between \$1 million and \$3 million from his customers for the purpose of purchasing trust units in CSI. In fact, according to the complaint, CSI does not exist, apart from Cowan's misrepresentations and created records, and does not hold securities or funds for customers; rather, Cowan used customers' funds for his personal expenses, and to satisfy periodic payments and redemptions for his customers as part of a "Ponzi" scheme. PROPOSED RULE CHANGE
