RULES AND RELATED MATTERS

AMENDMENTS TO RULE 10f-3 UNDER THE INVESTMENT COMPANY ACT

The Commission issued a release adopting amendments to Rule 10f-3 under the Investment Company Act of 1940, the rule that permits an investment company that is related to certain participants in an underwriting to purchase securities during an offering, if certain conditions are met. The amendments increase to 25 percent the portion of an offering that investment companies having the same investment adviser may purchase in reliance on the rule. The amendments also permit these investment companies to purchase securities in certain foreign offerings and offerings of unregistered securities. FOR FURTHER INFORMATION, CONTACT: C. INVESTMENT COMPANY ACT RELEASES

MANULIFE SERIES FUND, INC.
