COMMISSION ANNOUNCEMENTS

COMMISSIONER ISAAC HUNT TO TESTIFY

Commissioner Isaac C. Hunt, Jr. will testify before the Senate Committee on Banking Housing and Urban Affairs on July 28, 1998. The testimony, which concerns Arbitration of Employment Discrimination Disputes in the Securities Industry, will be given at a hearing which begins at 10:00 a.m. in Room 538 of the Dirksen Senate Office Building.

RULES AND RELATED MATTERS

GRANT OF EXEMPTIVE RELIEF FROM CERTAIN PROVISIONS OF THE TENDER OFFER REGULATIONS AND RULE 10b-13

The Commission granted an exemptive order from certain provisions of the Securities Exchange Act of 1934 (Exchange Act) to Trinity Acquisition plc with regard to a tender offer for the Ordinary Shares and American Depositary Shares of the Willis Corroon Group plc. The order granted relief from certain withdrawal rights provisions of Section 14(d)(5) of the Exchange Act and Rules 14d-7 and 14d-10, thereunder, and confirmed that the offer could employ certain practices consistent with U.K. law and practice. The order

also granted an exemption from the provisions of Rule 10b-13 of the Exchange Act to permit purchases outside the tender offer, subject to certain specified conditions. ENFORCEMENT PROCEEDINGS

MILTON VERRET AND RICKY BUSBY PERMANENTLY ENJOINED

The Commission announced that on June 24, 1998, the U.S. District Court for the Western District of Texas, Austin Division permanently enjoined defendants Milton J. Verret and Ricky D. Busby from further violations of the antifraud and reporting provisions found in Sections 17(a) of the Securities Act of 1933, and Sections 10(b), 13(a) and 13(d) of the Securities Exchange Act of 1934, and Rules 10b-5, 13a-1, 13a-11, 13a-13, 13d-2 and 12b-20 thereunder. Verret and Busby consented to the entry of the judgment without admitting or denying the Commission's allegations.

The Commission's complaint alleged that Verret and Busby participated in issuing false and misleading statements to the public regarding revenues and financing for an animated film called "Happily Ever After;" illegally traded on material, inside information about the film; and that Verret failed to make the required disclosures to the Commissions about his sales. The Court's judgment orders disgorgement of trading profits, and payment of prejudgment interest, but does not impose a civil penalty or require payment of disgorgement and prejudgment interest based on Verret's and Busby's demonstrated inability to pay. The judgment also permanently prohibits Verret and Busby from acting as an officer or director of any public company. [SEC v. First National Entertainment Corp., Milton J. Verret, Ricky D. INVESTMENT COMPANY ACT RELEASES

FIRST AMERICAN INVESTMENT FUNDS, INC., ET AL.

An order has been issued on an application filed by First American Investment Funds, Inc., et al. under Section 17(b) of the Investment Company Act granting relief from Section 17(a) of the Act. The order permits certain series of a registered open-end investment company to acquire all of the assets and liabilities of: (i) certain series of three registered open-end investment companies, and (ii) five registered closed-end investment companies. HOLDING COMPANY ACT RELEASES

THE SOUTHERN COMPANY, ET AL.

A notice has been issued giving interested persons until August 18, 1998, to request a hearing on a proposal by The Southern Company, a registered holding company, and its nonutility subsidiaries Southern Energy, Inc. (Southern Energy), Mobile Energy Services Holdings, Inc., Southern Energy Resources, Inc., Southern Energy North America, Inc. and Mobile Energy Services Company, L.L.C. (MESC). Applicants request that the Commission authorize through June 30, 2000, the transfer of nonvoting economic interests and voting interests in MESC to a special purpose subsidiary of Southern Energy. UTILICORP UNITED INC.

A notice has been issued giving interested persons until August 18, 1998, to request a hearing on a proposal by UtiliCorp United Inc. (UtiliCorp), a holding company claiming exemption from registration under Rule 10, to acquire an interest in certain foreign gas retail and distribution companies (Acquired Companies). In connection with the proposed acquisitions, UtiliCorp requests an order under Section 3(b) exempting each of the Acquired Companies from all provisions of the Act.
