RULES AND RELATED MATTERS

REPROPOSED RULES 55, 56, AND 87: REGULATING FOREIGN UTILITY COMPANIES AND AMENDING FORMS

On February 1, the Commission repropose for comment Rules 55 and 56 and an amendment to Rule 87 under the Public Utility Holding Company Act of 1935. As a related matter, the Commission requests comments on amendments to forms used to report information concerning foreign utility companies. The repropose rules and amendment address various issues related to the acquisition and ownership of foreign utility companies by registered holding companies. In addition, the Commission is requesting comment on possible limitations upon the ability of a holding company to qualify foreign operations as a foreign utility company. The rulemaking is intended to carry out Congress' mandate to adopt rules concerning the acquisitions of foreign utility companies by registered holding companies. ENFORCEMENT PROCEEDINGS

JUDGMENTS ENTERED AGAINST TWO DEFENDANTS IN PRIME BANK SCHEME

The Commission announced today that the Honorable Loretta A. Preska of the United States District Court for the Southern District of New York has entered final judgments against two defendants in a "prime bank" scheme. The defendants are H.D. Inc. and St. Barth LTD., two entities involved in promoting the scheme. H.D. Inc., formerly a New Jersey corporation, and St. Barth, formerly registered in the Commonwealth of the Bahamas, both consented to the judgments, without admitting or denying the allegations of the Commission's complaint.

Specifically, both entities consented to the entry of final judgments permanently enjoining them from violating Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. They also

agreed to pay disgorgement of \$803,470 plus prejudgment interest of \$651,507. The Court, however, waived the payment of disgorgement and prejudgment interest and did not impose civil penalties based on the defendants' demonstrated financial inability to pay.

The Commission's complaint alleged that H.D. Inc. and St. Barth, along with others, fraudulently obtained more than \$1.7 million from at least three individuals by offering and selling securities in the form of participations in investment programs purportedly to trade prime bank instruments. The trading was to result in spectacular profits for investors--returns of ten to fifty times their initial investments in two months to two years--at no risk. In its complaint, the Commission alleged that the investment programs were scams, the instruments themselves bogus. Instead of using the money as promised, the promoters of the scheme misappropriated the investors' funds for their own benefit, ultimately transferring most of the money to offshore accounts.

Previous judgments were entered against other defendants in this case (See, Lit. Rel. Nos. 15752, 15819, and 16207). Litigation continues as to the remaining defendants and relief defendants. [SEC v. Stewart, et al., Civil Action No. 98 CIV 2636, SDNY] (LR-16883)

SEC OBTAINS \$1.3 MILLION FRAUD JUDGMENT AGAINST FRED CARTER IN WASHINGTON, D.C. BASED INTERNET TELEPHONY SCHEMES

On January 29, 2001, Judge Paul L. Friedman of the United States District Court for the District of Columbia signed a final judgment by default against Fred Carter, formerly president and chief executive officer for American Telephone and Telecommunications Corporation (ATTC), a District of Columbia corporation purportedly set up to establish a long distance telephone service using Internet telephony technology. Fred Carter is permanently enjoined from future violations of the antifraud provisions of the Securities Act and the Exchange Act. He is also ordered to pay disgorgement of investors' money with prejudgment interest and civil money penalties, for a total judgment of \$1,328,845.40. Finally, he is barred from serving as an officer or director of certain public companies.

The Court concluded, as the SEC's complaint alleges, that from October 1996 through October 1997, Fred Carter made material misstatements and omissions in promotional mailings and seminars used to induce people to invest in ATTC. According to the complaint, he falsely claimed, among other things, to have designed a revolutionary technology for routing phone calls using the Internet, that ATTC's stock price would at least triple within one year, and that ATTC had a strategic alliance with an Internet telephony product manufacturer that would help ATTC implement its telephone service. In fact, the complaint alleges, ATTC did not design any technology, but merely purchased Internet telephony products for use in investor demonstrations. In addition, there was no reasonable basis for ATTC's financial projections and there existed no alliance with an Internet telephony product manufacturer. Further, investors were not told that investor funds were largely being disbursed for Fred Carter's personal use rather than being spent on bringing the promised telephone service to market.

The SEC alleged that by engaging in such conduct Fred Carter violated Section 17(a) of the Securities Act of 1933 (Securities Act) and Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder. SEC CHARGES DONALD ENGLISH, D/B/A E-BIZ VENTURES, WITH SECURITIES FRAUD

On January 31, 2001, Judge David L. Russell, United States District Court for the Western District of Oklahoma, issued an *Ex Parte* Order Freezing Assets, Requiring an Accounting, Repatriation Order and Order Requiring Preservation of Documents and Authorizing Expedited Discovery, against all defendants and relief defendants, and issued an *Ex Parte* Temporary Restraining Order and appointed a receiver over the assets of defendant Donald Allen English. The Commission's complaint accuses English of creating and organizing an Internet Ponzi scheme through which at least 22,000 investor accounts have lost at least \$8.8 million. To facilitate the scheme, English registered two Internet websites, www.ee-bizventures.com and www.donventures.com.au, which claimed that E-Biz was a "Christian-based humanitarian organization" which could provide "very large, long-term, monthly income with virtually NO effort." English and E-Biz promised returns of as much as 40 to 100 percent in as little as seven to ten days. The Commission also alleged that English and E-Biz fraudulently claimed to be in "total compliance with the laws and regulatory agencies" and to have hired special accounting, legal and computer expertise. In reality, English used investor funds to repay earlier investors and to purchase thousands of dollars of personal items, including electronic equipment, vehicles, appliances and furniture. Further, after English abruptly quit paying returns to investors, he began to lull them with false claims that the government halted its operations, that refunds would be sent starting on Valentine's Day, 2001, and that, soon thereafter, E-Biz would resume business.

The complaint charges that English violated the antifraud provisions of the Securities Exchange Act of 1934 and the Securities Act of 1933, as well as registration provisions of the Securities Act. The complaint seeks an asset freeze, accounting, and disgorgement against all defendants and relief defendants. In addition, the complaint seeks temporary restraining order, preliminary and permanent injunctions, disgorgement with prejudgment interest and a civil money penalty against English and the appointment of a receiver over his assets. The Commission acknowledges the assistance of the Oklahoma Department of Securities and the United States Postal Inspection Service in this matter. [SEC v. HOLDING COMPANY ACT RELEASES

SCANA CORPORATION, ET AL.

A supplemental order has been issued authorizing SCANA Corporation (SCANA), a registered holding company, SCANA's gas utility subsidiary company, Public Service Company of North Carolina, Inc. (PSNC), and SCANA's other utility and nonutility subsidiary companies (collectively, Applicants), through February 11, 2003, (Authorization Period) to (i) increase the amount of common stock and long-term debt issued by SCANA in an aggregate principal amount not to exceed \$2.45 billion; and (ii) increase the amount of commercial paper and short-term debt that PSNC is authorized to issue an aggregate amount not to exceed \$200 million and for PSNC to issue \$150 million in long-term debt. SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGES

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-01-10) relating to the conversion of open orders for Nasdaq securities at the commencement of decimal pricing. The National Association of Securities Dealers, through its wholly owned subsidiary, the Nasdaq Stock Market, Inc. (Nasdaq), filed a proposed rule change (SR-NASD-01-01) to amend NASD Rule 4330(f) to require a Nasdaq issuer to apply for initial inclusion following a reverse merger with a non-Nasdaq entity. Publication of the proposal is expected in the Federal Register during the week of February 5. (Rel. 34-43907)

The National Association of Securities Dealers, through its wholly owned subsidiary, the Nasdaq Stock Market, Inc. (Nasdaq), filed a proposed rule change (SR-NASD-00-76) relating to locked and crossed markets that occur at or prior to the market's open and the market's close. Publication of the proposal is expected in the Federal Register during the week of February 5. (Rel. 34-43913)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change submitted by the Chicago Board Options Exchange (SR-CBOE-00-53) relating to the live ammo to RAES system. (Rel. 34-43908)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-PCX-00-46) filed by the Pacific Exchange relating to prohibition of harassment has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the proposal is expected in the Federal Register during the week of February 5. (Rel. 34-43911)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the Philadelphia Stock Exchange (SR-Phlx-00-91) regarding the listing and trading of Index Fund Shares. Publication of the proposal is expected in the Federal Register during the week of February 5. (Rel. 34-43912)
