(NYSE: ICE) and Chairman of the New York Stock Exchange. Sprecher acquired the predecessor company to ICE for \$1, building a company with a market capitalization over \$28 billion in 15 years. Under Sprecher's leadership, ICE grew from operating an energy swaps market into a network of 11 global exchanges, including the New York Stock Exchange, through organic growth and acquisitions.</p> <p>As a power plant developer, Sprecher recognized the need among energy market participants for an accessible, standardized electronic marketplace for OTC energy contracts. He acquired Continental Power Exchange (CPEX) in 1997 to achieve his vision of an efficient market that would bring transparency to previously opaque and fragmented markets. Intercontinental Exchange was formed in 2000 and the company completed its initial public offering in 2005 on the NYSE. He has served as the company's Chief Executive Officer since May 2000 and as Chairman of the Board since November 2002.
