### **Rule 7.45E. Operation of a Routing Broker**

(c) Inbound Routing Function

(1) For so long as the Exchange is affiliated with NYSE Arca, Inc. ("NYSE Arca"), NYSE National, Inc. ("NYSE National"), NYSE Chicago, Inc. ("NYSE Chicago") and New York Stock Exchange, LLC ("NYSE"), and Archipelago Securities LLC ("Arca Securities"), in its capacity as a facility of NYSE Arca, NYSE National, NYSE Chicago and NYSE, is utilized for the routing of any approved types of orders from those exchanges to the Exchange (such function of Arca Securities is referred to as the "Inbound Router"), each of the Exchange and Arca Securities shall undertake as follows:

(A) - (D) No Change.

(2) Provided the above conditions are complied with, and provided further that Arca Securities operates as an outbound router on behalf of NYSE Arca, NYSE National, NYSE Chicago and NYSE on the same terms and conditions as it does for the Exchange, and in accordance with the Rules of NYSE Arca, NYSE National, NYSE Chicago and NYSE, Arca Securities may provide inbound routing services to the Exchange from NYSE Arca, NYSE National, NYSE Chicago and NYSE.
