## 2) Regulatory Fees

a) No change.

### b) [Reserved] Options Regulatory Fee

The per-contract Options Regulatory Fee (“ORF”) is assessed by MIAX PEARL to each MIAX PEARL Member for all options transactions, including Mini Options, executed, cleared, or ultimately cleared by the Member that are cleared by OCC in the “customer” range, regardless of the exchange on which the transaction occurs. The ORF is not assessed on linkage trades. The ORF is collected indirectly from Members through their clearing firms by OCC on behalf of MIAX PEARL. The Exchange may only increase or decrease the ORF semi-annually, and any such fee change will be effective on the first business day of February or August. The Exchange will notify participants via a Regulatory Circular of any change in the amount of the fee at least 30 calendar days prior to the effective date of the change.
